ON DECEMBER 12, 1975, AND REQUESTED THAT WEHUNT TELEPHONE COLLECT TO JOHN CREWDSON, A REPORTER FOR THE "NEW YORK TIMES" AT TELEPHONE NUMBER 202-293-3100. WEHUNT ADVISED THAT HE SUBSEQUENTLY CONTACTED CREWDSON WHO INDICATED THAT HE DESIRED TO COME TO TAMPA, FLORIDA, TO INTERVIEW WEHUNT CONCERNING INFORMATION THAT WEHUNT HAD PREVIOUSLY FURNISHED TO THE FBI. WEHUNT STATED THAT FROM HIS CONVERSATION WITH CREWDSON IT WAS OBVIOUS TO HIM THAT CREWDSON HAD THE RESULTS OF THE INTERVIEW OF WEHUNT BY A TAMPA FBI AGENT ON JULY 1, 1974. WEHUNT WAS ADVISED THAT THE TAMPA OFFICE WAS NOT AWARE AS TO THE CIRCUMSTANCES UNDER WHICH CREWDSON COULD OBTAIN THE RESULTS OF THE INTERVIEW CONDUCTED OF WEHUNT BY TAMPA AGENT1. Did Ray act alone?

It's not just the conspiracy buffs who have wondered for years whether James Earl Ray acted alone in killing Dr. Martin Luther King Jr. and, if so; what his motives were.

The assassination, the resulting worldwide manhunt, the eventual arrest, and finally Ray's guilty plea left all kinds of reasonable questions unanswered.

IN EFFECT, Americans had to take it on faith from the FBI, which conducted the investigation, that justice had been done when Ray was convicted and sentenced to life.

Now it is obvious that nothing the

FBI said or did in relation to King's life or his death deserved to be taken on faith. J. Edgar Hoover hated King. And the agency has confirmed that under his guidance it harassed King for six years, tapping his phones, bugging his quarters, circulating poisoned rumors about him, and at one point even prodding him to commit suicide.

And as a final worrisome note, bureau documents show that the FBI may have played a part in inducing King's selection of the Memphis motel at which he was killed.

UNDER THE circumstances, we think most Americans, black and white, will welcome the decision by Atty. Gen. Edward Levi, with support of President Ford, to review the FBI investigation of King's assassination. Levi hasn't actually reopened the inquiry; he says the current review will guide his decision on that.

Significantly, Ray is in the courts now attempting to withdraw his guilty plea and seek a new trial. While there doesn't seem to be any doubt he pulled the trigger on King, we would like to see Ray's story told, including whatever defense he can offer. Levi could contribute to that by ordering the whole investigation reopened.

Reference is made to Tampa memorandum dated
July 2, 1974.

On December 12, 1975, Robert Thomas Wehunt, Jr., 3109 Hartnett Avenue, Tampa, Florida, telephonically contacted the Tampa Office of the FBI and advised that on December 12, 1975, Angel Castillo, a reporter for the "St. Petersburg Times," a daily newspaper published in St. Petersburg, Florida, had contacted Wehunt and had requested that Wehunt telephone collect to John Crewdson, a reporter for the "New York Times," a daily newspaper published in New York, New York. Mr. Wehunt advised that Castillo indicated that Crewdson should be contacted by telephone number 202-293-3100.

Wehunt advised that he subsequently contacted John Crewdson at the above-listed telephone number at which time Crewdson indicated that he desired to come to Tampa, Florida, to interview Wehunt concerning information that Wehunt had previously furnished to the FBI concerning three signed statements that Wehunt's father had obtained from convicts in the Fulton County Jail, Atlanta, Georgia, indicating that these convicts had been approached by very influential businessmen to kill Dr. Martin Luther King, Jr. for \$100,000. Wehunt stated that from his conversation with John Crewdson it was obvious to him that Crewdson had obtained the results of the interview of Wehunt by an FBI Agent of the Tampa Office which interview took place on July 1, 1974. Wehunt advised that he did not give a definite answer to Crewdson but indicated that he would recontact Crewdson at which time he would furnish a definite answer.

This document contains neither recommendations nor conclusions of the FBI. It is the property of the FBI and is loaned to your agency; it and its contents are not to be distributed outside your agency.

Wehunt advised that he desired to bring this to the attention of the FBI and he indicated that he planned to contact Angel Castillo and have Castillo contact Crewdson to notify Crewdson that Wehunt did not desire to be interviewed inasmuch as Crewdson apparently had all of the information that Wehunt had previously furnished to the FBI. In addition, Wehunt advised that he was going to notify Castillo that he is fearful of his life if it becomes public knowledge that he furnished information to the FBI to the effect that very influential businessmen had plotted to kill Dr. King.

On December 17, 1975, Wehunt telephonically contacted the Tampa Office and advised that upon instructions from his attorney he had contacted John Crewdson telephonically and had advised Crewdson that he did not desire to be interviewed by Crewdson.



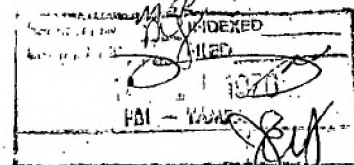

Let's get the facts

In the eight years since Dr. Martin Luther King Jr. was shot to death nobody has explained satisfactorily how his assassin could have been at once as stupid and as wily as the record would have us believe.

THE FACT IS, the circumstances of King's assassination remain clouded because James Earl Ray was allowed to plead guilty, and so the case wasn't tried.

Ray, according to the official account, was a fumbling hoodlum who, after staking out King at a Memphis motel, picked him off with a rifle from a rooming house window nearby.

After the shooting he ran, dropping the gun, his binoculars, and two cans of beer in plain view on the street, all bearing his fingerprints. That was unbelievably witless, even for Ray.

Thereafter he successfully eluded for more than two months an FBI search that involved 3,000 agents and cost \$1.4-million. That was unbelievably clever, especially for Ray.

FOR THESE AND other reasons we were disappointed that the 6th U.S. Circuit Court of Appeals Monday rejected Ray's request to withdraw his guilty plea and stand trial. Ray said he had been talked into the plea by his lawyers.

But the court said it found no evidence he hadn't volunteered his confession (which he retracted almost at once) and that therefore he couldn't be allowed now to repudiate it.

Legally, that probably makes sense. Practically, it leaves the case under clouds of suspicion which have darkened for eight years and which in the absence of a full hearing and trial aren't about to disperse.

Most people assume that Ray did fire the shot that killed King. And nobody,

not even Ray, has claimed he didn't figure in the killing at least in some way, although he insists now he did not pull the trigger.

BUT CONSIDER SOME of the worrisome and unanswered questions, in addition to those raised above.

One is the FBI's role in harassing King in the years leading up to his killing, and the suspicion that J. Edgar Hoover, who hated King, may not have had his heart in the murder inquiry.

Then there is the fact — or at least it appears to be a fact — that for two weeks after the shooting the FBI never thought to run the Ray fingerprints — so handily left at the scene — through its criminal file, to get him identified.

HOW DID RAY after the shooting raise the thousands of dollars required to finance his flight through five countries? How did he acquire a Canadian passport issued in the name of a Canadian whom he resembled?

How did Ray know, in advance, where King would be staying? And besides all that, what was his motive in leaving his girl friend and a job offer in Los Angeles to drive across the country and assassinate Dr. King?

No doubt there are reasonable answers to all these questions. At a trial the questions at least might have been asked.

Ray's current attorneys say they will appeal the appeal court's ruling. We hope they do, and that the Supreme Court will be able to find legal grounds to support Ray's demand for a trial.

ASIDE FROM RAY'S interests — and they are considerable since he is serving 99 years in a Tennessee prison — the public interest will be served by getting all the available facts on the record.

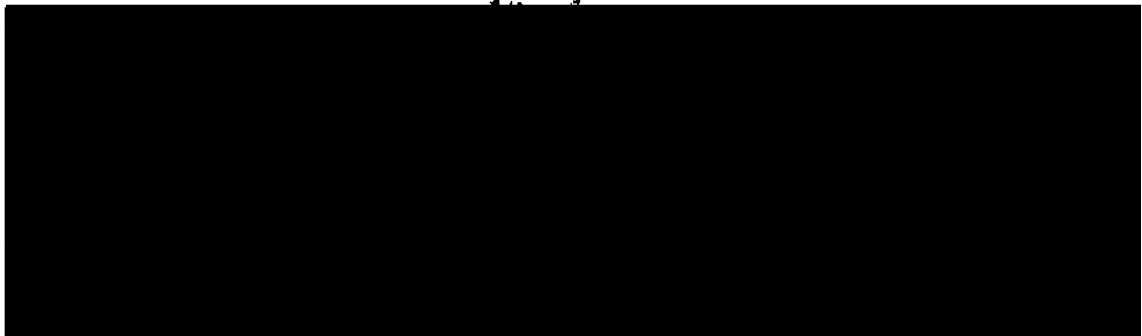

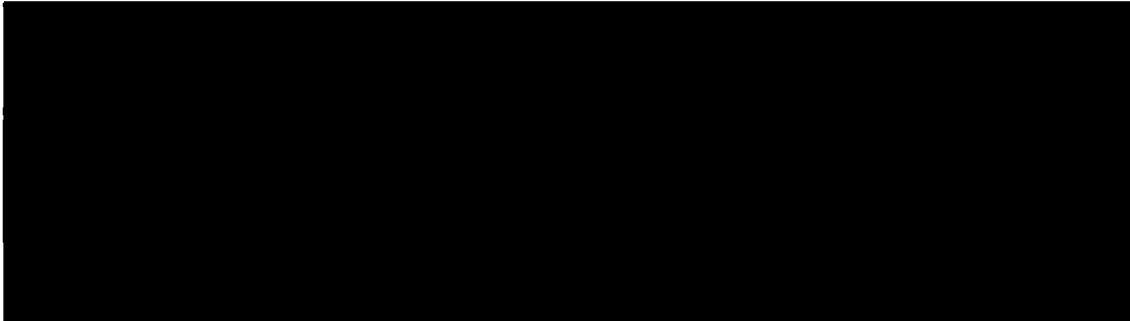
