



Robert T Webont IN 1966-67 My father had statements that I saw that was Made by 3 prisoners at the Fulton County Jail that stated they were offered large sums of Money to Kill Martin Luther King JR. My father was a Deputy Sherrif of fultow County and was working at the fulton county Jail at the time. I saw the statements. I do Not remember the names, however, I do remember that there were three people My father described as influential business men who Offered the money . Later my father told me he had tried to turn the statements over to the GBI and was told he had better not if he wanted to live . Later he told me that he had been told It he told any one they would Kill father and his entire family.

My father also told me that he Kept the statements and a large som of money that he hinted to being around 3 Million to 3/2 Million dollars. Later My Mother told Me she though my father told her he turned the Statements over to a man who was going to write a book . The Mars Name is Bob something - My Mother Knows his Name. My father died IN 1973 and I told all this to the FBI IN 1974. I do Not KNOW the Name of the bank where my father Kept the statements but it was located in Little Five Points in ATLANTA, GEORGIA. My sister, NOW Mrs Wayne Upshaw of Stone MT Georgia, said she typed the Statements for My father. My Mother The ALMA L. Wehunt of 3015 AlBatross Lane Decator Georgia
