SUBJECT: MURKIN

At approximately 9 a.m., 4/17/68, SA RUSSELL JEAN GRAY, JR., called from Puerto Vallarta with the following information:

The bar tender, LUIS GARCIA, who knew ERIC STARVO GALT briefly, has been cooperating and it has been determined that GALT probably spent the evening of 11/6/67 with a girl in Puerto Vallarta prior to checking in at the Tropicana Hotel. GRAY said that GARCIA had agreed to assist in locating this girl or finding out where she might be if she has left Puerto Vallarta.

GRAY also stated that it has been difficult to locate anyone at the Tropicana Hotel who remembers GALT well, but that a number of those interviewed do remember the white Mustang which GALT was using.

GRAY stated that he might be in need of funds for expenses and arrangements were made with SA ROBERT J. OGLESBY, JR., at Guadalajara to send money to GRAY with MEX-38 who was leaving Guadalajara to return to Puerto Vallarta today.

At 3:45 pm, 4/17/68, SA ROBERT J. OGLESBY, JR., advised that GRAY had contacted him to say that the girl who apparently spent at least one night with GALT was tentatively identified as ALICIA or ELISA ARELLANO TORRES and it is believed her address is Contreras Medellin 77, in Guadalajara. Information was also developed that her mother is MARGARITA TORRES, living at Calle L Samaniego 409, Colonia Durango in Juarez, Chihuahua.

OGLESBY stated that MEX-24 believes that he knows who this girl is and was being instructed to locate her and interview her very discreetly. OGLESBY was requested to bear in mind, while instructing the informant, that current instructions call for the utmost discretion and that arrangements should be made, if at all possible.

THIS CONSPIRACY, ERIC STARVO GALT DID, ON OR ABOUT MARCH THREE ZERO, 1968, PURCHASE A RIFLE AT BIRMINGHAM, ALABAMA.... UNQUOTE

ACCORDING TO MR. HOOVER, A 30.06 RIFLE EQUIPPED WITH A TELESCOPIC SIGHT WAS FOUND NEAR A ROOMING HOUSE ON SOUTH MAIN STREET IN MEMPHIS IMMEDIATELY AFTER THE FATAL SHOOTING OF DR. KING OCCURRED. THE ROOMING HOUSE OVERLOOKS THE LORRAINE HOTEL & MOTEL WHERE DR. KING WAS STAYING.

MR. HOOVER SAID THAT FBI AGENTS DETERMINED THAT THE ~~XXXXX~~ 30.06 RIFLE HAD BEEN PURCHASED FROM A GUN DEALER IN BIRMINGHAM, ALABAMA, ON MARCH 30, 1968. THE TELESCOPIC SIGHT ALSO WAS PURCHASED FROM THIS DEALER.

THE FBI DIRECTOR SAID THAT GALT, WHO HAS USED THE NAMES OF JOHN WILLARD AND HARVEY LOWMYER IN THE PAST, IS THE OWNER OF A 1966 WHITE MUSTANG BEARING ALABAMA LICENSE PLATES WHICH WAS LOCATED ABANDONED IN ATLANTA, GEORGIA, ON APRIL 11, 1968. INVESTIGATION DISCLOSED THAT GALT PURCHASED THIS CAR FROM A PRIVATE CITIZEN IN BIRMINGHAM ON AUGUST 30, 1967. THE MUSTANG'S ODOMETER SHOWED THAT IT HAD BEEN DRIVEN MORE THAN 19 THOUSAND MILES BETWEEN LATE AUGUST, 1967, AND EARLY APRIL, 1968.

ACCORDING TO MR. HOOVER, GALT'S TRAVEL IN MUSTANG INCLUDED TRIPS TO LOS ANGELES, CALIFORNIA; NEW ORLEANS, LOUISIANA;

BIRMINGHAM, ALABAMA; AND MEXICO, AS WELL AS TO MEMPHIS, TENNESSEE,

AND ATLANTA, GEORGIA. GALT WAS REPORTED TO HAVE BEEN IN MEMPHIS ON APRIL 3 AND 4, 1968, AND TO HAVE DEPARTED FROM THERE FOR ATLANTA.

INTENSIVE INVESTIGATION ~~OR~~ THE FBI HAS DISCLOSED THAT GALT HAS CLAIMED TO ~~XXXXX~~ HAVE BEEN EMPLOYED AS A COOK ON MISSISSIPPI RIVER VESSELS AND AS A MERCHANT SEAMAN. HE IS SAID TO BE AN AVID DANCER AND TOOK DANCING LESSONS IN NEW ORLEANS IN 1964 AND 1965; IN BIRMINGHAM DURING SEPTEMBER AND OCTOBER, 1967; AND IN LONG BEACH, CALIFORNIA, FROM DECEMBER, 1967 TO FEBRAURY, 1968.

GALT LEFT LOS ANGELES ON DECEMBER 15, 1967, AND DROVE HIS WHITE MUSTANG TO NEW ORLEANS, WHERE HE CLAIMED HE CONTACTED EITHER ANENGINEERING OR A CONTRACTING FIRM. HE LEFT NEW ORLEANS ON DECEMBER 19 AND ARRIVED BACK IN LOS ANGELES ON DECEMBER 21, 1967.

WHILE IN THE LOS ANGELES AREA EARLY THIS YEAR, GALT TOOK A COURSE AT A SCHOOL OF BARTENDING AND WAS GRADUATED ON MARCH 2, 1968.

THE FUGITIVE IS DESCRIBED AS A WHITE MALE. HE IS APPROXIMATELY 5'8" TO 5'11" TALL AND WEIGHS BETWEEN 160 AND 175 LBS. HE IS SAID TO BE A NEAT DRESSER AND HAS A MEDIUM BUILD.

April 17, 1968

Attorney General Ramsey Clark announced today that Eric Starvo Galt is being sought by the FBI as a fugitive on a Federal charge arising from the fatal shooting of the Reverend Dr. Martin Luther King, Jr., in Memphis, Tennessee, on April 4, 1968.

Director J. Edgar Hoover stated that a Federal complaint was filed by the FBI in Birmingham, Alabama, today charging Galt with conspiring to violate the civil rights of Dr. King in violation of Title 18, Section 241, of the United States Code.

The FBI complaint charges that "On or about March 29, 1968, at Birmingham, Alabama, ... Eric Starvo Galt and an individual whom he alleged to be his brother, entered into a conspiracy which continued until on or about April 5, 1968, to injure, oppress, threaten, or intimidate Martin Luther King, Jr., ... in the free exercise or employment of a right secured to him by the Constitution or Laws of the United States; namely, the right to freely travel from state to state. In furtherance of this conspiracy, Eric Starvo Galt did, on or about March 30, 1968, purchase a rifle at Birmingham, Alabama..."

According to Mr. Hoover, a 30.06 rifle equipped with a telescopic sight was found near a rooming house on South Main Street in Memphis immediately after the fatal shooting of Dr. King occurred. The rooming house overlooks the Lorraine Hotel & Motel where Dr. King was staying.

Mr. Hoover said that FBI Agents determined that the 30.06 rifle had been purchased from a gun dealer in Birmingham, Alabama, on March 30, 1968. The telescopic sight also was purchased from this dealer.

The FBI Director said that Galt, who has used the names of John Willard and Harvey Lowmyer in the past, is the owner of a 1966 white Mustang bearing Alabama license plates which was located abandoned in Atlanta, Georgia, on April 11, 1968. Investigation disclosed that Galt purchased this car from a private citizen in Birmingham on August 30, 1967. The Mustang's odometer showed that it had been driven more than nineteen thousand miles between late August, 1967, and early April, 1968.

According to Mr. Hoover, Galt's travel in the Mustang included trips to Los Angeles, California; New Orleans, Louisiana; Birmingham, Alabama; and Mexico, as well as to Memphis, Tennessee, and Atlanta, Georgia. Galt was reported

to have been in Memphis on April 3 and 4, 1968, and to have departed from there for Atlanta.

Intensive investigation by the FBI has disclosed that Galt has claimed to have been employed as a cook on Mississippi River vessels and as a merchant seaman. He is said to be an avid dancer and took dancing lessons in New Orleans in 1964 and 1965; in Birmingham during September and October, 1967; and in Long Beach, California, from December, 1967 to February, 1968.

Galt left Los Angeles on December 15, 1967, and drove his white Mustang to New Orleans, where he claimed he contacted either an engineering or a contracting firm. He left New Orleans on December 19 and arrived back in Los Angeles on December 21, 1967.

While in the Los Angeles area early this year, Galt took a course at a school of bartending and was graduated on March 2, 1968.

The fugitive is described as a white male. He is approximately 5' 8" to 5' 11" tall, and weighs between 160 and 175 pounds. He is said to be a neat dresser and has a medium build.

Galt has brown hair, which he wears in a "brush" cut. He reportedly has blue eyes; his nose is straight and narrow;

his teeth are straight and clean; and he has given his date of birth as July 20, 1931.

The fugitive is said to have a nervous habit of occasionally pulling at an ear lobe with his hand. His left ear protrudes farther from his head than his right ear.

According to Mr. Hoover, persons who have met Galt describe him as a "loner," and state his language and diction have a "rural" quality and suggest that he probably does not have a high degree of education. He is said to drink alcoholic beverages and has a preference for vodka and beer. He is a fan of western and country music.

Galt should be considered armed and dangerous.

Dear Mr. Ambassador:

This is not an easy letter for me to write, but I feel that I must.

Yesterday morning, approximately 9:15 a.m., while transacting some business at the First National City Bank, Reforma Branch, I happened to notice a young American man in his late twenties or early thirties enter and ask to purchase some Travelers Checks. From his facial features, which immediately caught my attention, there was a striking resemblance to the description the newspapers have given of the assassin of Dr. Martin Luther King. Also his other physical features, such as weight (in the vicinity of 170 lbs.), in height (not over 6 ft.), and I would add, he possessed a decided athletic build. He was also dressed very neatly (in a dark grey suit) and spoke with a decided southern accent. Outwardly, at least, he seemed calm, but I had the distinct feeling he was rather nervous. He frequently glanced around, and I would say, overly so. I tried hard not to arouse any suspicions that I was observing him.

Upon concluding my business (before he did) I hurried left the bank, but felt an obligation to return and report my feelings to the bank manager, to Mr. Ray Fitzsimmons, who very kindly listened to me and then himself made two trips from his desk to observe the man. He stated that he had seen this man in the bank before, once when he brought a letter of credit from New York for a negotiation, I understood him to say.

The last thing I want to do is jump to conclusions and cause anyone any embarrassment and inconvenience, however, I do feel this man could be the one being sought in the Martin Luther King slaying. If I could be of any further help, please count on my full co-operation.

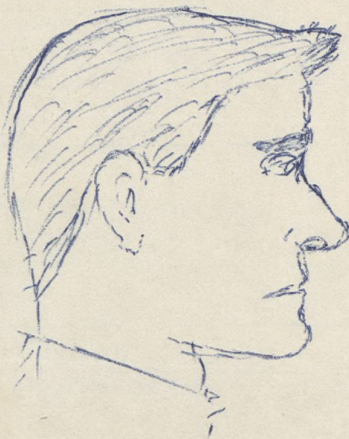

On 4/18/68 MARIO DEL X VALLE, Assistant Chief of the Inspection Service of Mexican Immigration advised that they had received notification from the office of the District Attorney (Agente del Ministerio Publico) in San Miguel de Allende that they had an American who greatly resembled the artist's conception of the ~~subject~~ assassin of King.

This is assumed to be the version by Sergio Jaubert which was released in the Mexican papers.

The American was named LANG CARPENTER, white, male, born Dec. 28, 1919, Missouri, U.S. passport [REDACTED].

Del Valle noted that he had entered Mexico on 3/30/68 on a one entry visa so that it was unlikely that he had anything to do with an incident in the U.S. on April 4.

It was pointed out to him that photographs of GALT were appearing that morning in the Mexican papers and that this information should be relayed to San Miguel de Allende.

He later advised that he had relayed this information to San Miguel and anticipated that CARPENTER would be released. They were to communicate with him if not.

1. Reference is made to your oral request of 16 April 1968 for a check of the records of this office for identification of a possible visitor to the Soviet or Cuban Embassy who could be identical with the subject of composite photographs provided by your office.

2. Subject could not be identified as being in contact with the Cuban Embassy during the period 11 August 1967 through 10 April 1968.

3. One unidentified person who claimed to be an American citizen was in contact with the Soviet Embassy on 30 January 1968. This subject was described as 22-27 years of age, approximately 5' 9" to 5' 11" in height, approximately 175 to 180 pounds, light brown hair and slightly ruddy complexion. He claimed that he was in a business relating to fertilizers for farm use. A comparison of photographs of this person and the Subject of your composite photographs and their descriptions indicate that your Subject is not identical with the unidentified visitor of 30 January 1968. Your Subject reportedly had dark brown straight hair combed straight back. The unidentified person had light brown hair with a slight wave and a deep receding hairline at each side of his forehead.

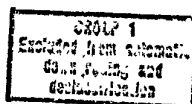

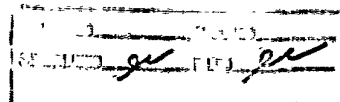

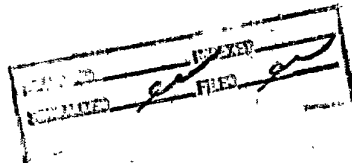

Attorney General Ramsey Clark announced today that the FBI has identified JAMES EARL RAY, an escapee from the Missouri State Penitentiary, as ERIC STARVO GALT, against whom a federal complaint was filed last Wednesday in connection with the fatal shooting of the Reverend Dr. MARTIN LUTHER KING, JR.

Director J. EDGAR HOOVER said that a systematic and exhaustive search of latent fingerprints uncovered in the Dr. KING case against the fingerprints of the over 53,000 persons for whom "Wanted Notices" have been posted in the files of the FBI's Identification Division led to the determination that GALT and RAY are identical.

Mr. HOOVER said that RAY, who is 40 years of age, was reported missing from the Missouri State Penitentiary at Jefferson City, Missouri, on April 23, 1967. He had been received at that institution on March 17, 1960, to serve a 20 year sentence following conviction in St. Louis for armed robbery and for operating a motor vehicle without permission of the owner.

In September, 1966, while serving this sentence, he was confined for a time in the maximum security ward at the State Hospital at Fulton, Missouri.

According to Mr. HOOVER, RAY has a known arrest record dating back to 1949. Prior to the 1960 conviction

for which he received the 20 year term, RAY had been convicted of burglary in Los Angeles, California, in 1949; armed robbery in Chicago, Illinois, in 1952; and forging and cashing United States Postal Money Orders in Missouri in 1955.

He has served terms in the Los Angeles County Jail in 1949; in state prisons at Joliet and Pontiac, Illinois, in 1952-54; and in the Federal Penitentiary at Leavenworth, Kansas, in 1955-58.

RAY was an enlisted man in the United States Army from February, 1946, to December, 1948, at which time he was given a General Discharge due to ineptness and lack of adaptability for military service. While in the army, he received a three-month sentence at hard labor for being drunk and breaking arrest.

Mr. HOOVER said that during his criminal career, RAY has also used the names of JAMES, MC BRIDE, JAMES WALTON, W. C. HERRON, and JAMES O'CONNER. He is a white male; claims to have been born March 10, 1928, in Illinois; is approximately 5 feet 10 inches tall and weighs about 163 to 174 pounds. He has blue eyes and brown hair. There is a small scar on the center of his forehead and a scar on the palm of his right hand.

RAY has claimed that he attended school through the tenth grade in Alton, Illinois. He has had the reputation of

being a "drifter" since leaving school. His vocational experience includes working as a baker, laborer and color matcher.

In connection with his escape from the Missouri State Penitentiary, an FBI complaint was filed in Jefferson City, Missouri, on July 20, 1967, charging RAY with unlawfully fleeing from the State of Missouri to avoid confinement. He has been a Federal fugitive since then.

The following leads have been assigned in connection with captioned case:

(1) Check with narcotics contacts in Guadalajara and Puerto Vallarta in view of indications that ERIC S. GALT had been interested in obtaining marijuana, provided such can be done discreetly. If the need for discretion indicates this should not be done, then contact should be established with the Narcotics Officer in the Embassy to ascertain if the sources available to that office can be utilized to determine if GALT is now endeavoring to obtain marijuana in Mexico. (lead assigned to SA FOARDE.)

(2) Reinterview all persons previously in touch with GALT to insure that all details have been obtained concerning his previous trip to Mexico, where he stopped en route to Puerto Vallarta and how much did he know about Mexico which might indicate a place where he would go back, if returning to this country. (Lead assigned to SA FOARDE for transmittal to SAs OGLESBY and GRAY.)

(3) For coverage in Merida and Progreso concerning possibility that GALT might be in those areas attempting to go to Cuba. Consul HARBEN and Identification Officer ARBEU should be advised by mail with copies of GALT's photographs. (Lead assigned to SA CLARK.)

(4) With regard to the possibility that GALT might go to Veracruz in an effort to go to Cuba, contact should be made with Consul SAM YOUNG and the Veracruz police, furnishing them appropriate photographs. (Lead assigned to SA PAGE.)

SA RICHARD W. KAISER telephonically advised at 5 p.m., April 21, 1968, he received a call from SAC, El Paso, Texas, at 1:45 p.m., same date, stating Bureau instructed he call KAISER about receipt by New York Office of a telegram at 9:40 a.m., same date, from ALEJANDRO RIVERA CERVANTES stating, "I HAVE LOCATED PERSON RESPONSIBLE FOR ASSASSINATION," giving return address telephone 3-29-85, Hermosillo, Sonora.

MEX 59 had contacted RIVERA at his hotel (not identified) in Hermosillo. RIVERA claimed on April 5, 1968, in Mazatlan, Sinaloa, near an unidentified beach at about 10 a.m., an UNSUB held him up with a lugar, but RIVERA had no money, so UNSUB left in a new red Datson with no license plates. UNSUB described as American.

RIVERA said he checked out of his hotel, name not given, at Hermosillo and left the same day in his 1966 Opel, which is registered to his wife, [REDACTED], 17 years old, who lived at Nonualco 45-C, Apartment 305, Ciudad Tlaltelolco, Mexico. [REDACTED]'s mother (FNU) GONZALEZ SOTO, lives there and her telephone is 29-46-08.

RIVERA said he had been joined by his wife in Hermosillo and they proceeded direct to Mexico, DF, along the route he claimed he followed UNSUB in his car arriving Mexico City about 4 p.m., April 6, 1968. He proceeded to the Hotel York in Mexico, DF, where he registered.

It is not clear why he was not with his wife at this time or needed transportation, but he stated to MEX 59 he left the hotel, proceeding to a near-by taxi stand (name of taxi company not identified and presumably only one near-by) whose telephones are 15-50-20 and 15-85-20.

He took a taxi and found UNSUB who had attempted the holdup riding as a passenger trainee. The driver (not

described) was apparently familiarizing UNSUB with the streets in Mexico City prior to the latter's going to work as a driver.

RIVERA said he was frightened and did not talk with UNSUB while he was being driven to his wife's address in Tlaltelolco.

At that time RIVERA claimed he did not suspect the identity of UNSUB. He said he left Mexico City on April 8, 1968, via train to Ciudad Obregon, arriving April 10, 1968. He saw a newspaper with an artist's conception of subject in this case (which drawing or newspaper not identified) and concluded attempted assailant (the UNSUB) is the assassin in this case. Incidentally, he also said he had seen subsequent photographs of JAMES EARL RAY or ERIC STARVO GALT (which not stated) and was finally convinced that this was the man who had tried to hold him up.

RIVERA said he had written to Mr. BAYARD RUSTIN, Negro leader in the United States identified as Executive Director of the Institute Phillip Randolph, New York, New York, but received no reply.

RIVERA proceeded to Hermosillo and on April 21, 1968, sent the telegram mentioned above. RIVERA is going to be in Hermosillo for two days and his local address will be Zacatecas 731 Sur, Ciudad Obregon, where he allegedly is employed by the Liga de Comunidades Agrarias y Sindicatos Campesinos Obregon.

MEX 59 noted that RIVERA has another wife named LIDIA ZACUETA NIEDLAS DE RIVERA and at times appears to be irrational and wandering in his accounts of his activities.

Of possible interest, MEX 59 noted that RIVERA said he was more than willing to return to Mexico City to point out UNSUB and reasoned RIVERA wanted his fare paid here.

RIVERA said he guessed the girl who is the radio operator at the taxi stand near the Hotel York would know the identity of the cab driver who was supposedly familiarizing UNSUB with the city.

RIVERA described UNSUB, whom he presumes to be JAMES EARL RAY, as WMA, 40 years old, 5 feet 10 inches, 180 pounds, blue eyes, pale complexion, always seen wearing gray Western-type hat but not with wide brim and a gray gabardine raincoat.

I will sincerely appreciate if you will retain one set of the photographs for your information and make the other four sets, together with the Spanish language summaries, available to Mr. Alberto Argueta Mendez, Director, General of Immigration in Guatemala City. I would appreciate it if you would suggest to Mr. Argueta that he make one set available to immigration at La Aurora Airport and furnish the other three for ports of entry from Mexico.

While we have no information that Ray might travel to Guatemala, we do know that he has visited Mexico and the possibility exists that he may have entered or try to enter Guatemala.

We would appreciate it if you would advise Guatemalan Immigration to notify your office immediately of any information received regarding this individual in order that you might be able to furnish such information to this office.

Subject is a white male, age 40, who claims to have been born on March 10, 1928, in Illinois. He is approximately 5 feet 10 inches tall and weighs about 163 to 174 pounds. He has blue eyes and brown hair. There is a small scar on the center of his forehead and a scar on the palm of his right hand.

He has also used the names JAMES MC BRIDE, JAMES WALTON, W. C. HERRON, and JAMES O'CONNER.

He has an extensive criminal record in the United States and is also currently wanted as an escapee from the Missouri State Penitentiary where he was serving twenty years for armed robbery.

It is requested that you be alert for any information relating to this individual and that any information developed be immediately relayed to the Legal Attache.
