Source orally advised that during the previous week, he and eight other DFS agents from various states in Mexico were ordered by their headquarters in Mexico to proceed to Mazatlan, Sinaloa, and conduct investigation to locate ERIC STARVO GALT. He stated that these instructions apparently were due to the fact that GALT allegedly had obtained a tourist visa from the Mexican Consulate, Memphis, indicating he would like to visit Mazatlan, Sinaloa. He stated these investigators contacted all hotels, restaurants, bars and other tourist attractions, but developed no pertinent information and were subsequently ordered to discontinue.

1. ALFREDO VALDEZ MONTOYA - Not particularly popular and strongly supports industry.
2. MIGUEL LEYSON PEREZ - No technical training, is a farmer and popular.
3. Lic. AMADO ESTRADA RODRIGUEZ - The leading candidate so far, is a State Senator, a heavy drinker, popular and very procommunist.

ALEJANDRO RIVERA CERVANTES, residence Zacateca #731 Sur, Ciudad Obregon, employed by Liga de Comunidades Agrarias y Sindicatos Campesinos, was interviewed in Hermosillo, Sonora, and related the following information:

On 4-5-68, RIVERA, while in Mazatlan, Sinaloa, about 10 a.m. in the morning, was accosted by an individual whom he later believed to be identical with the individual who assassinated MARTIN LUTHER KING in the United States. This individual held him up with a Luger pistol; however, upon determining that RIVERA had no money, immediately left the area, driving a late-model red Datsun car, bearing no license plates.

RIVERA related that he then returned to his hotel in Mazatlan (name not recalled), picked up his girlfriend, [REDACTED] who resides at Nonualco #45C, Apartment 305, Ciudad Tlaxiotepec, State of Mexico, telephone 29-46-08. Driving a 1966 Opel, he immediately departed for Mexico, D.F., and by

circumstance happened to be following the individual in the red Datsun the entire route to Mexico, D.F. He stated that the only time he stopped en route was for gasoline and, upon arriving in Mexico, D.F. he checked into the Hotel York. Shortly thereafter, upon leaving the Hotel York, he went to a taxi stand which uses the telephone numbers 15-50-20 and 15-85-20, where he obtained a taxi to take him to the address of his girlfriend, previously described.

Upon entering this taxi, he noted there were two individuals, the driver and the individual who had held him up in Mazatlan, Sinaloa. The driver was teaching this individual the streets of the city in preparation for his driving a taxi for this company. He stated that, due to fear, he did not report this matter to the local police. He noted that they had arrived in Mexico City around 4 p.m. on 4-6-68, and that he obtained this taxi around 6 p.m. that evening. He stated that this was the last time he had observed this individual.

RIVERA related that he left Mexico City again on 4-8-68 by train at 8:30 a.m., arriving in Ciudad Obregon, Sonora, on 4-10-68. Here he read a local newspaper which contained a drawing of the murderer of KING. He stated he immediately recognized that this was the individual who had held him up in Mazatlan, and whom he had last seen in Mexico City. On this date, he wrote a letter addressed to BAYARD RUSTIN, a Negro leader in New York, which letter he sent to "Director Ejecutivo del Instituto--Phillip Randolphs, New York, USA," informing him of the above information. He spent the entire week in Obregon, and on 4-20-68 arrived in Hermosillo, Sonora.

On 4-21-68 he sent a telegram to the FBI office in New York, stating "I have located the person responsible for the assassination of Martin Luther King. Please call me in Hermosillo, Sonora, Mexico, 3-26-85. I don't speak English," signed ALEJANDRO RIVERA.

RIVERA advised that at no time during this incident did his girlfriend observe the individual whom he has identified as the murderer of KING, nor did he relate any of the foregoing information to her.

He described this individual as a white male, North American, age 40, 5' 10" tall, weight 180, complexion "yellowish," wearing a western style hat and a gabardine raincoat, both gray in color.

He stated that at no time did he see this individual without the hat or raincoat, and that the individual spoke fluent Spanish. He suggested that the individuals at the taxi stand in Mexico, D.F. probably knew the present whereabouts of this individual.

RIVERA expressed concern that police investigators might contact his wife, ZAZUETA NIEBLAS DE RIVERA in Ciudad Obregon, and inform her of his travel with his girlfriend. He stated that he planned to remain in Hermosillo for three more days and then return to Ciudad Obregon.

BUS 14 AUTOTRANSPORTES TRES ESTRELLAS DE ORO

On 5/2/68 GUILLERMO DAVILA Traffic Manager for the bus line Autotransportes Tres Estrellas de Oro, Niño Perdido 19, Mexico City, Mexico, R furnished the following information.

He confirmed that their bus No. 14 left ~~Spain~~ Ciudad Obregon, Mexico at 1:55 PM on April 25, 1968 bound for Guadalajara and eventually Mexico City. This bus originates in Tijuana and their passenger manifests list only the passengers who originally boarded at Tijuana. Passengers purchasing tickets at other points appear on another list and only by ticket number, said numbers corresponding to the series of tickets issued to the purchase point. He furnished copies of the original manifest and the supplemental list.

IN addition they have a record of tickets issued by the driver, who is permitted to sell passage on board. On this particular section no tickets are recorded as having been sold by the drivers ~~after~~ after departure from Tijuana.

Four tickets were sold at Ciudad Obregon for passage to Guadalajara. Three were at the discount rate of \$80.40 pesos, indicating they were for Mexican students. The other ticket was for full fare of \$107.20 pesos. He emphasized that this ~~ticket~~ ticket was sold in the station at Ciudad Obregon. The list shows this ticket as No. 3901.

They share the station at Ciudad Obregon with Transportes Norte de Sonora and cooperate with this line. However they would not honor a ticket sold by them and in fact if a passenger bought a ticket to Guadalajara and got off at ~~Spain~~ Ciudad Obregon he would forfeit his right to the remainder of the passage to Guadalajara on a later bus. He would have to purchase another ticket to Guadalajara.

The suggestion was made that suspect individual who was believed to have been traveling on BUS 359 of Transportes del Norte and who was reported to have gotten off at San Luis Potosi, might have continued on the same date, April 6, on bus 382 of the same line.

FRANCISCO DAVILA, residence Calle Sierra de Santa Gertrudis #126, Monterrey, Nuevo Leon, Mexico, was interviewed 5/2/68 at the Mexico City Depot of Transportes del Norte.

He advised that he and his companion driver DE LA ROSA have worked together for over a year. He stated that they have not picked up any passengers in San Luis Potosi for at least a year. He and DE LA ROSA were the crew of bus 382 on 4/6/68.

He noted that it would be very unusual to pick up any such passengers at way stations such as San Luis Potosi and he would have recalled any such incident. He advised that through agreement passengers from San Luis Potosi to Mexico City are supposed to travel by Transportes Chihuahuenses, which uses the same station.

He could not identify photographs of the subject.

In view of the above there appears to be no necessity to locate and interview the other driver DE LA ROSA!

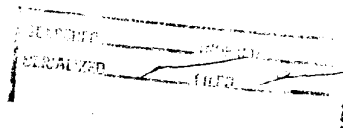

Inasmuch as SA PAGE needs transportation in the Merida-Campeche area, I telephonically contacted Assistant Director AL ROSEN at 9:40 a.m., 5/3/68, and called attention to SAC Letter 67-17, which requires specific Bureau authority to rent a car. It was explained to Mr. ROSEN that PAGE needs a car in that area and, of course, it was not possible for him to take a car from here since it is about a three-day drive and his presence was urgently needed on the peninsula.

SA JACK PAGE at 11:30 p.m., 5/2/68, telephonically advised that he was staying at room 20, Hotel Colon, Merida.

PAGE has been in touch with MEX-34 who has started working but as of that time had developed nothing in connection with this case.

Consul WILLIAM HARBEN has advised PAGE that Chief MENA of the Campeche police is extremely efficient and although he is no longer connected with the State Highway Police, he has another official position which gives him access to the type of information we need. HARBEN stated that under the set-up in Campeche Chief MENA should be able to know all of the Americans in his area within two days.

PAGE also advised that there is only one small, insignificant newspaper published in Campeche and that most of the newspapers read in Campeche are those published in Merida. There are two newspapers in Merida, one of which has approximately 75% of the circulation in the area. PAGE is arranging through Consul HARBEN for appropriate publicity in order to reach not only the readers in Campeche but also in the other sections of the peninsula.

PAGE is scheduled to contact Father O'BRIEN and the Presbyterian missionary in Merida the morning of 5/3/68 inasmuch as both of those clergymen have been on the peninsula for many years and are extremely well-acquainted with conditions in the area and are in a position to be advised of any newly arriving Americans.

He will establish contact with Chief MENA in the afternoon of 5/3/68.

At 9:30 a.m., 5/4/68 Assistant Section Chief CLEMENT McGOWAN was telephonically contacted at the Bureau concerning the following points:

(1) With regard to the new picture received 3:00 a.m., 5/4/68, that picture has not yet been released to the press and should not therefore be given circulation in Mexico at this time. Mr. McGOWAN advised, however, that it was permissible to show the picture to sources and to use on leads.

(2) With regard to the photograph of RAY obtained in Mexico showing him with sunglasses, it is alright to utilize this photograph in contact with sources and handling leads, but it has not yet been approved for release to the press.

With regard to both photographs mentioned above, Mr. McGOWAN is trying to get approval to have both pictures released but is encountering some difficulty due to previous criticism regarding the differences in pictures and descriptions which have been released on prior occasions. It was pointed out to Mr. McGOWAN that we consider the photograph with glasses to be significant here since if RAY should return to the tropics, he might well wear sunglasses which many Americans not accustomed to the tropical sun do. Mr. McGOWAN advised he would let us know immediately if and when approval was obtained for release of those photos to the press.

(3) With regard to the reward information, Memphis has not yet furnished the Bureau complete details but is sending in a newspaper article which has those details. As soon as it is received, Mr. McGOWAN will insure that we are advised of the pertinent details. At the present time, however, Memphis has reported that there are rewards totaling \$100,000 outstanding in Memphis - \$50,000 being put up by businessmen in the city of Memphis; \$25,000 by Scripps Howard newspaper chain, and \$25,000 by the "Commercial Appeal" (a prominent Memphis newspaper).

On 5/3/68, at approximately 8:30 p.m., at the writer was leaving the Embassy, near the rear gate, he was approached by a Mexican who said he wanted to talk to someone in the Embassy because he had information which might have a connection with the murder of Martin Luther King. The man was taken into the office. During interview he identified himself as: ROBERTO MURGUIA, Mexican citizen, residence, Pistillo 34, Col Reloi, ZP 22. He displayed Mexico drivers license # [redacted], as well as credentials showing membership in the National Association of Correnpondants. He said he is self employed, working occasionally, from his home, by dealing in the sale and re-sale of cars. He claimed formerly to have been a taxi driver, which he had to give up due to an injury to his leg. He related the following:

That evening, at about 6:10 pm, he went to visit his friend, JUAN MUNGUIA (similar last name, but no relation), who lives nearby at Pistillo #6. This friend is Chief of the night Police at Medico Centro.

MUNGUIA told him that one of his men, who also works as a policeman at night at Medico Centro, named GALAN, was trying to sell a 1966 "camionetta" for an American who claimed he needed money to return to the United States. The American also wanted to sell a high-powered rifle with telescope lens. He would sell the car and the rifle for 10,000 pesos.

MURGUIA indicated he would be willing to contact GALAN, posing as a prospective buyer, in order to obtain more information and try to identify the American as well as locate the car. He would recontact the writer the following morning at the Embassy, between 8:30 and 9:00 a.m.

MURGUIA appeared at the Embassy at 8:45 a.m., 5/11/68 and was interviewed by the writer, at which time he related the following:

On the previous night he returned home, ate and then contacted JUAN MUNGUIA. They proceeded to Medico Centro where they contacted GALAN. GALAN showed them the 1966 Plymouth "camionetta" and agreed to let them try the car. They drove to MUNGUIA's home, dropped him, then returned to Mexico Centro.

In negotiating with GALAN for the car MURGUIA obtained from him what GALAN claimed was a copy of the entry paper for the car. (This was made available to the writer) GALAN said that the American, whose name was shown as JAMES E. GIROD, of 13218 Budlong, Gardena, Cal., was presently staying on Rhin St. in Mexico City. He wanted 10000 pesos for the car and the rifle. (Apparently GIROD still had the rifle, because GALAN did not indicate he had it, and it was not seen by source. He also thought it best not to be too inquisitive.) The rifle was 30-30 caliber, with 250 cartridges and case. MURGUIA told GALAN he would have to think about the deal and see if he could raise the money. He promised to contact him the following night (Sat., 5/11/68)

MURGUIA was told by the writer that his information would be given to the proper authorities in the Embassy and he would be contacted sometime latter during the day. MURGUIA said he could be reached through the telephone of a friend, Fausto Canseco-Canseco, of Pistillo 32, telephone # 49-86-49.

At 1:15 p.m., 5/6/68, SA JAMES WILSON, Resident Agent, Brownsville, Texas, telephonically furnished the following information:

No such person as MATEO LOPEZ GARCIA or MATEO GARCIA LOPEZ has ever been heard of in Brownsville and Port Isabel. All inquiries in those areas concerning such an individual were negative.

SA WILSON suggested that MATEO LOPEZ GARCIA or MATEO GARCIA LOPEZ might be what is known around Campeche as a "cayucero" (one of the local boatmen who bring beer, women, etc., out to the shrimp boats anchored off Campeche). He referred specifically to the "ENRIQUE" mentioned in our airtel of 2/12/68 in our file 45-21 as sounding like this kind of a person. It was pointed out to SA WILSON that all inquiries in Campeche had failed to develop any information concerning MATEO LOPEZ GARCIA or MATEO GARCIA LOPEZ.

SA WILSON also advised that his office had received a subsequent wire pointing out that part of the former inmate's story had been verified and, therefore, it was considered that the rest of his story might be true. The wire specifically stated that, according to the former inmate, in late 1966 the subject had arranged for another inmate to send out \$15 from the prison to purchase stationery but that no stationery was later received and RAY claimed that he had merely used this channel to send money out of prison without the knowledge of the prison authorities. Further checks had shown that the other prisoner had actually sent out \$15 and some odd cents as claimed by the source. The conclusion was, therefore reached that the rest of his story might be true.


At 4:00 p.m., 5/6/68, SA JACK PAGE telephonically furnished the following information from Campeche:

SA PAGE has rechecked with the six Americans resident in Campeche and ascertained that they have no information concerning the previous visit to that area by subject RAY or his current presence there. SA PAGE has also rechecked with the Highway Police concerning the inquiries being conducted by that agency in all parts of the state of Campeche where they have installations. The checks made by the Highway Police showed that there was a newly arrived American at Champoton; however, a check by SA PAGE showed that that individual is a college professor who is crippled and is not identical with RAY. Highway Police checks in all other zones were negative.

SA PAGE will recheck with the Judicial Police and the State Police concerning the results of their inquiries in the outlying areas of the state of Campeche.

SA PAGE also advised that he had made inquiries at the shrimp freezing establishment in Campeche which has been in business for several years and they had no information concerning either RAY or MATEO LOPEZ GARCIA, aka Mateo Garcia Lopez. People at the freezing plant admitted that they frequently place orders for small items to be smuggled into Campeche but those are small appliances, such as transistor radios, and they claim that no one in Campeche smuggles large appliances, such as television sets.

SA PAGE noted that wide distribution has been given by the police to the flyers and IO's. At Champoton one of the flyers was posted at the police cuartel and at the bus station. SA PAGE advised that he keeps running into MEX-34's trail, which

is an indication of the extensive nature of MEX-34's inquiries. SA PAGE also advised that MEX-34 had checked into the possibility that MATEO LOPEZ GARCIA might have been a "cayucero" as suggested today by Brownsville, but that all of those checks were negative regarding RAY or MATEO LOPEZ GARCIA.

The file on PAPROKI should be checked for pertinent information to be furnished SA PAGE, although Consul WILLIAM HARBEN was very cognizant of the PAPROKI case.

KAISER advised that MEX-156 is rechecking the girl at the bus station but when originally interviewed, she felt positive that the look-alike had been at the bus station on 4/25, basing her opinion on her work schedule and other documents available at the bus terminal.

MEX-156 is contacting all taxi drivers and other methods of transportation around Hermosillo. He noted that

all of the above-listed buses go from Cd. Obregon to Guaymas en route to Guadalajara and Mexico City.

KAISER was instructed to give Guaymas a "BOPAT" shake, including the "zona" and areas where RAY could find someone who speaks English to talk to.

At 6:00 p.m., SA KAISER again telephonically contacted headquarters office and advised that he had just finished talking again to MEX-156. When MEX-156 reinterviewed the girl at the bus station she now admits that she could not be sure if the look-alike had appeared at the bus station on 4/24/68 or 4/25/68. She was positive, however, it was not any other day.

MEX-156 rechecked the "zona" last night with negative results.

MEX-156 is continuing to check cab drivers but has developed nothing positive yet, although several of the cab drivers claim to recognize the photograph although this is a feed-back from the pictures which appeared in the newspapers. He will continue to check the remaining cab drivers.

MEX-59 is in Guaymas trying to give that area a good shake-out.

With regard to the efforts to get San Diego to ascertain the date when the suspect bought a ticket at San Luis Rio Colorado, KAISER will send MEX-156 to San Luis day after tomorrow, as soon as he finishes checking out the cab drivers in Cd. Obregon.

With regard to the inquiry concerning JAMES E. GIROD who was trying to sell a car in Mexico, as reported in SA PARKER's memo of 5/4/68, the following information was furnished at 4:30 p.m., 5/4/68 by Supervisor NOLAN and SA FRED BECKER of the Los Angeles office:

JAMES E. GIROD is an actual individual who resides in Los Angeles. He has a criminal record for passing bad checks and an extortion investigation was previously conducted concerning him based on a threat he made to his wife over the telephone.

The 1966 Plymouth is legally registered to GIROD and there is no stolen report recorded concerning it. GIROD is not wanted for any crimes at the present time.

GIROD's mother advised that he is unemployed, is a compulsive gambler, and his mother believes that he is at present on a trip to Mexico accompanied by his uncle, DONALD GRAY, 53 years of age, who speaks Spanish and is an alcoholic.

Mr. NOLAN inquired what had been the results of investigation based on the information Los Angeles had previously furnished obtained from a Mexican guide that KING's murderer was then at a hotel in Puerto Vallarta. The Los Angeles office has not been advised of the results of those inquiries.

Mr. NOLAN also requested that if we send any "paper" into the Bureau concerning GIROD a copy be furnished to Los Angeles.

A copy of our cablegram to the Bureau of 5/4/68 and a copy of the cablegram reporting the results of the inquiries at Puerto Vallarta based on Los Angeles' previous information should be sent to Los Angeles by mail.

At 2:00 p.m., 5/4/68, Supervisor JAMES PEELMAN telephoned from the Bureau to advise that, according to Dallas, a telephone call was made 12/17/67 at 1:52 p.m. to telephone number "2-JERO" at Ojinaga, Chihuahua, and that on 12/7 at 2:47 p.m. a telephone call was made from Alpine, Texas, to telephone number 7441002 (no city designated) and to Piedras Negras telephone number 691. It was stated that the person making those calls actually talked to Piedras Negras number "6NIE1."

SA PEELMAN was advised that the lead for Ojinaga should be referred to El Paso and the lead for Piedras Negras should be referred to San Antonio since those communities are in the immediate border area.

With regard to telephone number 7441002, Mr. PEELMAN was advised that number is inaccurate since the largest telephone numbers in Mexico are those of Mexico City which have six digits instead of seven. He stated that he would re-check with Dallas and if there was any indication that the call had been made to Mexico City we would be advised.
