(Description white male, 5'8" to 5'9", 160 lbs., heavy, 27 to 30 years, sandy hair, ruddy complexion, wearing dark suit.) Same man returned 8 pm, 4/5/68; acted clam in spite of everyone else's acting excited over assassination. Jowers called police about the man, who was arrested and identified as Gene Pearson Crawford and later determined to have had no part in assassination.

Stated she knew a Ginger (Ginger Nance) and a Sue (Sue Harris); denied knowing Eric Starvo Galt. The three grew up together in Illinois. Harris' parents sent her to live with an aunt in Calif.

Katzenwinkel and Nance went to join her.

Drove a Rambler belonging to Charles Day, Nance's ex-husband, to Oklahoma City, where it broke down and they abandoned it. They got rides from there to San Diego and thence to L.A., arriving Tuesday before Mother's Day 1967. Had room in Palms Motel for two weeks, then moved to Apt. #6, 1535 Serrano Ave., where they stayed until mid-June 1967. Katzenwinkel stayed only a couple of nights, then moved into apt. of Thomas Hunter. In mid-June Nance returned to Illinois.

KATZWINKEL, Anita (cont'd)

Nance dated a Negro for a while; she has been married twice and goes by names of Cunningham (maiden name), Day, and Nance. Nance left clothes and items in Apt. #6, Katzwinkel had help opening door.

When Nance and Katzwinkel came to Calif., they found Harris living in commin-law relationship with Tom Flickeid at Palms Motel. Harris was prostitute. Harris and Flickeid left in 1967 Thunderbird for tour of southern states; last seen Feb. 14, 1968. Description of Flickeid.

Katzwinkel said she did not know Galt or anyone who drove white Mustang; said she had not given her name and Serrano address to anyone; knew nothing about word, "Oklahombe." Furnished pictures of herself, Harris and Flickeid.

Reinterviewed and gave a few more details. Admitted prostitution. Had one "date" at Serrano apt.; described man. Said she had given her name and address to only one customer, a Negro who drove white Mustang convertible.

Did not recognize photo of Vernon or artist's conception of Eric Galt.
