Met Eric S. Galt on Dec. 14, 1967, at bar in St. Francis Hotel, with Stein's sister Rita and cousin Marie Martin; Marie lived room 201, St. Francis. Galt offered to drive Stein to New Orleans in consideration for their registering for Wallace. Next day Galt drove them to register for Wallace in a white Mustang. Galt was present during registration and seemed to be known. They returned to Stein's residence, then went to Bertano address, where Galt got clothes.

Drove to New Orleans via Yuma, Tucson, El Paso. Galt made several phone calls, mostly in Texas. Galt said he was from Alabama, had owned a bar in Mexico. Galt seemed to be involved in Wallace campaign. Galt said he had to contact engineering or contracting firm in New Orleans.

Galt preferred to stay in motel rather than Stein's mother's home. Stein directed Galt to motel on Chartes St., New Orleans. They drove straight through to New Orleans, arriving 12/17/67.

Left New Orleans 12/19/67 with Stein and Rita's 2 children. Drove straight through. Galt made no personal contacts with anyone during return trip.

Galt said if Negro wants to be free, he shouldn't stay in south. Galt paid cash for all trip expenses.

Description of Galt: white male, 32 to 35 yrs, 5'9", approx, 170 lbs, light brown hair, light (possibly green) eyes, wore brown suit, southern accent, neat, no scars.

Before leaving for New Orleans, Galt put clothing into trunk of white Mustang. In trunk was a small blue or grey suitcase and a yellow box which looked like a kodak camera box. Exact route from LA to New Orleans and return given.

Galt purchased a tire in El Paso. On trip Galt said he'd been in Army. Galt said Wallace didn't want to be President, just on ballot and that Stein didn't have to vote for him.

Recalls Galt spoke to man at

Galt mentioned names of streets and places in New Orleans.

Car went off road in snow storm on return trip.

Galt said he had to contact engineering or contracting firm in Chalmet suburb; mentioned names "Jackson Barracks."

Galt told Stein that Galt had seen Stein while Galt was in bar in New Orleans. Could only have been on Canal St.

Says Ray once dated Helena the Greek Goddess, who worked out of Vegas Club across street from St. Francis.

Says Ray made 2nd trip to New Orleans after 2/14/68, at which time Ray took a box of clothes from Marica Martin to her daughter, Marion Eisman (ph).

Says that the New Orleans contractor mentioned by Ray on Dec. New Orleans trip had Italian name and worked in area of industrial Canal. Maria Martin told Stein that the man lived near chef menteur Highway in area of Jackson Barracks.

Reinterviewed concerning all details of his association with Eric Galt. Identified Polaroid photo of Galt in chair, but could not identify surroundings. Has impression that Galt thought he would be making the New Orleans trip with Rita Stein until he was told that Charles Stein would go with him. Described two persons at the place where they registered for Wallace. Galt's suitcase and Kodak Camera box were in trunk when Galt picked up Stein; they then went to Surrano address so that Galt could check mail; Galt picked up 2 envelopes. Galt told Stein name and address of the person whom Galt was meeting in N. Orleans, an Italian name, well-known in New Orleans, in Chalmette - Industrial Canal area of the city. Galt purchased used tire near El Paso, later

made phone call.

Arrived New Orleans 12/17/67. Delivered box of clothes to Lorraine Calloway. Then went to Stein's mothers house where Stein left his belongings. Then went to Provincial Motel, where Galt registered. Then Galt drove Stein back to mothers' house.

Galt said he w saw Stein on Canal St. Left New Orleans 12/19, returned LA 12/21. Car went off road in snow on return trip. Stein recalls seeing extra pack of License plates, white with black numerals, in Galts car. The first time they met but not after. Recalls seeing extra Ray after trip. and Galt
