Galt's offer conditioned on their registering for Wallace. Next day Galt drove them to register in white Mustang. Was present while they registered. Then Galt returned Rita and Marie to residence and left with Charles Stein. Approx. 1 week later, they returned

with children. Next day Galt brought one child's toy left in car.

Next saw Galt in mid-Jan. the same bar. She said only hello, and didn't see him again.

Galt never expressed political or racial views.

Lived at rooming house from 3/67-6/68, in Room 6B. At 4 pm 4/4/68, heard voice of Mrs. Brewer in hall; went out and saw her with man near Room 5B.

Identifies profile photo of Ray (Esp. nose and chin) as man he saw that afternoon.

That afternoon, heard footsteps in 5B, and heard man go to common bathroom several times. Toilet flushed only once. 3d time, man stayed in bathroom a long time. Anschutz asked Stephens who was in bathroom at this time, then returned to his room. Between 5 and 6 pm, heard shot

from bathroom; had not heard footsteps of man returning to his room since Arnschutz complained. Heard shouts from Lorraine. Went to hall, and looking over bannister saw man running at end of hallway, carrying bundle in right hand, including a 3 or 4 foot long object. Stephens did not get a good look at him, but thinks it was same man; had on same dark suit.

Description: white male, in 30's, 5'10"-11", 165 lbs, average build, sandy or dark blond hair receding on left side, normal haircut, clean shaven, neat appearance, wearing dark suit, no hat, carrying nothing. Mr. & Mrs. Stephens remained in room during afternoon. Heard someone in 5-B. Several times heard footsteps from 5-B to bathroom. Stephens was quite aware that person remained in bathroom for some time since it was a common bathroom. Heard toilet flushed

only once. Between 5 and 6 p.m. 4/4/68 was in kitchen repairing radio. (Kitchen adjacent to bathroom.) Heard a person go from 5-B to the bathroom and remain there for 20-30 minutes. Heard no noises. During this period Anschutz knocked on door and angrily asked who was there. Heard no steps from bathroom until shot. Certain it was a shot, and certain it came from bathroom.

Went out of kitchen, through living room-bedroom, opened hall door, and saw a man carrying large bundle (3' to 4' long, 6" to 8" thick) running west down hall. Had impression bundle was wrapped, maybe in newspaper. It occurred to Stephens that this was man in 5-B. Anschutz made some remark to man, and man answered.
