Asked Francisco Perez Gomez to write a note to Galt about money she used to go away. Galt did not smoke; drank vodka; introvert; always tired.

First Negro officer to have general jurisdiction over prison yard, and, hence, was resented. Knew "Jimmy" Ray; quite; got along well with Negro prisoners but did not associate with them. Ray operated a magazine-rental service for which he received money or cigarettes. Ray not known to be drug user or to have abnormal sex problems.

Turner does not believe, Ray would kill Negroes and does not believe he

killed King. Turner said the first published sketch of assassin looked more like Aeby than Ray.

Ray was seen associating, with Neal Aeby, a cellmate of Frank Joseph Guinan. Aeby was type to kill Negroes. Aeby had disease. Turner once recommended harsh punishment for Aeby; Ray may have resented harsh recommendation. On day of Ray's escape, J.C. Fletcher, an inmate, reported to Turner that there had been an escape.

Black Muslims is only "hate" group in prison.

Turner could not recall seeing Ray with Jimmy Carpenter, does not recall Raymond Lewis Curtis.

Jimmy Bradley may have known Ray. Bradley was successful in prison rackets.

Turner had not heard of King bounty.

Always came in on Saturday afternoon with underwear, T-shirts, and dress shirts. Vernon thinks he would leave a bundle and pick up a bundle. Vernon identified laundry mark as similar to laundry's; photos of underwear could be Galt's.

Entries in laundry book show Galt's first name as Eric.

Galt usually wore Bermuda shorts.

Description: White male, 44-45 yrs., 5'9",
