Mrs. Peters, manager of laundry, waited on white male who gave name Eric Galt on April 1, 1968, shortly before 10 am. He deposited 4 undershirts, 3 underdrawers, 1 pr sox, 1 wash cloth for laundry, and 1 coat, 1 trousers, 1 tie for dry-cleaning. Slip for laundry indicates EGC83 would be on laundry in indelible pencil. Slip for dry cleaning, indicates a tag with 8/755 would be stapled on dry-cleaning.

Description of clothing: black check suit coat with small check blocks, dark gray trousers, black tie with tan and brown diagonal stripes.

Description of Galt: in 30's, approx. 185 lbs, slightly more than 6' tall
