About 4 pm, 4/4/68, man entered York Arms and said he wanted to buy pair binoculars. Mr. Carpenter said they were almost out and had one pair for \$200 and one pair for ninety-some dollars. The man said these prices were too high, and Mr. Carpenter said he might have a cheaper pair in window. Carpenter went to window and returned with pair of Bushnell binoculars size 7 x 35 for \$39.95. The man raised them to his eyes and indicated they were acceptable. Man asked if instructions were in box.

Carpenter wrote price on box and wrote tax of \$1.60, then added the two figures for total of \$41.55. Placed sales slip and box containing binoculars in gray paper bag which bears name of York Arms. Binoculars were in leather or simulated leather case.

Description of customer: white male, 26-32 yrs, 5' 11", 160-175 lbs; black or dark brown hair, neat, combed straight back with no part; no glasses; ruddy complexion; medium build; dark suit, white shirt with noticeably wide space at collar, dark tie with light stripe tied in long slender knot not filling space between collars.
