Ran out north door, east toward motel; jumped over fence, dropped down 10' retaining wall, ran to driveway on Mulberry. Dropped fire-arm, picked it up. Ran north on Mulberry to Huling, west on Huling to Main, south on Main to Jim's Grill. Saw no pedestrians; told customers to say in Grill. Continued running south on Main and saw items in doorway at Canipe Amusement Co. Saw other officers approaching, turned around, and walked

to Canipe, then across street by blue Camero. Positive no one left area on foot or by car after he arrived on Main St. Only time he couldn't see street was when he stepped into Grill momentarily.

Did not see Canipe until he returned to Amusement Co. at which time other officers were there. After hearing reports from Canipe customers and squealing tires, he observed tire marks in road probably made by car parked in 2nd space.

Thinks he was the deputy seen by persons in Amusement Co.

Assigned to Tactical Unit 10 (3 vehicles, 12 officers), stopped at Memphis Fire Dept. at Main and Butler, 1/2 block from Lorraine at about 6 pm, 4/4/68. Negro detective ran into firehouse and said King was shot.

Ghormley ran east on Butler to Mulberry and north on Mulberry toward Lorraine Motel, saw Negroes on balcony pointing to a building west of motel, the front of which was on S. Main.

Ghormley retraced steps around firehouse and ran north on Main.

Noticed blue suitcase, rifle box, blanket. Canipe said man dropped it and gave description. Ghormley relayed information to dispatcher by walkie-talkie. Canipe mentioned white Mustang. Relayed info to dispatcher.

Ghormley guarded the articles so no one could disturb them. Other officers arrived.

Tactical Unit, on phone at firestation, saw men running, hung up phone, followed them to Mulberry, learned that King had been shot and that shot believed to have come from building north of firestation. Ran to Main St. where there were 2 Memphis policemen and a Deputy Sheriff. Took up position in street in front of Canipe Amusement Co., saw satchel and rifle on green cloth in doorway, kept watch of articles but stayed in position.

Other officers searched parking lot. Man came out of Canipe Amusement and said he had been ordered to go to police station. Gross checked with superior and told the man it was OK to go. Man left in pick-up truck.

Gross saw Inspector N. E. Zachary and another officer collect satchel, rifle, and green cloth with handkerchiefs so as not to touch items. Observed from 10 to 15 feet.

Does not recall Patrolman Dollahite running on Main St.

Says, if person started to go south on Main, first thing he would have seen were 3 police cars. Possibly explains why man dropped bundle.
