Recalls that Galt used Spanish phrases. Recalls seeing Galt after return from New Orleans and that he mentioned friends who lived in Industrial Canal area or in Chef Menteur Highway, New Orleans. Recalls seeing girlie magazine in his room when they exchanged TV sets. Recalls that Galt, in response to a question, said he did not have polaroid camera. At that time, ~~Galt~~ Galt said he was going to travel through

the South, and agreed to take a package of clothing to Martin's mother in New Orleans.

About 2 weeks later Galt left some barbells at her apt. He said he was broke and expecting money from his brother.

Recalls that Galt once mentioned smoking marijuana but said it did nothing for him. Recalls showing Galt an ad in LA Free Press for "hot tempered man."
Answered questions about Charles and Rita Stein. Said one was not romantically involved with Galt.

Met Eric S. Galt on Dec. 14, 1967, at bar in St. Francis Hotel, with Stein's sister Rita and cousin Marie Martin; Marie lived room 201, St. Francis. Galt offered to drive Stein to New Orleans in consideration for their registering for Wallace. Next day Galt drove them to register for Wallace in a white Mustang. Galt was present during registration and seemed to be known. They returned to Stein's residence, then went to Sertano address, where Galt got clothes.

Drove to New Orleans via Yuma, Tucson, El Paso. Galt made several phone calls, mostly in Texas. Galt said he was from Alabama, had owned a bar in Mexico. Galt seemed to be involved in Wallace campaign. Galt said he had to contact engineering or contracting firm in New Orleans.

Galt preferred to stay in motel rather than Stein's mother's home. Stein directed Galt to motel on Chartes St., New Orleans. They drove straight through to New Orleans, arriving 12/17/67.

Left New Orleans 12/19/67 with Stein and Rita's 2 children. Drove straight through. Galt made no personal contacts with anyone during return trip.

Galt said if Negro wants to be free, he shouldn't stay in south. Galt paid cash for all trip expenses.

Description of Galt: white male, 32 to 35 yrs, 5'9", approx, 170 lbs, light brown hair, light (possibly green) eyes, wore brown suit, southern accent, neat, no scars.

Says Ray made 2nd trip to New Orleans after 2/14/68, at which time Ray took a box of clothes from Marica Martin to her daughter, Marion Eisman (ph).

Says that the New Orleans contractor mentioned by Ray on Dec. New Orleans trip had Italian name and worked in area of industrial Canal. Maria Martin told Stein that the man lived near chef menteur Highway in area of Jackson Barracks.

Told doctor he had no "deep dark secrets". Was cooperative with doctor. Doctor hypnotised him; was cooperative and it was easily done. Told doctor he was getting better.

I.D. Ray photos - 4/19/68

Ray came to 6 appointments 11/27/68, 12/4/67, 12/6/67, 12/11/67, 12/14/67 and cancelled appointment on 12/18/67. Told doctor his brother in Louisiana had found him a job in New Orleans in Merchant Marines and could not come again. Ray paid \$25 a visit in cash each time. Possibly sent one money ~~order~~ order for final payment.
