(1) On 10/3/67, received order from Galt at at B'ham address for one Kodak Dual Projector M952, one Kodak super 8 camera model 8, one HPI combination splicer and 20 feet remote control cable for \$337.24 on money order.

(2) Above equipment sent out 10/3/67 under invoice #179530. Substitution of a Crestline Super 8 camera for Kodak model M8 made on loan as latter not in stock.

(3) On 10/12/67, Crestline camera returned. Accompanying equipment was letter from Galt dated 10/5/67 acknowledging equipment its return. He also said he was going to Mexico 10/7/67 and would send his address.

(4) On 10/18/67, the Kodak Super 8, under

invoice #179530 sent to Galt in B'ham. By a typed letter signed Galt, the company was advised Galt returned the Crestline saying he could not wait for Kodak. He requested refund be sent to him to Puerto Vallarta, Jalisco, ~~Max~~ Mexico, Apartado Postal #23. The Kodak camera was received by company 11/2/67.

(5) Letter from Galt dated 11/20/67, requesting refund be sent to 1535 N. Serrano, LA as he did not get ~~in~~ it in Mexico. Galt said he'd be in LA for 5 months.

(6) On 11/30/67, company re-mailed refund check #322338, for \$142.89 to Mexican address. (cancelled refund check has not, as of 3/29/68 been received).

(7) On 10/2/67 Galt's original check for

\$337.24 deposited at Merchandise National Bank, Chicago.

(8) Galt's request for an automatic printer and sound strip indicates he would employ them.

(9) Stated he received call 10/4 or 10/5/67 between 8-9 am from Eric Galt saying he was returning Crestline camera. Man had southern accent.

(10) Furnished to agent a Prinz Air Shuttle release with 20 foot cable like one found (on 4/15/68) also furnished same date on blank Superior Bulk Film Co. check drawn on Merchandise National Bank similar to refund sent Galt.
