

Went with Galt on 2 occasions. Galt always drank screwdrivers (1 or 2). Not a bigh spender. Went to see floor show with Galt; As leaving saw girl named Elisa at bus stop. All 3 went to Club Los Labos where Galt got drunk or sick. Went to sit in car. Galt then took Garcia home, saying he wanted to stay with girl.

Galt drove white mustang, red insides, automatic. Blue license plates. Galt complained one car tire was too large. Galt said plates said alabama.

Garcia went to Galt's room day after picking

Says Galt was guest at above's hotel: Hotel Rio, Morelos 86 from 10/19/67 thru 11/5/67. Galt remembered to be alone.

In Puerto Vallarta, Jalisco

(Same person as Irma Morales). Was prostitute at Casa Suana at Puerto Ballerta. Identified photos of Ray as Galt.

Met him she thinks 10/24/67. Next day they slept together, and did so for several days. Galt allowed self 100 pasos (\$8) a day for drinking and 100 pesos a day for women. Drank beer in day; the tring the description of the first rolls of firm in camera, and red insides. Upon return Galt took out new poloroid from ice chest in back of car. Took photo of her-was bad-he destroyed it. Stopped again-took another photo-also bag and destroyed. Galt said it was one of the first rolls of firm in camera,

and had 2 pictures left. Returned home about 5 pm.-did not stay at Casa Susana.

Returned next day at 9 pm-bekween believe it to be 10/29. Galt got into argument with Negroes there. Went to car and brought back what she believed a gun. Galt said he hated Negroes and was going to kill them. left. Galt said he was going after them, but she said cops were due to visit house any minute. Galt left. Galt came back next day: Said he was going to sleep and eat only for next few days. Returned she thinks next Thursday, saying he was going to move to Hotel Tropicana. He spent about 200 pesos (\$16) and left. Returned next evening between 8-9 p.m.. Manvela was drunk. Galt got mad- Photographer took photo of him. & Galt said he was going

to Yelapa Sat and Sunday. Left.

Returned next Monday between 8-9 p.m. Galt still mangry with her re photo and drunk. Galt asked her to marry him again. She refused. Galt spent evening with Arcella (Elisa). Saw Galt following 3 days but did not talk.

Said he only smoked marijuana, drank gin. Could not dance. Spoke no Spanish. Had an old pair of sandals.

Furnished photo taken of Galt around 11/3/67.

Furnished registration card for Hotel Tropicana (report unclear).

Said Galt probably left 11/13/67 between 9 am and 11 am.

Hotel in Puerto Vallarta, Jalisco

Prostitute at Cosa Susana, Matamoros 503, Puerto Vallarta. Called "La Chilindrina."

Galt came to her room in 10; 711/67; Said he was on 40 day vacation/Puerto Vallarta. Language proglems. Told her he had car outside and wanted to take her to Posada Vallarta to spend night. She refused. He stayed at Cosa Susana; left 8 am next morning. Mezo was absent from city for 8 days. Upon return, Galt staying with "Irman", another girl at Coss Susana. Irma got drunk; Galt tried to renew frendship with Meza, said through with Irma. Galt left Cosa Susananot seen again.

I.B. photo or Ray - taken 1968 in Calif. as Galt. (Meza did not remember Galt's name.)

Proprietors of motel at Playa la Gloria.

Remembered American in white mustang that came to motel with Elisa in 11/67. Also came twoce alone. Left room at dawn and returned locking self in all day. Came a 4th time with an unknown prostitute.

XXV-7 Girl at Casa Susana. Slept with Galt several times.
