intend to meet with Mr. Phil M. Canale, State Attorney General, Shelby County, Tennessee, during the latter part of September, 1968, to thoroughly discuss the state's prosecution. Mr. Canale is, of course, aware of the existence of the evidence and the results of our findings. The Department advised that in the event Mr. Canale desires a particular piece of evidence for court purposes which we recovered and in our possession, we should make arrangements to turn it over to him.

A conference was held at our Memphis Office with Mr. Canale and his representatives and the matter of lining up witnesses and evidence in the forthcoming state trial was discussed. Mr. Canale proposed the following procedures be established:

1. Representatives of his office to meet with our Laboratory examiners who conducted examination of the evidence. He would like this meeting to take place preferably next week.

2. Mr. Canale would desire that his representatives thoroughly review the actual physical evidence for the purpose of selecting those items which will be most advantageous to introduce and it would be determined the number of examiners he may need in connection with the trial.

3. After review of the evidence he proposes that representatives of his office contact pertinent field divisions and discuss with Agents who obtained the evidence what they can testify to and he may desire to talk to the witnesses. This in effect will amount to a pretrial conference with Agents who conducted the investigation, would obviate the necessity of unnecessary Agents to appear for extensive pretrial conferences, and would minimize the time Agents will spend in Memphis in connection with the trial. This, of course, would result in the savings of Agents travel and per diem cost.

4. Mr. Canale mentioned the possibility that a representative of his office may become involved in foreign travel which would relate to the investigation conducted in those foreign countries. Mr. Canale would, of course, do this at his own expense. Mr. Canale feels it will be necessary for him to evaluate the persons as witnesses and to conclude which witnesses it would be necessary to utilize.

It was of the opinion of Mr. Canale that if the preliminary work can be completed, he can better evaluate what he needs for the trial and feels that on this basis he will need a minimum of FBI personnel to testify as to the various items that may be of pertinence in this case. The SAC in Memphis concurs with Mr. Canale and recommends that we honor his request.

**ASSASSINATION OF MARTIN LUTHER KING, JR.**

This will confirm the conversation between Mr. D. Robert Owen and Special Agents Joseph G. Kelly and Richard E. Long of this Bureau on September 16, 1968, relative to the scheduled state trial of James Earl Ray in Memphis, Tennessee, on November 12, 1968, and possible future action on the part of the Bureau.

Mr. Owen advised he was fully aware that the physical evidence recovered at the scene of the assassination by the Memphis authorities has been returned to them. The results of our Laboratory examinations of this evidence, as well as our Laboratory findings concerning evidence recovered by the FBI, have also been made available to the Memphis authorities. Included in the evidence recovered by this Bureau and presently maintained in the custody of our Laboratory are documents which have been identified as James Earl Ray's handwriting, handprinting, and typewriting. In addition, a 1966 Mustang automobile is being retained by our Atlanta Division in its possession.

In view of the pending Federal charge of Civil Rights Conspiracy against Ray which the Department does not desire to dismiss at this time, it was indicated by Mr. Owen that all evidence recovered by the Bureau with the exception of the 1966 Mustang should be maintained by the Bureau. In addition, it was also indicated that with reference to future court action the Memphis authorities will no doubt need particular items of evidence in the Bureau's possession and arrangements should be made with the Memphis authorities to furnish any item of evidence at their request.

In view of the above, we are instructing our Atlanta Office to turn over to the Memphis authorities the 1966 Mustang automobile and we will retain all other evidence in our Laboratory until a specific request is received from the Memphis authorities.

**ASSASSINATION OF MARTIN LUTHER KING, JR.**

In our memorandum of August 8, 1968, we advised you that in accordance with your request we were disseminating to Mr. Phil M. Canale, Jr., State Attorney General of Shelby County, Tennessee, ten FBI investigative reports; the original documents provided to us by British authorities in regard to the extradition proceedings of James Earl Ray and the most recent report of New Scotland Yard; and a copy of our prosecutive summary report.

The Department has been furnished copies of additional investigative reports, as well as memoranda containing the results of investigation conducted by foreign police departments recording efforts to locate Ray as a fugitive.

In view of the fact that the state trial of James Earl Ray in Memphis is scheduled for November 12, 1968, you are requested to advise us if you desire any of the additional reports and memoranda already in your possession which have not been previously provided Mr. Canale furnished to him now.

**NOTE:**

We disseminated copies of our reports to the Department which record the results of investigation as to the prosecutive aspect of the assassination of Martin Luther King, Jr. We have also furnished the Department with copies of documents in regard to the extradition proceedings of James Earl Ray, a most recent report of New Scotland Yard, and a copy of our prosecutive summary report. With Departmental approval, we furnished copies of these reports and documents to Mr. Phil M. Canale, Jr. who is handling the state's prosecution in this case.

We have also furnished the Department with additional investigative reports, as well as memoranda containing the results of investigation conducted by foreign police departments recording efforts to locate Ray as a fugitive.

In view of the fact that the state trial of Ray in Memphis is scheduled for 11-12-68, we are requesting the Department to advise us if they desire any additional reports or memoranda be furnished Mr. Canale. It is desired that the further dissemination of the reports and memoranda to Mr. Canale be a decision of the Department as this could possibly avoid any criticism at a later date.

We previously advised the Department that Mr. William Bradford Huie, author, whose books include, "Three Lives for Mississippi" dealing with the murder of the three Civil Rights workers in June of 1964, was interviewed at his home at Hartselle, Alabama, at his request and wanted to "bargain" with us. (He would furnish us information as provided to him by Ray in exchange for current non-publicized photographs of Ray.) We advised our Birmingham Office not to "bargain" with Mr. Huie under any circumstance. We also advised the Department that Huie has obtained notes from James Earl Ray, and Mr. Huie is preparing an article in "Look" magazine based on these notes. The obtaining of these notes was discussed with the Department and they advised they are considering the question of obtaining a search warrant or subpoena duces tecum for Mr. Huie's notes and/or calling Mr. Huie before a grand jury.

The attached is in response to our memorandum which stated that unless promptly advised to the contrary, we would furnish information referred to the above to Mr. Phil M. Canale, Jr., State Attorney General, Shelby County, Tennessee, who is handling the state's prosecution.

Thank you for your memorandum of September 10, 1968, advising that Mr. William Bradford Huie was interviewed at his home in Hartselle, Alabama, at his request and providing me with information concerning that interview.

The action to be taken by the Department now with respect to the notes from James Earl Ray reportedly in the possession of William Bradford Huie raises a number of legal questions. These questions have been under consideration by this Division since your Bureau first reported the matter on August 27, 1968, to Mr. D. Robert Owen and they are presently being considered by the Attorney General. I plan to communicate with you immediately upon the resolution of these questions. Until that time, I would appreciate your postponing any action to furnish information with respect to the matter of the Ray notes to Mr. Phil M. Canale, Jr., State Attorney General, Shelby County, Tennessee, as outlined in the final paragraph of your memorandum of September 10, 1968.

ASSASSINATION OF

Mr. William Bradford Huie was interviewed at his home in Hartselle, Alabama, at his request. He advised that while James Earl Ray was incarcerated in London, England, he (Huie) entered into a contract with Ray to write the true account of Ray's activities and background concerning the assassination of Martin Luther King, Jr. This contract is also of interest to Arthur Hanes, Ray's attorney, inasmuch as the cost of the trial, including attorney's fees, is dependent upon the commercial success of the contract. Mr. Huie has advised that to date he has invested approximately \$20,000 in this venture.

Mr. Huie further related he is in constant contact with Ray through Attorney Hanes in the form of written questions and answers by Ray. These items include names of cities, states, places, maps and individuals contacted by Ray as well as activities from the date of his escape from prison to his apprehension in England.

Mr. Huie stated that he has been refused personal contact with Ray by Judge W. Preston Battle, the judge who will handle the trial. Mr. Huie further stated that he desires to obtain current nonpublicized photographs of Ray and he would be most willing to divulge all information he has received to date to the Bureau on a confidential basis provided his request could be met. Mr. Huie was advised that this Bureau would not attempt to influence, interfere with, or suggest action taken by state officials or courts.

On August 27, 1968, Mr. D. Robert Owen of your Division was advised that William Bradford Huie has obtained notes from James Earl Ray, and Mr. Huie is preparing an article in "Look" magazine based on these notes. Mr. Owen advised that he will consider the question of obtaining a search warrant or subpoena duces tecum for Mr. Huie's notes and/or calling Mr. Huie before a grand jury.
