The enclosures refer to investigation conducted relative to referenced matter as it appeared to refer to captioned matter.

The Bureau's attention is directed to the fact the FCC does not have an office in the Memphis area; however, an official of the Memphis PD did contact a representative of the FCC at Atlanta, Ga., to report this incident. No inquiry has been received by the Memphis PD or this office from FCC relative to this referenced incident and therefore it appears FCC is not interested in a CB radio transmission of this type.

Concerning the possibility of interviewing other individuals contacted by the Memphis PD during its investigation of this matter, it is pointed out no attempt was made to interview these individuals due to the investigation conducted by the Memphis PD and due to the lack of evidence indicating anyone other than EDWARD LE MASTER MONTEDONICO, JR., was responsible for this radio transmission.

EDWARD LE MASTER MONTEDONICO, JR., was interviewed as indicated on the enclosed FD 302. He indicated during the interview that he had a great deal of experience in CB radio transmissions and in the operation of these units. He commented several times that anyone with a knowledge of CB radios could disguise their voice and transmission so as to go on broadcasting without being identified. He also said that there is no way for anyone, including FCC, to identify the sender of a transmission such as the one mentioned above unless the guilty individual made the admission that he or she was the individual that made the broadcast.

It is also noted that others during this investigation expressed the same opinion that it is impossible to identify the individual making a broadcast of this type unless the guilty person admitted doing same.

It was determined also that there are numerous individuals in the Memphis area operating CB radios illegally and/or without being properly licensed. It was further determined that numerous individuals broadcast using "skip" identification, which is illegal, but which is known only to the sender and

receiver. There are also numerous licensed CB radio operators in the Memphis are and it was suggested that there are possibly an equal number that are not licensed and, therefore, it would be virtually impossible to interview each and every individual either having a CB unit or having access to one.

Various individuals commented during this investigation that no one gets too excited about illegal broadcasts since the FCC generally levies a fine of up to \$50 and possibly lifting the license for 3 to 6 months if a person is guilty according to the FCC of making a broadcast of this type. Therefore, no one does much about these illegal transmissions since the punishment is this light. It was expressed that the greatest fear of CB operators is the bad name they receive when incidents of this nature are made public.

In light of the above, UACB no further investigation is being conducted concerning referenced matter.

This is the case involving the murder of Martin Luther King, Jr.

With reference to the dissemination to the Department of investigative reports in this case, such reports fall into two categories: 2) reports containing information of evidentiary value pertinent to the prosecution of the Federal violation involved; and b) reports containing the results of the extensive fugitive investigation conducted to locate and apprehend the subject, James Earl Ray.

All reports pertinent to the prosecution of the Federal violation involved, and in which the Department has a legitimate interest, have been disseminated promptly to the Department and there has been absolutely no delay in doing so.

The remaining reports contain the results of our extensive fugitive investigation to locate and apprehend Ray. Copies of these reports were not disseminated to the Department since they relate solely to the fugitive aspects of the case, and contain no evidentiary material or information of value to the Department in the discharge of its prosecutive function relative to the Federal charge involved.

There are twenty such reports involving approximately 2,000 pages. They contain background data and results of extensive interviews and/or other investigation conducted to locate Ray. Although they do not relate to the prosecution aspect of the case, they will none the less be furnished to the Department in accordance with Mr. Pollak's specific request.

In this connection, by letter dated July 12, 1968, received at the Bureau July 15, 1968, Assistant Attorney General Fred M. Vinson, Jr. of the Criminal Division requested we review the records of the Missouri State Penitentiary pertaining to Ray, and summarize references to Ray's family background; education; physical, medical and psychiatric examinations and disciplinary proceedings. destially came to our attention before Vinson's memorandum was written that British prison authorities had asked Vinson for information of this type in connection with their responsibility to maintain Ray's custody and the extradition proceedings.)

We had, of course, reviewed much records in the initial phase of the fugitive aspect of the investigation, and the results had been set forth in the fugitive reports dated May 15, 1968, and June 14, 1968, submitted by our Kansas City Office. Copies of these reports, which contained in full the information requested by Vinson in his letter, were furnished to him on July 19, 1968. Since the Attorney General had requested that information relating to the case be furnished to both Vinson and Assistant Attorney General Stephen J. Pollak of the Civil Rights Division, copies of the pertinent reports were also furnished to Pollak.

It should be noted Vinson did not furnish Poliak a copy of his (Vinson's) July 12, 1968, letter to the Bureau and consequently Poliak is apparently completely unaware the pertinent Kansas City reports were furnished to him and Vinson in answer to Vinson's specific request. This is another typical example in the Department of the left hand not knowing what the right hand is doing and explains why Poliak has gone off half cocked in erroneously accusing us of delay in disseminating the reports in question.

As a further example of this lack of coordination between Pollak and Vinson as relates to this case, it is noted that after Ray was turned over to state authorities in Tennessee we inquired of Vinson by letter whether the Federal process against Ray should be dismissed since the extradition order did not cite the Federal Civil Rights charges and it was our understanding that Ray could not, therefore, be prosecuted on Federal charges. A copy of our letter was furnished to Pollak.

Vincon in reply advised us that he felt the Federal process should be dismissed; however, Poliak, apparently unaware of Vincon's position, subsequently advised us that he felt the process should not be dismissed pending disposition of the state number charges against Ray. It was necessary for us by memorandum to point out the discrepancy in the two views and request clarification in the matter.

ASSASSINATION OF MARTIN LUTHER KING, JR.

Reference is made to your letter dated August 16, 1968, requesting that copies of all investigative reports and results of interviews prepared in this case be furnished you and referring to alleged delay on the part of this Bureau in furnishing the Department copies of reports dated May 15, 1968, and June 14, 1968, prepared by our Kansas City Office.

For your information, investigative reports prepared in this case fall into two categories: 1) those containing information of evidentiary value pertinent to the prosecution of the Federal violation involved; and 2) those containing the results of the extensive fugitive investigation conducted to locate and apprehend the subject, James Earl Ray.

All investigative reports pertinent to the prosecution of the Federal violation involved have been furnished to the Department promptly and on a timely basis.

The remaining reports prepared in this case pertain solely to the extensive fugitive investigation conducted to locate the subject. Such reports are not normally furnished to the Department since they contain only information relative to the fugitive aspect of the case and do not contain information of evidentiary value or of pertinence to the prosecution of the Federal violation involved.

The reports repared by our Kansas City Office and referred to in your letter fall into this category. An additional twenty such reports have been prepared by our various field divisions, and in accordance with your specific request, copies of all these reports will be furnished under separate cover to the Attorney General, to you and to the Assistant Attorney General in charge of the Criminal Division.

For your information, Assistant Attorney General Fred M. Vinson, Jr., by letter dated July 12, 1968, which was received in this Bureau July 15, 1968, requested that the records of the Missouri State Penitentiary be reviewed pertaining to Ray and references to Ray's family background; education; physical, medical and psychiatric examinations and disciplinary proceedings be summarized. Such records had previously been reviewed in the initial phase of the fugitive aspect of this investigation, and the results of the review had been set forth in the pertinent reports prepared by our Kansas City Office and referred to in your letter. Since they contained the desired information requested by Assistant Attorney General Vinson, copies of these reports were furnished to Mr. Vinson on July 19, 1968, with a copy for you, even though they did not appear to contain information relevant to the prosecutive aspects of this case, but rather to the fugitive investigation.

We will continue to furnish to the Department, on a timely basis, copies of investigative reports and the results of interviews prepared in this case.

Special Agent in Charge Robert Jensen of our Memphis Division received a subpoena duces tecum on August 20, 1968, requesting his appearance in court at Shelby County, Memphis, Tennessee on August 21, 1968, and to bring with him documents pertaining to Charles Quitman Stephens. Stephens, a witness in this case, lived in a rooming house at which Ray stayed on April 4, 1968.

The matter in court relates to writ of habeas corpus in order that Stephens, who is being held by the state as a material witness, might be released from incarceration.

This matter has been discussed with the Department, and they advised they are sending to SAC Jensen a telegram to the effect that he is to appear in court as directed, he is not to take any documents with him, he is not to answer any questions concerning investigation conducted regarding the assassination of King, and if necessary advise the court he is under specific instructions of the Attorney General and cite Departmental Orders. The Department also advised a representative of the United States Attorney's Office in Memphis will be in court.

Memphis has been advised of the discussion with the Department.

This is in response to your memorandum of August 5, 1968, concerning the question whether the Sederal complaint against James Earl Ray should be dismissed.

I have discussed this entire matter with Assistant Attorney General Vinson who dealt with the British authorities concerning the extradition. He has no objection to allowing the federal complaint to remain outstanding under these circumstances.

In reply to your inquiry as to the circumstances under which federal prosecution would be pursued, we would want to review the facts after the conspiracy investigation has been completed; if the evidence and the outcome of the State proceedings were such that federal prosecution seemed desirable, we would consider taking steps to try to obtain the necessary waiver from the British government.

This is the case involving the murder of Martin Luther King, Jr.

William Somersett, a former symbol informant was discontinued by the Bureau as he furnished unreliable information and information that could not be verified or corroborated. Re recently provided information to the effect that several individuals involved in various acts of violence in Mississippi could possibly be involved in the assassination of Martin Luther King, Jr. The person allegedly furnishing information to the former informant is Margaret Capomacchia, who is believed to be mentally disturbed and is the mother of Kathleen Ainsworth, who was involved in the bombing at the residence of Meyer Davidson, Meridian, Mississippi, on 6/30/68. Ainsworth was killed in an exchange of gunfire with police officers.

Our Jackson Office has accounted for the whereabouts of these individuals enumerated by the former informant during the pertinent time. The mother of Ainsworth was located and interviewed, and she refused to discuss the entire matter. She denied knowing anyone by the names as enumerated by the former informant. Mismi points out that prior interviews with the son and daughter-in-law of Capomacchia indicate that she has a mental problem.

In view of the alleged mental condition of the mother of Ainsworth and in view of the past performance of the former informant, coupled with the possibility that he may be fabricating the entire situation, Miami is being instructed to have no further contact with the former informant in regard to this alleged conspiracy. We are also instructing Miami, as well as other interested offices, not to conduct any further investigation; however, if any information comes to their attention they should notify the Bureau, submit same with recommandations and take no further action.



Legat, London transmitted to us a report of New Scotland Yard concerning the activities of James Earl Ray while in London, England. We transmitted this report to Mr. Vinson, Assistant Attorney General. Mr. Vinson, in his memorandum of August 6, 1968, stated that in connection with Document Number Nine appended to that report, he noted that "Sneyd's" possessions, as listed, included one Barclays Bank slip in name of Sneyd. Mr. Vinson stated he would appreciate being informed of what sort of bank transaction was represented by this document.

The personal effects, including this slip, are presently in possession of the Shelby County Sheriff's Office, Memphis, Tennessee. Memphis obtained copies of the bank slip and transmitted them to the Bureau. We are responding to Mr. Vinson's inquiry and are enclosing copies of the Barclays Bank slip. Legat, London has been requested to determine if New Scotland Yard conducted any investigation in that particular matter and if so, advise us of the results thereof.
