JERRY O'LEARY AND

Jerry O'Leary, a very friendly and reliable contact of the Bureau with "The Evening Star," has advised that he has been contacted by "The Reader's Digest" on the possibility of writing a story regarding the Martin Luther King case for the July, 1968, issue of "The Reader's Digest." O'Leary has been the author of two outstanding articles on the Director.

O'Leary said that the officials of "The Reader's Digest" still remember very vividly that it was an article in the November, 1960, issue of their magazine which led to the apprehension of Joseph Corbett, Jr. —the kidnap—murderer of Adolph Coors III. We, of course, cooperated with "The Reader's Digest" in the preparation of that article; and "The Reader's Digest" has told O'Leary that they are hopeful a similarly effective article concerning the fugitive in the King case can be published.

According to O'Leary, "The Reader's Digest" feels that the search for James Earl Ray contains many of the same elements as did the search for Joseph Corbett, Jr. --in that both cases involve a "loner" who used fictitious names and backgrounds to conceal true identity. With a multimillion circulation in the United States, Canada, Mexico and other countries, "The Reader's Digest" feels it may be able to stage a repeat of the success which followed its 1960 article on the Coors case.

If James Ray is still at large when the July, 1968, issue of "The Reader's Digest" goes to press, the magazine would like to publish an article setting forth brief facts of the King case and extensive data regarding Ray's background and character which might prove helpful in turning him up. If Ray is apprehended prior to mid-June, 1968, when the July Issue of "The Reader's Digest" is printed, the magazine would, of course, change its approach to the article.

In connection with the Martin Luther King case, there has been some speculation that James Earl Ray concocted the alias of Eric Starvo Galt by combining the names of characters from Ian Flemaing books and from the book "Atlas Shrugged" by Ayn Rand. This speculation is based upon the fact that in Ian Flemaing's series of James Bond books, an individual named Ernst Stavro Blofeld is one of the most formidable adversaries who confronts James Bond. Ernst Stavro Blofeld, for example, appears in "Thunderball," "On Her Majesty's Secret Service!!" and elsewhere in the James Bond series. It will be noted, however, that there is a significant difference between Eric Starvo Galt and Ernst Stavro Blofeld.

Ayn Rand's book "Atlas Shrugged" was published in 1957 and is more than 1,100 pages long. The book begins on page 1 with the question, "Who is John Galt?" (Galt is characterized in this book as a

social "drop-out"--a person who has withdrawn from society because he resents the "leeches" who habitually take from, but do not contribute to, the body politic.) It is interesting to note that a person named <u>Eric Starnes</u> also is mentioned in "Atlas Shrugged." On 321 of this book, a chief of police in Louisiana is quoted as stating as follows about the Starnes family:

"There's all sorts of human beings to see in the world, there's murderers and criminal maniacs—but, somehow, I think these Starnes persons are what decent people shouldn't have to see. They're a bad sort....Yes, they're still here in town—two of them, that is. The third one is dead. Suicide. That was four years ago. Its an ugly story. He was the youngest of the three, Eric Starnes. He was one of those chronic young men who go around whining about their sensitive feelings, when they're well past forty...."

The name Eric Starnes--appearing in a book which starts off with the question 'Who is John Galt?"--could prompt some persons to say that James Earl Ray concocted the name Eric Starvo Galt after reading Ayn Rand's "Atlas Shrugged", and that this alias has nothing to do with any of the characters in Ian Flemaing's books. Furthermore, these persons could say similarities do exist between James Earl Ray's family and the family of Eric Starnes as described on page 321 of "Atlas Shrugged." Confronted with the above-cited quotation from "Atlas Shrugged," some of these same persons undoubtedly would insist that RBI frigitive James Earl Ray (like Eric Starnes) has committed suicide. (On the other hand, significant differences can be pointed out between Eric Starnes and James Ray. For example, Eric Starnes is described as the youngest of the Starnes; whereas, James Earl Ray was the oldest child in his family.

Attached are lists of the names which appear in 14 of the 18 Ian Fleming books. The other four Ian Fleming books (Thrilling Cities, "'Octopussy," "More Gilt-Edged Bonds" and "Chitty-Chitty-Bang-Bang") are not available in Washington book stores, including stores dealing in paperback books. If desired, we will ask the New York Office to attempt to run down copies of these four books in that city.

SAC Wesley Grapp of the Los Angeles Office has telephonically furnished the following information.

The Los Angeles Police Department has just furnished to the Los Angeles Office a letter dated 5/1/68 postmarked in Los Angeles and addressed and mailed to the Editor in Chief of the "Los Angeles Times" newspaper in Los Angeles, California. The letter is typed single spaced and purportedly signed by James Ray.

In the letter the writer states that he has been in the Los Angeles area but was departing Los Angeles as of the time he mailed the letter. He alleges that he is sick over having slain King but states he killed him for \$3,000. He additionally states that he is disgusted with articles which have been appearing in the press concerning him, particularly derogatory comments made about him by Warden Harold Swensen of the Missouri State Penitentiary and Cathy Norton, a dance instructor who was quoted as saying that "Ray was clumsy." In the letter he alleges that while he is remorseful over having slain King he will not go back to prison again and will kill himself before doing so. The letter does not indicate where Ray stayed in Los Angeles or what other cities he may have been in since the assassination.

SAC Grapp stated that while it is not known whether the letter is legitimate or a crank letter, it is being forwarded to the Bureau immediately by commercial aircraft for appropriate Laboratory examination to determine if, in fact, it was written by Ray.




