Dear Sir:

Outside of the people who were involved, i am the only person alive who knows about the "conspiracy" which killed Rev. Martin Luther King.

The information, time & events, and people involved, was all told to me by inmate "Tom Rester Pugh" who was living in a cell next to me at the Okla. State Penitentiary in the early & middle part of 1993.

Tom Rester Pugh was part of the Little Dixie Mafia in Tennessee during the 1960's. Other men who were also involved, were close friends & associates of his. Jerry James, Pat Urley, and Hirksey Nix Jr. are a few that are still alive. Jerry James made a deal with the Government to get out of prison, and was once on the F.B.I.'s most wanted list. Pat Urley is in a Federal Prison in Arizona now, and was once a member of the Airborne Rangers & a sharpshooter.

Hirksey Nix Jr. is now doing time in prison, and was once wanted by the F.B.I.

These men, along with another man named Al Mc Donald, committed crimes with Tom Frazier Pugh that only I know about. Five murders, nobles, and killings. Tom Pugh was implicated in other murders in Oklahoma along with two crime partners Al Mc Donald, but was not convicted of some of them. But I personally know about them.

S.M. Bell is an ex-D.A. out of Tulsa Okla. who is in private practice now, also knows about these murders that he could not convict him of. Tom Pugh & Al Mc Donald both were finally convicted of one count of murder, each, on different cases, that they were both involved in together. Tom is doing life at the Oklahoma Penitentiary, and Al Mc Donald was killed there in 1978.

Tom Pugh also did prison time in Texas; did prison time in Kentucky before escaping there in 1976 with Thomas Carthage, and did prison time in New Mexico for robbing Dave Sawyer of 200 or 300 thousand dollars worth of jewelry sometime in 1976 or 1977.

Dave Sawyer was some type of Democratic chairman or official.

Thomas Cawthorne was an F.B.I. informant; was Tom Pugh's crime partner in robbing Jesse Sawyer; and was given a new identity under the witness protection program, for telling about 17 burglaries that him and Tom Pugh had pulled together in different states while they were on escape from Kentucky.

Tom also told me that Cawthorne was smart enough not to say anything about anyone they had killed during that period of time.

I personally know about 3 or 4 different "High profile murder cases" that Tom Pugh & Al M^cDonald, and Tom Pugh & Kirksey Nix Jr. pulled in Okla., Tennessee, & Alabama. And all of the cases are well known by the media, the F.B.I., & S.M. Fallis out of Tulsa Oklahoma.

Tom Pugh told me that he is well known by the F.B.I., and that he has refused to talk to them on different occasions. He also told me that the White House has a special file on him, but will not release it to him. And he believes that the file may have something to do with him & Pat Urley being in Memphis at the time of the assassination.

I personally know of and can place Tom Pugh and Pat Urley in Memphis on 2 seiperate occasions, prior to the assassination.

These 2 men played only a small part in the conspiracy, but Tom told me "WHY" Martin Luther King was killed, and told me "WHO" carried out the conspiracy & "paid off" James Earl Ray.

There was a "Group of 2 other men" who planned & carried it out.

James Earl Ray does not even know about this. That's why he hasn't been able to give any information.

Tom Pugh personally knew these people, had talked to them, and was in Memphis at the time.

Between the months of April & July 1993, i wrote to numerous people trying to get the information out.

I wrote to Chuck Colson, head of Prison Fellowship in Washington DC, telling him that i knew about the conspiracy, and asked him to please notify Rev. Jesse Jackson for me.

I later recieved a response from a lady there stating they could not help me with my request.

I also wrote Chaplain Ray, head of the International Prison Ministry

in Dallas Texas the same letter, and recieved the same response.

I also wrote Judge Glenn Carter of the Pottawatomie County Court House at 325 N. Broadway, Shawnee Oklahoma 74801, Phone# (405) 275-1296, telling him that i knew about the conspiracy, and asked him to please forward my letter to David Walters the Governor of Oklahoma.

I later recieved a response from Judge Carter stating that he did send my letter to Governor Walters.

But the Governor never answered my letter. He was having charges brought against him for money related ~~charges~~ crimes, so i guess he didn't care to answer my letter, or either he didn't care about Martin Luther King.

I was transferred to this state out of Okla. on Oct. 23, 1993 because i was an eyewitness to a murder that happened there on Aug. 17, 1993, and the Internal Affairs interviewed me there at the Oklahoma State Penitentiary on Aug. 24, 1993. I told them how 2 Guards allowed 2 inmates out of their cells to kill the man who lived in the cell next to mine there.

on 2 conditions:

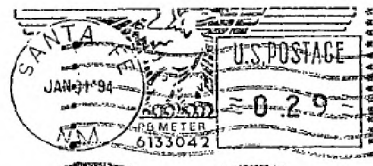
#1 - I am to be paid for the story, so

For information of receiving offices, persons mentioned in ELLIOTT's letter are: PAT URLEY, believed to be PAT EARLY; TOM LESTER PUGH, aka TOM PUGH, LESTER PUGH; JERRY JAMES, believed to be JERRY RAY JAMES, ex FBI Top Ten from 1960's; KIRKSEY NIX, JR., son of the now deceased Oklahoma Appeals Judge, currently serving time in Louisiana for murder; and AL MCDONALD, aka ALBERT MCDONALD, now deceased, also a well known criminal in Oklahoma.

ELLIOTT states in his letter he has attempted to tell his story and to sell his story to many prominent persons without success. His last paragraph set forth what is believed to be ELLIOTT's true motivation: to get out of jail and make a lot of money.

For the information of the Bureau, Memphis and Oklahoma City, U.S. Probation Officer GUNTHER HASELBAUER, Santa Fe, New Mexico, contacted the U.S. Bureau of Prisons at the request of SA [REDACTED] Albuquerque Division, on 3/18/94 and determined that there are currently three federal prisoners named PATRICK EARLY but none are located in federal facilities in the State of Arizona at this time.

JAMES EARL RAY has at least two known brothers. One is JOHN LARRY RAY, DOB [REDACTED] SSAN [REDACTED] FBI #368725A, who is the subject of a case entitled, "JOHN LARRY RAY; FARMERS BANK OF LIBERTY, LIBERTY, ILLINOIS, 5/30/80, BANK ROBBERY, OO: SPRINGFIELD, 91A-SI-8398."

The other brother is JERRY WILLIAM RAY, description unknown, living in Northbrook, Illinois as of 1980.

Albuquerque is placing its case in an RUC status since no further investigation remains in the Albuquerque Division but requests that Albuquerque be provided with information copies of any pertinent developments resulting from the enclosed information provided by FRANK DEAN ELLIOTT.

FRANK DEAN ELLIOTT, a white male born on [REDACTED] at Shawnee, Oklahoma, was interviewed at Penitentiary of New Mexico (PNM), Santa Fe, New Mexico where he is currently serving a life sentence for first degree murder as a transfer inmate from the State of Oklahoma. ELLIOTT, who is incarcerated under PNM Inmate No. 42954, advised that he was sentenced on his current charge at Shawnee, Oklahoma on April 1, 1991 and was transferred from the Oklahoma State Penitentiary (OSP) to PNM on October 23, 1993.

ELLIOTT was advised of the official identity of Special Agent (SA) [REDACTED] Federal Bureau of Investigation (FBI), and of the fact that he was being interviewed regarding any information he may have pertaining to the assassination of Reverend MARTIN LUTHER KING, Jr. since he indicated in his letter dated January 15, 1994 to DAN WADE, Assignment Editor, KOB Television, Broadcast Plaza, Albuquerque, New Mexico that he did have pertinent information regarding the assassination of Reverend KING. ELLIOTT was advised that this interview was being conducted at the request of the Oklahoma City Division of the FBI after ELLIOTT sent a copy of his foregoing letter to DAN WADE to the Oklahoma City Division of the FBI by cover letter dated January 20, 1994.

The interview with ELLIOTT commenced in the presence of SHANNON McREYNOLDS, PNM Classification Officer and Case Manager for Housing Unit 2A in the North Facility, the maximum security unit at PNM. McREYNOLDS was present for security reasons and ELLIOTT, who was acquainted with McREYNOLDS, agreed to his presence during the interview. ELLIOTT furnished the following information regarding the assassination of Reverend KING.

During the summer of 1993, ELLIOTT, while incarcerated at OSP, was housed in a cell next to another inmate named TOM LESTER PUGH, who was also serving time for murder. During their incarceration next to one another, the television program known as Home Box Office (HBO) featured a program about JAMES EARL RAY and the killing of MARTIN LUTHER KING, Jr. which prompted PUGH to talk to ELLIOTT. ELLIOTT thought that PUGH became sociable with him because PUGH, whom he claimed is homosexual, thought that he and ELLIOTT would later share a cell together. This did not happen, however.

In PUGH's conversations with ELLIOTT, PUGH told him that in either October or November, 1967 he (PUGH) and PAT EARLY or URLEY (phonetic spelling) robbed some businessmen at a poker game which was taking place at a cabin in the Memphis, Tennessee area. The local newspaper said that the robbery occurred at a fish fry but PUGH said it was at a poker game. During the robbery a Rolex watch was stolen from one of the victims. PUGH claimed to have later been interviewed about this robbery by the FBI while in custody in Dallas, Texas.

PUGH told ELLIOTT that during February 1968 he and EARLY went to a gun shop on the west side of the river in Memphis, Tennessee where they purchased a .30 caliber rifle and a 30.06 caliber rifle. According to PUGH, the purpose for purchasing these weapons was to use them to assassinate MARTIN LUTHER KING, Jr. when he visited Memphis, Tennessee later that year. PUGH was to plan the assassination and to act as the driver while EARLY was hired as the sharpshooter because of his previous training and shooting experience.

PUGH told him that the persons who contracted PUGH and EARLY to kill KING were unnamed members of the Retail Merchants Association of Memphis, Tennessee. Their reason for wanting KING killed was that local Afro-Americans in Memphis, Tennessee were boycotting local businesses of white merchants due to the civil rights movement in which KING was an instrumental figure.

The person who actually hired PUGH and EARLY to perform the assassination on behalf of the Retail Merchants Association was the business manager for the popular entertainer named JERRY LEE LEWIS. PUGH did not give the name of this individual but said he was the father of LEWIS' 13 year old cousin whom LEWIS married. PUGH was already acquainted with LEWIS' business manager since PUGH had previously committed unnamed crimes for this person.

PUGH told ELLIOTT that after this person hired PUGH and EARLY for the assassination and after they then purchased the two foregoing rifles, PUGH and EARLY thought about their assignment for a few days. PUGH realized that the assassination of KING would be a highly publicized event and that the FBI would be persistent in investigating the case so he told LEWIS' business manager that he and EARLY had changed their minds and would not be carrying out their assignment to assassinate KING.

According to PUGH, LEWIS' business manager then contacted a brother of JAMES EARL RAY, whose name was not given to ELLIOTT by PUGH. RAY's brother reportedly told LEWIS' business manager that his

brother, JAMES EARL RAY, would be willing to perform the assassination of KING since JAMES EARL RAY had just recently been released from a penitentiary.

PUGH told ELLIOTT that JAMES EARL RAY, after assassinating Reverend KING and his subsequent conviction, has been unable to tell authorities who was behind the assassination plot because the only contact RAY has had in this matter was his own brother. For this reason, RAY has given the authorities a phony name as his contact person to protect his brother.

SA [REDACTED] asked ELLIOTT if PUGH told him what happened to the two rifles that PUGH and EARLY purchased together to be used in the assassination of KING and he said PUGH did not tell him what happened to these two weapons. ELLIOTT said that he was told that after the killing of KING, JAMES EARL RAY was arrested in another country in possession of \$10,000 cash, a couple of passports and a 30.06 caliber rifle, but he did not know if this rifle was one of the two rifles previously purchased by PUGH.

ELLIOTT said that as he was being furnished this information by PUGH, ELLIOTT asked PUGH where he was when KING was assassinated and PUGH got angry and told ELLIOTT that he would not say anything which would implicate him in this matter. PUGH did not say whether he (PUGH) was in Memphis, Tennessee at the time that Reverend KING was assassinated. ELLIOTT felt that PUGH was being truthful when furnishing the foregoing information to ELLIOTT about the assassination of Reverend KING.

SA [REDACTED] asked ELLIOTT for his motive in sharing this information with authorities and he said he was mainly interested in seeing that justice was done. He said he would be willing to testify in a court of law, if necessary, and hoped that this new account of the assassination of Reverend KING would be pursued by one of the current news story programs such as "Hard Copy," "Current Affair" or "Inside Edition." He said he was not seeking personal financial gain but his only hope was that his mother would receive a small amount of money if his information proved accurate and was pursued by the media.

To his knowledge, PAT EARLY or URLEY is currently incarcerated in a federal prison in the State of Arizona.
