CAR HAD FOUR INDIVIDUAL RED PLASTIC FLOOR MATS, MUFFLER PAINTED SILVER WHEN PURCHASED BY GALT IN AUGUST SIXTYSEVEN.

MRS. MC MINN advised on 4/11/68, that her former husband, HENRY DAVID MC MINN, JR., appeared in Ruidoso Downs, NM, at approximately 2:30PM, 4/1/68, remained until 7:30PM, at which time he departed, indicating he was proceeding to Albuquerque, NM, thence to Phoenix, Arizona.

MRS. MC MINN advised that at the time of his appearance he was in possession of a White Station Wagon, possibly a 1962 or 1963 model and make not specifically known. She indicated he usually drives Chevrolets or Fords, therefore, this could have been one or the other. Also, the vehicle has Texas license plates, believed to have the prefix BYM 969 or 696.

MRS. MC MINN advised that her former husband was previously connected with the NAACP in Little Rock, Arkansas, in approximately 1965 or 1966, however, she is unaware of what capacity he was so connected. It was her impression he either distributed or sold literature to Negroes in that particular area.

In the event the enclosures tend to implicate this individual it is suggested that Memphis set out specific leads to assist in effecting his location.

MRS. MC MINN ADVISED THAT AT THE TIME OF HIS APPEARANCE HE WAS IN POSSESSION OF A WHITE STATION WAGON, POSSIBLY A SIXTYTWO OR SIXTYTHREE MODEL AND MAKE NOT SPECIFICALLY KNOWN. SHE INDICATED HE USUALLY DRIVES CHEVROLETS OR FORDS, THEREFORE, THIS COULD HAVE BEEN ONE OR THE OTHER. Search of premises believed occupied by Unsub who assassinated Dr. MARTIN LUTHER KING on 4/4/68, disclosed suitcase in which was located tee-shirt and undershorts bearing laundry mark on red tape with black lettering believed to be thermo-seal type, manufactured by Textile Marking Machine Co., Inc., Syracuse, N. Y. The tape is $\frac{1}{8}$ " wide and $1 \frac{1}{16}$ " long and bears letters and numbers 02B-6.

Experts at Textile Marking Machine Company advise type on this machine is unusual in that the first two characters are 15 point type and the last three characters are 18 point type, with the middle character, the letter B, probably being narrow rather than regular type. The usual machine carries 15 point type for the first three characters and 18 point type for the last two characters

Textile Marking Machine experts also stated this machine is defective in that it is producing a tape $1 \frac{1}{16}$ " long instead of $1 \frac{1}{8}$ " long and is not projecting the tape far enough resulting in cutting off a portion of the first letter. The code used in the Northeast part of the U. S. is as follows:

The first letter O stands for lot number; the first number 2 indicates the day of the week, two being Tuesday; the second letter indicates the first letter of the store name, this is the letter B; the last number is the bundle number, this is 6. Color coding of the tag may designate various things such as a different month or the identity of a store in a chain. Experts also state the use of this system on laundry items is unusual in that the system is normally used on garments being dry cleaned

The Bureau has instructed that all textile machines using this type tape be located and machines using this code be identified.
