AT 1:38 PM 4-8-68 Mrs. CHRISTINE WARD (protect identity), 2591 Browntown Road, N.W., Atlanta, 794-6186, called and advised as follows:

On 4-7-68 between 5:00 pm and 5:30 PM a male using a credit card number placed a call from Atlanta to ANDREW GAFFEY, room 825, Sheridan Peabody Motel, Memphis, Tenn. GAFFEY never answered the phone and the call was cancelled.

While WARD was attempting to complete the call she overheard the caller and someone near him talking. One of the men said "There isn't that many people who know". She then heard some reference to SCLC. WARD believes the call was placed from a phone with the first three digits of 523. She explained that when a credit card is used the calling number is not required and she believes the call was from a 523 number because she only receives calls from certain exchanges.

WARD stated that if it is felt to be important enough the ticket she prepared re the call can be located and the credit card number obtained.

WARD goes on duty at 3:30 pm today at the telephone company office on Ivy Street. If ~~xxx~~ it is desired to talk with her today she should be called at home prior to 2:05 pm.

MRS. GRADY LAFFIELD, TWO SIX SEVEN EIGHT, HILLCREST DR., MACON, GEORGIA ADVISED TODAY ON HIGHLY CONFIDENTIAL BASIS THAT LOGICAL SUSPECT IN CAPTIONED CASE IS HER HUSBAND'S NEPHEW, BOBBY DEAN MEDLIN, CHARLESTON, SOUTH CAROLINA, WHO HAS MADE NUMEROUS STATEMENTS IN PAST THAT HIS LIFE'S AMBITION WAS TO KILL DR. KING. SOME MONTHS AGO MEDLIN STATED HE HAD RIFLE WITH SCOPE SIMILAR TO RIFLE WHICH KILLED PRESIDENT KENNEDY AND HIS DAY WOULD COME, IMPLYING THAT HE WOULD HAVE OPPORTUNITY TO KILL DR. KING. HE SHOULD BE WELL-KNOWN TO PD, CHARLESTON, S. C. , FOR PREVIOUS DUI VIOLATIONS AND POSSIBLY OTHERS. SOURCE BELIEVED MEDLIN FAVORS SKETCH OF UNSUB WHICH APPEARED IN NEWSPAPER.

The copies furnished were Xeroxed from a Xerox in the possession of former SA WILSON. The handwriting on the document is reportedly that of suspect Dr. ALVIN EUGENE FRENCH.

For the information of the Laboratory, Dr. ALVIN EUGENE FRENCH has been travelling through the Southern states, passing true name checks and obtaining rental cars through the use of credit cards, some of which have been cancelled. He has a poor financial history with a number of Buffalo area financial institutions.

Dr. FRENCH reportedly served for several years in Africa as a Missionary, during which time he contracted brain fever. He has been under treatment as a mental patient

On 4/5/68, he called a girl friend at a Rochester, New York banking institution from Memphis, Tennessee, at which time he said he was going to Atlanta, Georgia, where he would stay at a Holiday Inn. At Atlanta, he said he planned to confer with some of Dr. MARTIN LUTHER KING's successors.

Former SA WILSON had verified Dr. FRENCH's presence in Atlanta on 4/8/68, at which time Dr. FRENCH indicated he planned to stay in Atlanta until 4/10/68.

Buffalo does not know whether any handwriting of unsub in captioned case available. If available, it should be compared with Dr. FRENCH's handwriting.

On 4/10/68, laundries as listed in telephone directory in Rome RA territory were telephonically contacted, without locating any using the "~~thermoseal~~" *THERMO SEAL* marking machine. It ~~was~~ determined that several used "ribbonrite" machines manufactured by Textile Marking Machine Company, Syracuse, N.Y., which stamps a mark on the garment and could also be used to stamp a tag.

Based on description of machine mentioned in retel, at this time it does not appear that the "ribbonrite" machine is identical with the "thermoseal" marking machine.

Search of premises believed occupied by Unsub who assassinated Dr. MARTIN LUTHER KING on 4/4/68, disclosed suitcase in which was located tee-shirt and undershorts bearing laundry mark on red tape with black lettering believed to be thermo-seal type, manufactured by Textile Marking Machine Co., Inc., Syracuse, N Y. The tape is  $\frac{1}{4}$ " wide and  $1 \frac{1}{16}$ " long and bears letters and numbers 02B-6.

Experts at Textile Marking Machine Company advise type on this machine is unusual in that the first two characters are 15 point type and the last three characters are 18 point type, with the middle character, the letter B, probably being narrow rather than regular type. The usual machine carries 15 point type for the first three characters and 18 point type for the last two characters.

Textile Marking Machine experts also stated this machine is defective in that it is producing a tape  $1 \frac{1}{16}$ " long instead of  $1 \frac{1}{8}$ " long and is not projecting the tape far enough resulting in cutting off a portion of the first letter. The code used in the Northeast part of the U. S. is as follows:

The first letter O stands for lot number; the first number 2 indicates the day of the week, two being Tuesday; the second letter indicates the first letter of the store name, this is the letter B; the last number is the bundle number, this is 6. Color coding of the tag may designate various things such as a different month or the identity of a store in a chain. Experts also state the use of this system on laundry items is unusual in that the system is normally used on garments being dry cleaned.

The Bureau has instructed that all textile machines using this type tape be located and machines using this code be identified.
