ERIC STARVO GALT
SUSPECT

The following is a summary of the information now available regarding ERIC STARVO GALT:

GALT, a 30 year old white male, first came to our attention during the course of a routine check of motels. It was determined that ERIC S. GALT, 2808 Highland Avenue, Birmingham, Alabama, registered at the Rebel Motel, 3466 Lamar Avenue, Memphis, Tennessee, on April 3, 1968, and departed the following day. We paid particular notice to GALT only because the registration card indicated he was driving a Mustang automobile having Alabama License 138993.

Mr. PETER CHERFUS, owner of the boarding house at 2808 Highland Avenue, Birmingham, advised that ERIC GALT was a tenant there from approximately September 1, 1967, through December 1, 1967. No registration card is available. According to CHERFUS, GALT was previously employed at Ingalls Boat Works, Pascagoula, Mississippi, but was unemployed and on "vacation" while in Birmingham. At the time he departed Birmingham GALT indicated he was going to Mobile to accept employment on a boat.

On August 30, 1967, in answer to a newspaper advertisement, GALT purchased a 1966 white Mustang hardtop, red interior, from Mr. WILLIAM D. FAIBLEY, 70140 Eighth Street South, Birmingham, Alabama. GALT came to the FAIBLEY residence on August 29, 1967, in a taxi and declined to drive the Mustang, stating he had no Alabama Drivers License, but claiming to have one from Louisiana. GALT met FAIBLEY on August 30, 1967, at the First National Bank, Birmingham, and paid GALT \$1995 in cash, mostly in denominations of \$20 and \$100.

GALT indicated to the members of the FAIBLEY family that he worked on a large line "out of" St. Louis. He stated he worked about 20 days on the barge and then would be off for 10 days. He indicated to the FAIBLEYS that he was married and that his wife lives "now" in Rocky Ridge, an area south of Homewood, Alabama. One of the FAIBLEYS recalls GALT stated he was divorced and that GALT's wife lived either on Rocky Ridge or Dolly Ridge Road "over the mountain" referring to that area south of Homewood, Alabama.

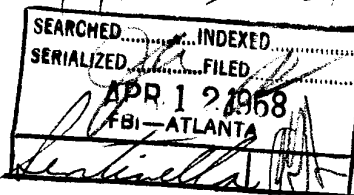

She stated that her company (Fashion & Whitfield) have ten different colors for their tabs and the only letter used on their tabs are the letter F (for Fashion) and " W " (for Whitfield) She made available two of these thermo tabs and stated that the first two numerals designated the lot number, the letter designated the route (" F " for over the counter Fashion and " W " for over the counter Whitfield) and the last two figures the number of bundles in the lot. She further stated that when the laundry is picked up at the home the letters " F & W " are replaced with figures which designate the route the truck driver will deliver the laundry

TX It should be noted that neither Fashion or Whitfield keep a name list of customers other than the laundry pickups which are billed each month. A review of that file failed to reflect the name LOWMEYER or LOWMYER
