The following is a summary of the information now available regarding MRIC STARYO GALL:

GALF, a 30 year old white male, first came to our attention during the source of a routine check of notels. It was determined that ERIC S. GALF, 2606 Highland Avenue, Birmingham, Alabama, registered at the Robel Motel, 3466 Lasar Avenue, Moughin, Tennessee, on April 3, 1968, and departed the following day. We mad particular notice to GALF only because the registration card indicated he was driving a Mostang Automobile having Alabama Liceage 138993.

Mr. PETER CHERRES, owner of the boarding house at 3606 Highland Avenue, Birmingham, advised that ERIC GALT was a tenant there from approximately September 1, 1967, through December 1, 1967. He registration card is available. According to CHERRES, GALT was previously suplayed at Ingalla Beat Verks, Pascagoula, Mississippi, but was unemployed and on "vecation" while in Birmingham. At the time he departed Birmingham GALT indicated he was going to Mabile to accept suplayment on a beat.

On August 30, 1967, is answer to a nonspaper advertisement, GALF purchased a 1966 white Mustang hardtep, red interior, from Mr. VILLIAM D. MAISLEY, 70140 Righth Street South, Birmingham, Alabama. GALF came to the MAISLEY residence on August 29, 1967, in a taxi and declined to drive the Mustang, stating he had no Alabama Drivers License, but claiming to have one from Louisiana. GALF not PAISLEY on August 30, 1967, at the First Maissal Bank, Birmingham, and paid GALF \$1996 in each, mostly in denominations of \$30 and \$100.


