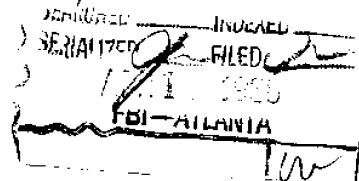

On 4/13/68, WILSON L. CLEVELAND, JR., Army Serial Number [REDACTED] assigned to Co. E, Second Bn., First Brig, USATO, Fort Benning, Ga., advised that prior to entering in U. S. Army, he was employed by GAC, Birmingham, Ala. and that during this employment, he resided at the Berkley (phonetic) Apts., which he believed to be located on Highland Ave., Birmingham from approximately 9/28/67 for an approximate two week period. He stated that he had a room on the second floor and that during the time he was at this apartment building, he never became acquainted with any of the other tenants except one man whose name he could not furnish. He stated that this man was a drug salesman staying on the first floor of the apartments and was believed to be employed by Bristol-Myers Co. and that he met this man for a short period of time one evening while they both were watching a football game in the television room located in the lobby.

He stated after moving from the Berkley Apts., he moved to a rooming house in the same section of town where he stayed for about two weeks. He does not believe that this rooming house was located on Highland Ave. He stated that he has never met anyone using the surname GALT nor during the period of time while residing in the vicinity of Highland Ave. did he meet anyone driving a white Mustang. He stated that he could furnish no information concerning the tenants at the Berkley Apts. or at the other boarding house.

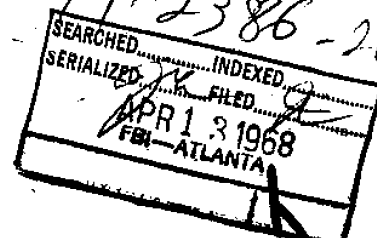
