It should be noted that the 11:00 p.m. news reflected that a cab driver had indicated he transported a suspect, identified by artist's conception as GALT, to the vicinity of Peachtree and 14th Street.

City Directories reflect that 61 13th Street is a 16 unit apartment building.

The source knew this chiropractor one or two years ago in the area of Peachtree and 10th - 14th Streets. The unemployed chiropractor used to hang out in the liquor stores in that area. Source could not remember name.

State records for licenses for present and former chiropractors should be checked under suspect's name and aliases in this case.

The following investigation was conducted by  
SA KENNETH R. HEINEMAN at Atlanta, Georgia:

Mr. BILL PHILLIPS, night supervisor, Atlanta Transit, Incorporated, 125 Pine Street, NE, Atlanta, Georgia, advised that his company runs five separate bus routes past the intersection of Memorial Drive and Connally Street, SE. Each of these routes runs two or three buses past that intersection between 8:30 a.m. and 9:15 a.m., and each bus would have a different operator. The names of the operators and the times at which they would arrive at that intersection can only be obtained from Mr. OWENS, the division superintendent.

On April 12, 1968, Mr. JULIAN A. OWENS, division superintendent, Atlanta Transit, Incorporated, 125 Pine Street, NE, Atlanta, Georgia, furnished the following list of bus operators, who would be the only operators to pass the intersection of Memorial Drive and Connally Street, SE between 8:30 a.m. and 9:15 a.m. on Friday, April 5, 1968. Each of the following bus operators was interviewed but was unable to recall anyone getting on his bus on April 5, 1968 fitting the description of ERIC STARVO GALT:

On April 16, 1968, Mr. K.C. LOWE, who drives a cab for Bus Station Cab Company, 200 Williams Street, NW, Atlanta, Georgia, advised that 200 Williams Street, NW is not a dispatch center but merely the corner of William Street and Cain Street where there is a call box. There are about 20 drivers who work for Bus Station Cab Company, all of whom own their own cabs, and these cabs are merely cars for hire and not metered cabs. There is no dispatch system for these cabs and they operate only from people hailing them from the street. Therefore, they keep no trip sheets and have no record whatsoever of what driver might be in a certain area at a certain time of day.

Mr. LOWE stated that he did not recall picking up anyone in the 14th Street and Peachtree Street area on April 5, 1968 and that he would question all the other drivers concerning a pickup in that area or from the bus station to that area on that date. Mr. LOWE added that should any positive information be developed, he would immediately forward it to the FBI.

On April 16, 1968, Mr. JAMES WYATT, owner, Gate City Taxi Company, 52 Bell Street, NE, Atlanta, Georgia, advised that his trip sheets reflect nothing concerning a call to or from the 14th and Peachtree Streets area. He said that his cab company services only the Negro area of town and never has a trip into the white section. He stated that his drivers never go to the airport or to the bus station on calls unless it is someone that they know personally. They never answer calls from white people and seldom ever allow their cab to be hailed by a white person.

Mr. WYATT said that he is certain that none of his cabs would have taken anyone from or to the 14th and Peachtree area.

On the same date, Mr. BILL DALLIS, owner, Bill's Cab Company, 457 Cain Street, NE, Atlanta, Georgia, advised that the drivers for his company work only in the Negro area and would not pickup anyone on a call at the bus station or airport unless the call was from someone the driver knew personally. His company maintains no trip sheets and they do not answer calls out at the 14th and Peachtree Street area unless it is someone they know. They do not deliver or pickup in the white areas of town and they do not operate on the hailing system since each call comes only from the dispatcher.

Mr. DALLIS stated that he is certain that none of his drivers could have taken anyone from or to 14th and Peachtree areas on April 5, 1968.

On the same date, Mr. WELCOME HARRIS, Ace Cab Service, 26 Bell Street, NE, Atlanta, Georgia, advised that his trip sheets reflect no calls to or from the 14th and Peachtree Street areas on April 5, 1968.

Mr. HARRIS stated that his drivers would not pickup anyone on a call from the bus station or airport unless it was someone the driver knows personally, as they operate only within the Negro section of town. They do not deliver or pickup around the 14th and Peachtree area and they service only the Negro community. He is certain that none of his drivers could have picked up anyone from or delivered anyone to 14th and Peachtree Street areas on April 5, 1968.

On the same date, Mr. HERSCHEL MINIFIELD, a driver for Ace Cab Service, 26 Bell Street, NE, Atlanta, Georgia, advised that he recalls on Monday, April 8, 1968, his cab was hailed at Forsyth and Hunter Streets by a white man answering the description of ERIC STARVO GALT. He recalls that this man got into his cab and immediately began questioning him about the assassination of MARTIN LUTHER KING. This man requested that he be taken to the Ebenezer Church where the funeral for Dr. KING

was to be held the following day and that he be taken by Dr. KING's home. MINIFIELD recalls that as he complied with the man's wishes, when they arrived at Dr. KING's home, the man seemed to be making some notes in the back seat. After taking this man past the church and the home, MINIFIELD dropped him off across the street from the Ace Cab Service, where this man walked up the sidewalk and joined several white man talking under the viaduct over Bell Street. MINIFIELD can recall nothing more about his conversation with this man or about the man's appearance, except that the man was a white male, about 35 years old, had dark hair and a ruddy complexion and was neatly dressed.

When shown a photograph of the artist's conception of ERIC STARVO GALT, MINIFIELD stated that this man looked extremely similar to the man he picked up and drove around on April 8, 1968.

At 1:32 PM, 4/17/68, Supv. WILLIAM MARTINDALE, Bureau, called and referred to UPI release at 4:15 AM, 4/17, to the effect that two cab drivers in Atlanta had seen GALT and that one of them positively identified him as having been picked up in the hippie district of Atlanta.

I advised Mr. MARTINDALE these press reports were result of our checking of cabs in the area of 14th St. and Peachtree, that one of the individuals interviewed stated that a hippie passenger he picked up resembled the look alike of the unknown subject, but there was no indication that this had any merit.

Mr. MARTINDALE requested these two interviews be covered in our summary teletype for the day. I assured him this would be done.

On 4/17/68, Captain STEVE POLK, GBI, assigned as Personal Aide to Georgia Governor LESTER MADDOX at the Georgia State Capitol, Atlanta, requested the writer talk with Miss MARY BASLEY, Receptionist in the Office of Governor MADDOX at the Capitol Building, Atlanta, regarding the following:

Miss BASLEY stated that on 4/11/68, she observed several reporters examining the guest book in the reception room of the Governor's Office. She explained that the guest book is normally used by individuals visiting the Governor's Office on Open House Day each Wednesday, which period is referred to as "Little Peoples Day With The Governor".

Miss BASLEY saw JIM WINN, a reporter for the Savannah and Augusta, Georgia, newspapers, turn to the page in the guest book dated 4/3/68, and sign "ERIC GALT, 903 Highland Avenue, Birmingham, Alabama, Jefferson Co., Alabama." TED SIMMONS of the Associated Press and DUANE RINE of the "Atlanta Constitution" were also observed by Miss BASLEY examining the guest book at the same time. She stated these three reporters actually intended to play a joke on another reporter normally assigned to the State Capitol, just for the purpose of seeing his reaction when he realized that ERIC GALT's name appeared in the Governor's guest book.

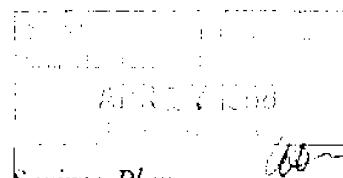

On 4/17/68, Mrs. PAUL KELLY, 2239 Tanglewood, Decatur, Ga., advised that on Monday, 4/15/68, while shopping in King's Hardware Store, Belvedere Shopping District, she observed a man dressed in Marine Corps dress blue trousers in what appeared to be a Marine Corps fatigue khaki jacket, a cap and unshined shoes. She believed the sleeve of the khaki jacket bore two chevrons indicating to her that he would be a Corporal. She became aware of his presence since she knew it was very unusual for a man to wear dress blue trousers and khaki jacket. Further, that his shoes were not shined and all Marines are very conscientious about shining their shoes. She stated this man bought a .22 rifle, a box of Winchester ammunition and six transistor batteries. She stated that she had thought it over and became highly suspicious stating that if he was a Marine he would certainly have had his "fill of shooting" and if he wanted some rifle practice, he didn't have to buy shells but could get them in the Marine Corps. She described him as a white male, 6' to 6'2", 23-28 years of age, brown hair, blue-green eyes, with a slender build.

She went on to say that she either saw an artist's conception of Dr. KING's killer or read in the paper where someone who apparently had seen the killer abandoning an automobile described him as very good looking. She said that was the determining factor in her call to the FBI since this man described above was, in her opinion, the most handsome man she had ever seen and because of this she felt he should be considered a suspect.

It was pointed out to Mrs. KELLY that Dr. KING was murdered 4/4/68 whereas this individual did not purchase the .22 rifle until eleven days later. She stated she hadn't thought of it that way.

NEWS RELEASE

Attorney General Ramsey Clark, announced today that Eric Starvo Galt is being sought by the FBI as a fugitive on a Federal charge arising from the fatal shooting of the Reverend Dr. Martin Luther King, Jr., in Memphis, Tennessee, on April 4, 1968.

Director J. Edgar Hoover stated that a Federal complaint was filed by the FBI in Birmingham, Alabama, today charging Galt with conspiring to violate the civil rights of Dr. King in violation of Title 18, Section 241 of the United States Code.

The FBI complaint charges that "On or about March 29, 1968, at Birmingham, Alabama, Eric Starvo Galt and an individual whom he alleged to be his brother, entered into a conspiracy which continued until on or about April 5, 1968, to injure, oppress, threaten or intimidate Martin Luther King, Jr., in the free exercise or enjoyment of a right secured to

him by the Constitution or laws of the United States, namely, the right to freely travel from state to state. In furtherance of this conspiracy, Eric Starvo Galt did, on or about March 30, 1968, purchase a rifle in Birmingham, Alabama."

According to Mr. Hoover, a 30.06 rifle equipped with a telescopic sight was found near a rooming house on South Main Street in Memphis immediately after the fatal shooting of Dr. King occurred. The rooming house overlooked the Lorraine Hotel and Motel where Dr. King was staying.

Mr. Hoover said that FBI Agents determined that the 30.06 rifle had been purchased from a gun dealer in Birmingham, Alabama, on March 30, 1968. The telescopic sight was also purchased from this dealer.

The FBI Director stated that Galt, who has used the names of John Willard and Harvey Lowmeyer in the past, is the owner of a 1966 white Mustang bearing Alabama license plates, which was located abandoned in Atlanta, Georgia, on April 11, 1968. Investigation disclosed that Galt purchased this car from a private citizen in Birmingham, on August 30, 1967. The Mustang's odometer showed that it had been driven more than 19,000 miles between late August, 1967 and early April, 1968.

According to Mr. Hoover, Galt's travels in the Mustang include trips to Los Angeles, California, New Orleans, Louisiana, Birmingham, Alabama, and Mexico, as well as Memphis, Tennessee and Atlanta, Georgia. Galt was reported to have been in Memphis on April 3 and 4, 1968, and to have departed from there for Atlanta.

Intensive investigation by the FBI has disclosed that Galt has claimed to have been employed as a cook on Mississippi river vessels and as a merchant seaman. He is said to be an avid dancer and took dancing lessons in New Orleans in 1964 or 1965, in Birmingham during September and October, 1967, and in Long Beach, California, from December, 1967 to February, 1968.

Galt left Los Angeles on December 15, 1967, and drove his white Mustang to New Orleans, where he claimed he contacted either an engineering or a contracting firm. He left New Orleans on December 19, and arrived back in Los Angeles on December 21, 1967.

While in Los Angeles area early this year, Galt took a course at a school of bartending and was graduated on March 2, 1968.

The fugitive is described as a white male. He is approximately 5' 8" to 5' 11" tall and weighs between 160 and 175 pounds. He is said to be a neat dresser and has a medium build.

Galt has brown hair which he wears in a "brush" cut. He reportedly has blue eyes, his nose is straight and narrow. His teeth are straight and clean and he has given his date of birth as .

The fugitive is said to have a nervous habit of occasionally pulling at an earlobe with his hand. His left ear protrudes farther from his head than his right ear.

According to Mr. Hoover, persons who have met Galt describe him as a "loner" and state his language and diction have a "rural" quality and suggest that he probably does not have a high degree of education. He is said to drink alcoholic beverages and has a preference for vodka and beer. He is a fan of western and country music.

Galt should be considered armed and dangerous. Any information concerning him should be furnished immediately to the nearest FBI office.

On 4/17/68 MRS. AMY JOHNSON, nee BOOKER, telephoned at the Atlanta Office and declined to furnish her home address, telephone number, or place of employment. She advised she resides in Marietta, Ga.

She reported as follows:

On 4/15/68 she and a companion whom she declined to identify were in the Broadview Plaza, Piedmont Road, between 5 and 6 p.m. when she observed a dark green or black two-door automobile, make not known, but which appeared to be of the "sporty" type. She advised that this car bore Alabama tag, number not known. She stated three men were in this vehicle but she did not observe what they were doing. She stated this vehicle was parked in one of the lanes in front of Walgreens Drugstore about a quarter of the total length of the lane away from the drugstore.

She stated she did not pay too much attention to this vehicle or the occupants on 4/15/68 but stated that she and her companion returned to the same place sometime between 5 and 6 p.m. 4/16/68 and observed that the same car was parked in about the same place. Three occupants were in the vehicle and she observed that the individual who was in the passenger seat in the front left the car and went into the drugstore. She advised that this individual was a white male, age approximately 30, 6' tall, 160-165 lbs., neat appearance, wearing glasses, and a sport shirt and slacks. She stated that the shirt was grey or light blue. She advised she decided to go into the drugstore and observed the passenger in the drugstore but she did not observe him purchase anything but did see him meet another individual whose description she could not recall. She advised that the driver of the vehicle and the individual who was in the back seat then went to Kresge Department Store and she described the driver of the vehicle as being white male, approximately 30 years of age, 5'6" or 7" tall, 175 lbs., light hair, wearing slacks and sports shirt. She stated

that the only description she has of the individual in the rear seat is that he was a white male, having dark hair.

She reported that the individual who had been sitting in the right front seat after leaving the drugstore and the individual whom he had met in the drugstore went to Kresges where he met the other two individuals inside the store and after being in there a short time the three returned to the car. She advised that the individual who had been in the right front seat then returned to Kresges and fumbled with the paper stand outside the store then went into the record shop and the individual in the back seat then went to the record shop. She advised she does not know what then transpired.

She advised that the individual who had been sitting in the right front seat appeared to resemble the artist's conception of ERIC GALT, which he had observed in a newspaper.

A representative of the following cab companies reviewed their trip sheets for the period of April 5, 1968 for any fare which originated in the Fourteenth and Peachtree Street area traveling to various parts of the city with particular emphasis placed on trips traveling to the airport, bus terminal and Ponce de Leon Place and Highland Terrace.

Only two such fares were noted and both of these were handed by the Atlanta Lincoln Cab Company with the results set forth following that company's entry.

1. Mr. ABRAM SANDLER, Co-owner, East Atlanta Cab Company, 534 Flat Shoals Avenue, Southeast.

2. Mr. MACESO MITCHELL, Operator, Gulf Cab Company, 136 Flat Shoals Avenue, Southeast.

3. Mr. JOHN SANKFIELD, Town Cab For Hire, 60 Flat Shoals Avenue, Southeast. SANKFIELD advised that he only operates one vehicle and this vehicle is being repaired presently and has not been in operation for approximately four weeks.

4. Mr. R. E. CORNE, Bookkeeper, Atlanta Lincoln Cab Company, 55 Milton Avenue, Southeast. CORNE noted two fares, the first of which originated at 1230 Peachtree Street, Northeast, terminating at the Greyhound Bus Terminal. This cab was driven by PAUL DOTTERER, a driver for the Veteran Cab Company. DOTTERER was shown a composite photograph of the suspect in this matter and stated that he did not believe

On April 17, 1968, Mr. J. B. HURLAY, Assistant Station Superintendent, Post Office Substation "F", was contacted regarding the possibility that an individual using the name GALT might possibly be using a General Delivery address.

HURLAY advised that approximately a dozen individuals were using the General Delivery services and none were listed under the name GALT.

An inquiry was then made concerning the most recent dates on applications where General Delivery services were made. The only recent application was made on April 1, 1968, being an individual using the name FLOYD E. BOUGHER.

Mrs. M. P. HICKS, Clerk, Substation "F", was exhibited a composite photograph of the suspect in this case and she stated that BOUGHER and the individual portrayed in this photograph were positively not identical.

HURLAY also advised that his substation covers the geographical area of Northeast Atlanta which is bounded on the South by Ponce de Leon Avenue, on the East by Briarcliff Road, on the North by the Seaboard Airline Railroad and on the West by the Southern Railroad System.
