PRISON DEPARTMENT RECORDS SHOW HE IS WHITE MALE, BORN [REDACTED] AT HARNETT COUNTY, N. C., FIVE FEET NINE INCHES, ONE HUNDRED SEVENTY-FIVE POUNDS, FAIR COMPLEXION, BROWN EYES, BLACK HAIR, OCCUPATION WELDER AND USED CAR SALESMAN, HOME ADDRESS SANFORD, N. C.

WILLIAMS EX-WIFE, CAROLYN RUTH WILLIAMS, INTERVIEWED AT SANFORD, N. C., TODAY AND ADVISED SHE DIVORCED HIM WHILE HE WAS SERVING PRISON SENTENCE AND HAS NOT SEEN HIM SINCE TIME OF SENTENCE. SHE STATED WILLIAMS WAS NOT A MEMBER OF THE KLAN BUT ATTENDED PUBLIC RALLIES OF KLAN. WHEN HE GOT DRUNK HE OFTEN TALKED ABOUT MARTIN LUTHER KING AND SEVEN TIMES SAID HE WOULD LIKE TO KILL THE SOB. WILLIAM DAVID PAISLEY, SR., SAID THERE IS A RESEMBLANCE BETWEEN THE MAN IN THE PHOTO (GALT) AND THE ERIC S. GALT WHO

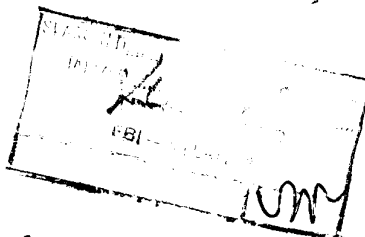
