At the request of COP Ernest Sanders, Marietta PD, Marietta, Ga., MRS. JAMES G. WILCOX, 504 Chestnut Hill Rd., Marietta, Ga., phone 427-1531, was interviewed at the PD regarding an incident that had occurred to her in possible connection with this case.

MRS. WILCOX advised that she is a member of the Board of Education of Marietta, Ga., and on 4/10/68 had attended an Educational Conference at Atlanta, Ga., with MR. LLOYD COX, Superintendant of Schools, Marietta, Ga., and MISS EDNA LEE, Counselor, Marietta, High School, Marietta, Ga. Enroute back to Marietta all three stopped at the Howard Johnson Restaurant located at Northside Drive and U.S. 41, in Atlanta, Ga. As they entered the dining area of the restaurant MRS. WILCOX observed a man seated alone 2 to three booths away from where she, COX and LEE sat. Mrs. Wilcox stated that the time was about 10:30 PM.

While MRS. WILCOX and the others were dining the man previously observed in the booth close by came up to her table and in the presence of COX and LEE said directly to MRS. WILCOX "I hope you don't think I'm rude, but could I have my cup of coffee with you?" MRS. WILCOX thought at first the man might have attended the same conference as she had and might be known by COX or LEE. As soon as it was obvious that they did not know him and noone invited him to sit down the man walked away. MRS. WILCOX said she was completely surprised by the request and observed the man go back to his booth and he appeared to be working on some papers in front of him. At another time shortly thereafter he was observed walking up and down nervously at the rear section of the dining room.

MRS. WILCOX stated that she did not recall the incident until she saw the picture of ERIC STARVO GALT in the morning newspaper of 4-18-68, at which time it struck her that this was the man who had approached her and the others at the Howard Johnson Restaurant as set out above. MRS. WILCOX described this man as W/M, 35-40, 6', 170-175, face shaped same as newspaper and hair the same, hair light brown to sandy, local accent, good teeth, wearing a brown suit, well dressed, white shirt, tie not recalled.

MRS. WILCOX stated that she talked today to MR. COX regarding her belief that the man mentioned above is GALT but COX who also observed the man disagreed with her. COX said he had observed GALT's picture in the newspaper and he is not identical with the person mentioned above.

On 4/18/68 at 8:20 p.m. Mr. JOHN DORE, who gave his address as 306 Robinson Street, Hapeville, Georgia, advised that he saw a man fitting the description of the first drawing that was in the paper enter the Johnson Grocery Store on Old 41 Highway. He saw this man enter the grocery store on 4/5/68 at about 4:45 p.m. He stated that this man was trying to cash a large check around \$400 or \$500 and exhibited a drivers license with the name JOHN WILLARD appearing on it. He noted that the man did not have the same appearance as the picture on the drivers license.

DORE described the man as weighing 160 - 170 lbs., having a long straight nose, wearing a mustache and looked like Clark Gable. He also pointed out the man had a nervous habit of pulling on his ear.

He stated that JOHNSON appeared to know the man but that the man looked considerably different than his picture on the drivers license. When he asked JOHNSON about this, JOHNSON said the man lives up the road about two and a half blocks. DOORE stated that the unidentified man was driving a blue Mustang with Alabama license plates, and on the seat next to the man was an overnight bag which appeared to be rather dirty.

She stated this was the man that looked like the picture in yesterday's paper. She noted that the men said they were from Illinois and the first man, whom she described, was helping tend bar in the package store next to the Star Motel.

Mrs. WHITEHEAD could not furnish a description of the second man but remembered that he look very similar to the original drawing that appeared in the paper.

Rev. HEATH looked up and observed cab driver for Courtesy Cab Company Number 71. He stated this cab driver looks like the artist's conception of the murderer of MARTIN LUTHER KING. Rev. HEATH was shown photographs of ERIC STARVO GALT and advised the cab driver resembled these photographs but not as much as artist's conception appearing in the newspaper. He advised he had observed this cab driver on Wednesday evening at 8:30 P.M. waiting with other cab drivers for fares at the Atlanta Airport.

On 4/18/68, ALICE WILSON, Courtesy Cab Company, advised cab driver of Courtesy Cab Number 71 on Wednesday evening was cab driver known to her as AARON. She described AARON as being 6' tall, slender build and bald headed.

On 4/19/68, ELVIN KELSIE AARON, 1872 Stanton Road, Southwest, Atlanta, Ga., was located employed at the J. A. Jones Construction Company at the intersection of Houston and Piedmont, Atlanta, Ga. AARON was determined not to be identical to photograph of ERIC STARVO GALT.

It was noted AARON is a white male; born [redacted], Newton County Ga.; 5'11" tall; 155 lbs.; blue eyes; receding hairline, balding; ruddy complexion; has tattoo of naked woman on right forearm; front teeth, upper and lower, missing, other teeth noticeably in bad condition.

Mrs. WOLF is a professional artist, by making some minor changes in the photo of GALT as appeared in the newspaper she was able to make the photo look like the man they saw. Mr. WOLF called the police department and reported the incident about 4:00 am.

WOLF stated he and his wife would help in any way possible, including a drawing of the man they saw, but due to their position in the community their identity would have to be kept confidential.

OLDEN ALLEN, Home Address 425 Arnold Street, NE., Apartment 1, Atlanta, Georgia, advised that he works as a helper handling the Jet Magazine out of the Crown Service Station at 331 Auburn Avenue, which is located directly across the street from the SCLC Headquarters.

ALLEN stated that he a totally disabled veteran and he only works on a limited part-time basis. ALLEN said that the day before Rev. MARTIN LUTHER KING, JR., was killed in Memphis, Tennessee, he recalls seeing two men at the Crown filling station.

ALLEN said that he fixes the time of having seen these two individuals by the fact that he thought about it when he heard about Dr. KING's death. He knows that it was the Wednesday prior to the shooting because in handling Jet Magazines, he makes pick ups at the Crown Station on Tuesday and he can never carry all of the magazines to make deliveries, so he leaves a portion of them at the station. He recalls that the day he saw the two individuals, he had returned to the station for the purpose of picking up parts of a load of magazines that he had left there on the previous Tuesday. ALLEN said that he would fix the time that these individuals were in the Crown filling station between 10:30 or 10:40 a.m. and 12 or 12:30 p.m., and that the length of time would be at least 1½ hours and possibly longer. He said that they were not in the station when he arrived at 10:30 a.m. but that they came in about ten minutes after he came it. He said that he knows he was there approximately 1½ hours and they were still there when he left.

ALLEN said that he can not recall the make, model or color or any other information concerning the automobile that these individuals were driving. He said that he does recall that the manager of the station,

Mr. BRYANT, asked him to go and ask the men what they wanted since they were parked in front of a pump. He said when he went and asked them what they wanted, they replied that they had to use the phone. He said that the driver of the automobile moved the car from in front of the pump and drove it straight toward the building, which would place the rear of the car toward SCLC Headquarters.

He said the driver of the automobile got out and went to a phone booth where he made a call. He recalls the driver stayed in the phone booth apparently in conversation for 25 or 30 minutes. He said he does not know which one of the three phone booths the driver used.

ALLEN said that he would describe the driver as a white male, about 35 or 36, 5' 10", but that he could furnish no other details concerning his description. He said that the second man, who remained in the car appeared to be about the same age, but that he did not notice him and subsequently could not give any additional information.

ALLEN said that during the time that these two men were in the station someone, he cannot recall who, remarked "There goes Dr. KING". He said that he has a faint recollection that one of the two white men made the remark but since there were others in the station, he is not sure who made the remark.

ALLEN said that the individuals in the station at the time that he can recall are as follows:

1. A man known to him only as HAMP, who is a retired Negro male about 60 years of age, who hangs around the station quite a bit of the time.

ALONZO BRYANT, Manager, Crown Service Station, corner of Hilliard and Auburn Avenues, NE, directly across from SCLC Headquarters, advised that he recalls the incident in the recent past when two white men came into the station and stayed for quite a long period of time and there was some comment concerning these individuals, because there are very few white customers who come to the station.

Mr. BRYANT said that he does recall that these time of day these people came in was sometime after 10:30 a.m., because OLDEN ALLEN, who works part time for him was at the station and he does not come to work until 10:30 a.m. Mr. BRYANT said that did notice that one of these individuals got out of the car and used the public phone booth. He said that he vaguely recalls that the individual was 5' 8" or 5' 10", 190 pounds, and he thinks he had black hair. He recalls that the individual was well dressed but could recall only that he had on a suit and tie, but could give no color of either.

He said that he recalls that there was some discussion about these two men among some people in the station, but that he could recall whether this incident happened before or after the death of Dr. MARTIN LUTHER KING, JR.

He says that he vaguely recalls that the man who went to the phone booth, also received a call at one of the phone booths.

He says he also has some vague recollections that while these two individuals were at the station that someone made the remark to the effect that "There goes Dr. KING".

of these individuals is very poor because he has a rather busy station and he would not have much time to make much of an observation of customers. He said he can recall one thing about the two men, they did not make a purchase.

Mr. BRYANT said that he recalls that ROBERT EVANS, a Negro male, approximately 60 years of age, who works as a brick layer's helper, was in the station at the time and he feels that EVANS could give a rather complete information about this incident, because EVANS and others in the area sit and play checkers at a spot adjacent to where these individuals parked their car.

Dear Sir:

The following information was given today to the New York branch of the FBI via telephone, but I cannot know whether or not they acted upon it.

It is urgently requested that you investigate a 34-year old male, by name of:

CLAUDE ALBERT (AL) CASS,

living and working in Atlanta, Ga. He has been employed as a marshal of the City-County Civil Court in Atlanta. Descriptions tally -- when they agree -- down to the "hot rot grin," as one Negro schoolboy expressed it. You realize the above-named project was, in all likelihood, conducted by a person or persons with 1) access to abandoned, impounded motor vehicles (the probable source of the white Mustang, registered in Galt's name), and 2) knowledge and possession of short-wave equipment similar to that of the police force.

In the deviousness of Southern politics, an out-of-the-area disposal of an annoying citizen through the instrumentality of a "clean" (i.e., no record) sub-sub-lieutenant is not altogether unheard of. Do racial Maddogs become moderates overnight -- say, upon election to office -- or do their true feelings simply go underground to be capped by a lid of expediency? Even in the South, it is now neither "nice" nor "intellectual" to be rabidly segregationist, an overall attitude which forces politicians to a posture of uneasy fence-sitting.

It is scarcely in my province to instruct you on the conduct of your business -- but a word of caution might be in order regarding the routine fingerprint and whereabouts check you will no doubt make: wisdom dictates that you not contact, directly or initially, the Chief Marshal in the Atlanta-Fulton County office.

In the interests of apprehending the killer and helping put an end to the rioting in our cities, I am

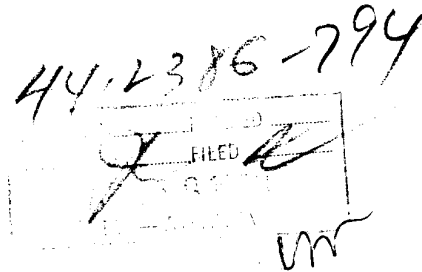

It was made at an Alcoholic Clinic in Atlanta, Gorgia. It showed this man in jail - also before the judge (being released) also showed him crossing street and entering a bar with another man (looked like other one had blond hair - about 1/2 head shorter than the man I am mentioning. Also showed them coming out of bar & drinking from bottle. When Judge called his name he mentioned the name Rudolph 3 or 4 times. I could not quite get the last name - sounded like Helon or Hallon. Judge was quite plump. Do not know who he was either. Man is classified as an alcoholic. I could be very wrong but I could not help noticing the resemblance to description of dress, heighth etc. that has been in our paper.

Please do not mention this letter to anyone as we are already living in fear all over America of the violence going on.

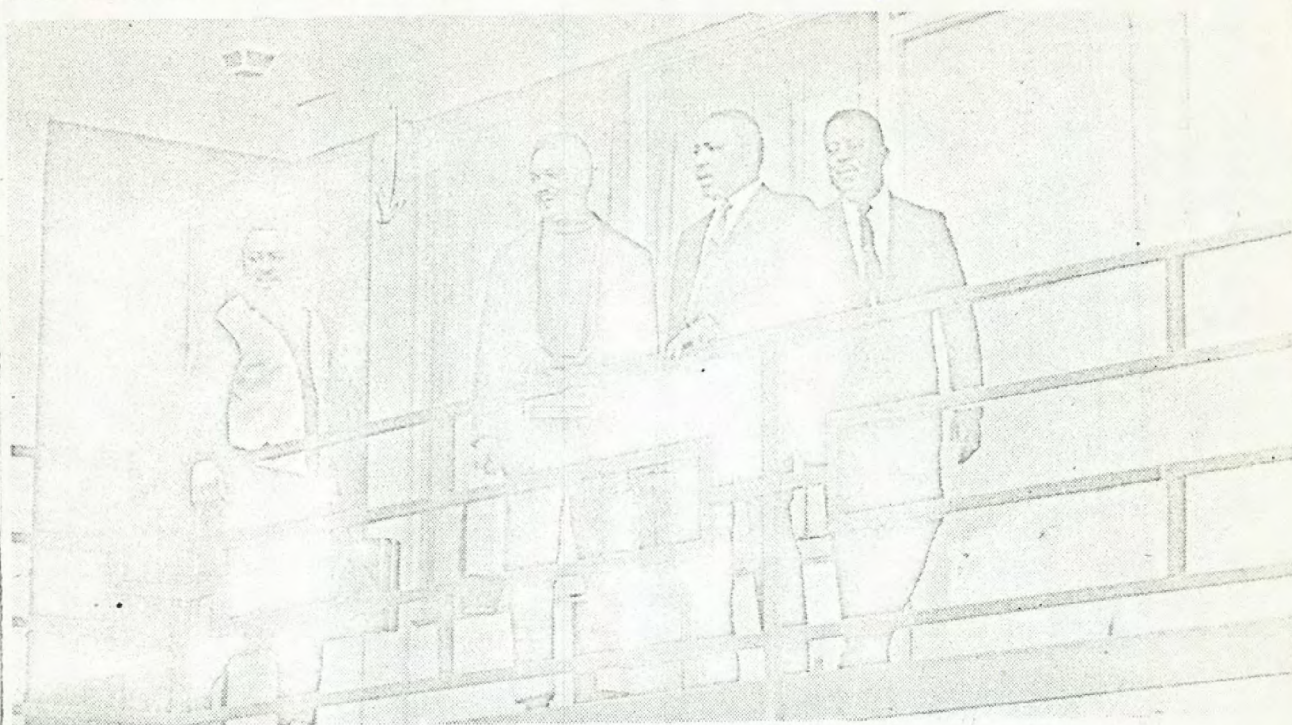

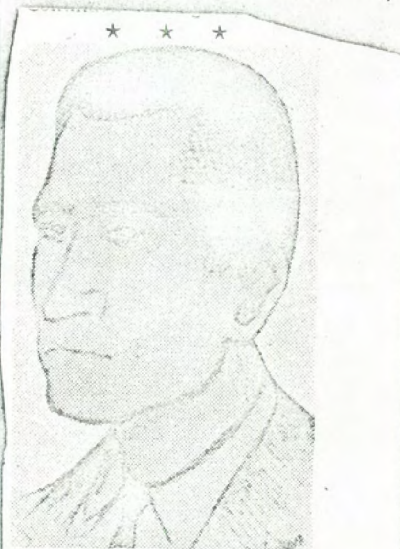

Result of examination:

It was concluded that the "Eric S. Galt" and the "Eric Galt" signatures on Q216 through Q221, Q223 and Q224 were prepared by the writer of the signatures in this name appearing on specimens previously received. The signatures on Q222 are too distorted for identification with these previous signatures but similarities were noted.

Because of the lack of comparable writings and variations, it could not be determined whether the other writings appearing on Q216 through Q224 were prepared by the writer of the available writings which are attributable to Galt, however, similarities were noted between the payee names on money orders and the "Galt" writings.

Because of the lack of comparable letters and letter combinations necessary for an adequate comparison, it could not be determined whether the "Harvey Lowmyer" signature on the Q72 gun invoice was prepared by the writer of the money orders, Q216 through Q224, and other writings attributed to Galt.

It was concluded that the questioned signatures on Q225 and Q226 were prepared by the writer of the "Galt" signatures on other specimens previously submitted.

The typewritten impressions appearing on Q225 are the same style as those appearing on other items believed emanating from Galt, but the lack of identifying defects precludes a determination that the same typewriter was used to prepared all of these items.

The submitted specimens are temporarily retained. Photographs were made.
