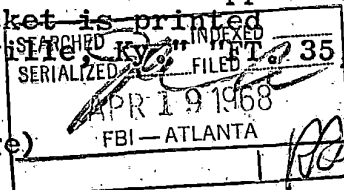

Result of examination:

It was concluded that the writings appearing on Q118 were not prepared by the writer of the other material attributable to the unknown subject also known as Eric S. Galt. While the limited nature of the "Harvey Lowmyer" signature on Q72 and the lack of comparable letters for comparison precluded an adequate examination, differences were noted between the writings on Q118 and the questioned "Lowmyer" signature.

Among the miscellaneous items in Q122 and Q123 were two tickets stapled together, one red and one green. The top red ticket bears the numbers "4" over "4591" which appear on each half of this ticket. The green ticket is printed "FLAG-TAGS," "STRY-LENKOFF Co.," "Louisville, Ky.," "printed in USA."

Also included in the above were twenty "S&H" green stamps, each of which had "14LK" printed at the top and "627" printed at the bottom.

These items, Q118 through Q123, were examined for indented impressions and other markings but other than that set out above, nothing of significance was noted.

The evidence has been retained.

OSBORNE, informed him that some time in the past he met one JOE GEARY, a welder who spends his summers in Ill. or Mich. and his winters in Fla. in some respects "favored" the photograph of ERIC STARVO GALT, which appeared in the Atlanta newspapers on 4/18/68.

GEARY is well known to one LARRY PODLIN, Manager of the Health Club, Air Host Inn, Atlanta, Ga., Airport.

LARRY PODLIN, supra, contacted same date by SAs JOHN J. LANGSFELD and JOHN B. REYNOLDS. PODLIN advised he is from Chicago and he has a friend, JOE GEARY, who is also from Chicago, Ill.

He advised GEARY is a white male, 44 years of age, single, 5'8", dark, straight hair, combed "slick." PODLIN viewed a photograph of ERIC STARVO GALT and stated he did not resemble JOE GEARY. PODLIN made available a letter and envelope he received from GEARY postmarked 4/4/68, Chicago, Ill. He stated GEARY currently resides at 8935 South Troop, Chicago, Ill, 60620. This address is that of a friend and GEARY owns and operates about a 1966 green Chevrolet truck which has a camper on the back bearing an Ill. tag. He spends his summers in Chicago, Ill., area and his winters in the area of Ft. Lauderdale, Fla.

APRIL 19, 1968

ATTORNEY GENERAL RAMSEY CLARK ANNOUNCED TODAY THAT THE FBI HAS IDENTIFIED JAMES EARL RAY, AN ESCAPEE FROM THE MISSOURI STATE PENITENTIARY, AS ERIC STARVO GALT, AGAINST WHOM A FEDERAL COMPLAINT WAS FILED LAST WEDNESDAY IN CONNECTION WITH THE FATAL SHOOTING OF THE REVEREND DR. MARTIN LUTHER KING, JR.

DIRECTOR J. EDGAR HOOVER SAID THAT A SYSTEMATIC AND EXHAUSTIVE SEARCH OF LATENT FINGERPRINTS UNCOVERED IN THE DR. KING CASE AGAINST THE FINGERPRINTS OF THE OVER 53,000 PERSONS FROM WHOM "WANTED NOTICES" HAVE BEEN POSTED IN THE FILES OF THE FBI'S IDENTIFICATION DIVISION LED TO THE DETERMINATION THAT GALT AND RAY ARE IDENTICAL.

MR. HOOVER SAID THAT RAY, WHO IS 40 YEARS OF AGE, WAS REPORTED MISSING FROM THE MISSOURI STATE PENITENTIARY AT JEFFERSON CITY, MISSOURI, SINCE APRIL 23, 1967. HE HAD BEEN RECEIVED AT THAT INSTITUTION ON MARCH 17, 1960, TO SERVE A 20-YEAR SENTENCE FOLLOWING CONVICTION IN ST. LOUIS FOR ARMED ROBBERY AND FOR OPERATING A MOTOR VEHICLE WITHOUT PERMISSION OF THE OWNER.

PAGE THREE

IN SEPTEMBER, 1966, WHILE SERVING THIS SENTENCE, HE WAS CONFINED FOR A TIME IN THE MAXIMUM SECURITY WARD AT THE STATE HOSPITAL AT FULTON, MISSOURI.

ACCORDING TO MR. HOOVER, RAY HAS A KNOWN ARREST RECORD DATING BACK TO 1949. PRIOR TO THE 1960 CONVICTION FOR WHICH HE RECEIVED THE 20-YEAR TERM, RAY HAD BEEN CONVICTED OF BURGLARY IN LOS ANGELES, CALIFORNIA, IN 1949; ARMED ROBBERY IN CHICAGO, ILLINOIS, IN 1952; AND FORGING UNITED STATES POSTAL MONEY ORDERS IN MISSOURI IN 1955.

HE HAS SERVED TERMS IN THE LOS ANGELES COUNTY JAIL IN 1949; IN STATE PRISONS AT JOLIET AND PONTIAC, ILLINOIS, IN 1952-54; AND IN THE FEDERAL PENITENTIARY AT LEAVENWORTH, KANSAS, IN 1955-58.

RAY WAS AN ENLISTED MAN IN THE UNITED STATES ARMY FROM FEBRUARY, 1946, TO DECEMBER, 1948, AT WHICH TIME HE WAS GIVEN A GENERAL DISCHARGE DUE TO INEPTNESS AND LACK OF ADAPTABILITY FOR MILITARY SERVICE. WHILE IN THE ARMY, HE RECEIVED A THREE-MONTH SENTENCE AT HARD LABOR FOR BEING DRUNK AND BREAKING ARREST.

MR. HOOVER SAID THAT DURING HIS CRIMINAL CAREER, RAY HAS ALSO USED THE NAMES OF JAMES MCBRIDE, JAMES WALTON, W. C. HERRON AND JAMES O'CONNER. HE IS A WHITE MALE; CLAIMS TO HAVE

BEEN BORN [REDACTED] IN ILLINOIS; IS APPROXIMATELY 5 FEET 10 INCHES TALL AND WEIGHS ABOUT 163 TO 174 POUNDS. HE HAS BLUE EYES AND BROWN HAIR. THERE IS A SMALL SCAR ON THE CENTER OF HIS FOREHEAD AND A SCAR ON THE PALM OF HIS RIGHT HAND.

RAY HAS CLAIMED THAT HE ATTENDED SCHOOL THROUGH THE 10TH GRADE IN ALTON, ILLINOIS. HE HAS HAD THE REPUTATION OF BEING A "DRIFTER" SINCE LEAVING SCHOOL. HIS VOCATIONAL EXPERIENCE INCLUDES WORKING AS A BAKER, LABORER AND COLOR MATCHER.

IN CONNECTION WITH HIS ESCAPE FROM THE MISSOURI STATE PENITENTIARY, AN FBI COMPLAINT WAS FILED IN JEFFERSON CITY, MISSOURI, ON JULY 20, 1967, CHARGING RAY WITH UNLAWFULLY FLEEING FROM THE STATE OF MISSOURI TO AVOID CONFINEMENT. HE HAS BEEN A FEDERAL FUGITIVE SINCE THEN.

RAY SHOULD BE CONSIDERED ARMED AND EXTREMELY DANGEROUS. ANYONE HAVING INFORMATION CONCERNING HIM SHOULD IMMEDIATELY CONTACT FBI HEADQUARTERS IN WASHINGTON, D. C., OR THE NEAREST FBI OFFICE.

Reference: Laundry Phase

The following investigation was conducted on April 17, 1968, by SAs MARION E. CHEEK and TRAVIS L. LYNCH:

Observation of the J. R. Cheshire Company, 379 Piedmont Road, NE, Atlanta, Georgia, revealed this building was torn down for the City Auditorium.

Mr. JOHN ROWAN, Southern Automatic Equipment Company, 496 Piedmont Avenue, NE, Atlanta, Georgia, advised that J. R. Cheshire Company, formerly located at 379 Piedmont Road, NE, Atlanta, Georgia, is out of business, but the business of that company was assumed by the Wink Davis Equipment Company, Inc., 568 Somerset Terrace, NE, Atlanta, Georgia.

Mr. TROY THOMASTON, Wink Davis Equipment Company, Inc., 568 Somerset Terrace, NE, Atlanta, Georgia, advised his company was established about 3½ years ago, and assumed the operation of J. R. Cheshire Company. He stated they are distributors of laundry machine equipment.

Mr. THOMASTON advised that on December 13, 1963, they sold Thermo Seal Machine, Serial Number 32735, to McDonough Cleaners and Laundry, McDonough, Georgia. Mr. THOMASTON believes that McDonough Cleaners and Laundry has since traded this machine and he suggested that Mr. AIKEN CHAFFIN, Owner, McDonough Cleaners and Laundry, McDonough, Georgia, be contacted to determine the present location of the Thermo Seal Machine, Serial Number 32735.

Mr. JOHN ROWAN, Manager, Southern Automatic Equipment Company, 496 Piedmont Avenue, NE, Atlanta, Georgia, advised that his company is a distributor for Thermo Seal Machines. He advised that his company does not utilize any machines for marking laundry, and they are strictly laundry equipment distributors.

Mr. ROWAN checked his records and advised that his company sold Thermo Seal Machine, Serial Number 32794 to Mr. MARSHALL MC FARLAND, 2458 Carroll Avenue, Chamblee, Georgia, who operates Chamblee Cleaning Center. Mr. ROWAN knows that Mr. MC FARLAND has several other locations and that he has several other similar machines at his other locations.

Mr. MARSHAL MC FARLAND, Owner, Chamblee Sunshine Cleaning Center, 2458 Carroll Avenue, Chamblee, Georgia, furnished the following information:

Mr. MC FARLAND is the owner and operator of the Chamblee Sunshine Cleaning Center, 2458 Carroll Avenue, Chamblee, Georgia; the Shallowford Plaza Sunshine Center, 2604 Shallowford Road, NE, Atlanta, Georgia; the Roswell Plaza Sunshine Center, 1037 Alpharetta Street, Roswell, Georgia; the Dial Cleaners and Laundry, 3426 Shallowford Road, Chamblee, Georgia; and the Dial Cleaners and Laundry, 285 Mount Vernon Highway, Sandy Springs, Georgia.

Mr. MC FARLAND has Thermo Seal Machines at each of the above locations, and these machines are used for marking shirts and flat work. Each of his machines has 6 characters for printing and his code is as follows:

The first 2 digets are used to indicate the lot number, the 3rd character is a letter used to designate the week. The week is designated by starting with the alphabet, and running through the alphabet each 6 months, using 1 letter per week. The last 2 digets are used to designate a bundle number. Mr. MC FARLAND's establishments do not use the 6th character on his machines. All of the establishments use the same type of code.

Mr. MC FARLAND exhibited Thermo Seal Machine, Serial Number 32794 at the Chamblee Sunshine Center, 2458 Carroll Avenue, Chamblee, Georgia, and furnished samples reflecting the code 02B-6; D2B-6; and 20R-3.

Mr. MC FARLAND has not used red tape on his Thermo Seal Machines, except some period of time ago, his Shallowford Plaza Sunshine Center used 2 rolls of red tape for marking laundry. This establishment at Shallowford Center ordinarily uses yellow tape. The Chamblee Sunshine Cleaning Center uses blue and gray tape only, and has never used another color. The Roswell Sunshine Cleaning Center, Roswell, Georgia, uses only pink tape, and has never used another color. The Dial Cleaners and Laundry, 3426 Shallowford Road, uses only white tape, and has never used another color.

The Dial Cleaners and Laundry at 285 Mount Vernon Highway, Sandy Springs, Georgia, uses only white tape, and has never used another color tape.

On April 18, 1968, Miss ANN TRIBBLE, Assistant Manager, Shallowford Plaza Sunshine Center, 2604 Shallowford Road, NE, Atlanta, Georgia, which is one of Mr. MARSHALL MC FARLAND's establishments, furnished samples of yellow tape bearing the codes 02B-6; D2B-6; and 20R-3.

Miss TRIBBLE checked her records and advised that on October 25, 1967, her establishment did use the code 20R-3 on 1 shirt for Mr. SAM HARDMAN, Claim Check Number L-35639. From a review of records, she was positive that Mr. HARDMAN only had 1 shirt laundered and she was positive that this particular code could not have been placed on another item for at least 6 months prior to October 25, 1967, and has not been used since that time. This establishment would not have used the code 02B-6 or D2B-6 inasmuch as their code would have reflected 2-B-6 instead of 02B-6, and they would not have used a letter as the first character in their code.

Inasmuch as Mr. MC FARLAND advised none of his establishments would have used yellow or red tape, except the one at Shallowford Plaza, no samples were obtained from his other locations.





Attorney General Ramsey Clark announced today that the FBI has identified James Earl Ray, an escapee from the Missouri State Penitentiary, as Eric Starvo Galt against whom a Federal complaint was filed last Wednesday in connection with the fatal shooting of the Reverend Dr. Martin Luther King, Jr.

FBI Director J. Edgar Hoover said that a systematic and exhaustive search of latent fingerprints uncovered in the Dr. King case against the fingerprints of the over fiftythree thousand persons for whom "Wanted Notices" have been posted in the files of the FBI's Identification Division led to the determination that Galt and Ray are identical.

Mr. Hoover said that Ray, who is forty years of age, was reported missing from the Missouri State Penitentiary at Jefferson City, Missouri, since April 23, 1967. He had been received at that institution on March 17, in St. Louis for Armed Robbery and for Operating a motor vehicle without permission of the owner.

In September, 1966, while serving this sentence, he was confined for a time in the maximum security ward at the State Hospital at Fulton, Missouri.

According to Mr. Hoover, Ray has a known arrest record dating back to 1949. Prior to the 1960 conviction for which he received the twenty-year term, Ray had been convicted of burglary in Los Angeles, California in 1949; armed robbery in Chicago, Illinois in 1952; and forging United States Postal Money Orders in Missouri in 1955.

He has served terms in the Los Angeles County Jail in 1949; in State prisons at Joliet and Pontiac, Illinois in 1952-54; and in the Federal Penitentiary at Leavenworth, Kansas, in 1955-58.

Ray was an enlisted man in the United States Army from February, 1946, to December, 1948, at which time he was given a General Discharge due to ineptness and lack of adaptability for military service. While in the Army, he received a three-month sentence at hard labor for being drunk and breaking arrest.

Mr. Hoover said that during his criminal career, Ray has also used the names of James Mc Bride, James Walton, W. C. Herron and James O'Conner. He is a white male; claims to have been born in Illinois; is approximately five feet ten inches tall and weighs about

163 to 174 pounds. He has blue eyes and brown hair. There is a small scar on the center of his forehead and a scar on the palm of his right hand.

Ray has claimed that he attended school through the tenth grade in Alton, Illinois. He has had the reputation of being a "drifter" since leaving school. His vocational experience includes working as a baker, laborer and color matcher.

In connection with his escape from the Missouri State Penitentiary, an FBI complaint was filed in Jefferson City, Missouri on July 20, 1967, charging Ray with unlawfully fleeing from the State of Missouri to avoid confinement. He has been a Federal fugitive since then.

Ray should be considered armed and extremely dangerous. Anyone having information concerning him should immediately contact FBI Headquarters in Washington, D. C., or the nearest FBI Office.
