SAs JOHN P. GRANFIELD and C.O. KENNERLY, JR.:

RE: LEWIS DOWDA PHASE

On 4/24/68, Mrs. RALPH J. GRAHAM, 65 Wood Ridge Drive, Marietta, Georgia, telephone number 422-2514, advised she is the mother of SHARON DOWDA, nee Graham, aka Mrs. Lewis Dowda.

Mrs. GRAHAM reported that her daughter, SHARON, is 22 years of age, and met her husband, LEWIS DOWDA, while she was employed part-time at the Bonanza Steak House in Marietta, Georgia. SHARON, according to Mrs. GRAHAM, knew DOWDA for about four months prior to their marriage in August 1967. Since their marriage, Mr. and Mrs. DOWDA lived at Olive Springs Apartments at Austell and Olive Springs Roads, Cobb County and subsequently moved to Frances Ann Apartments on Olive Springs Road, Smyrna, Georgia where they were living at the time of LEWIS DOWDA's arrest on 4/15/68.

They are the parents of a two week old baby who Mrs. GRAHAM was caring for at the time of the interview. She explained that her daughter, SHARON, is staying with her and her husband temporarily.

She viewed photographs of subject JAMES EARL RAY with negative results and advised that she has never heard her son-in-law, LEWIS DOWDA, whom she referred to as "Whitey" refer to subject RAY.

She advised that he never exhibited any right or left feelings but did state that he did not like the riotous conditions which have prevailed nor did he like STOKELY CARMICHAEL. She added that her son-in-law never had any problems with members of the Negro race and pointed out that he got along well with the employees at the Bonanza Steak House.

She advised that the only individual she knows of who was a friend of her son-in-law's was an individual whom she knew only as "RED" who visited her daughter and son-in-law for about two weeks in about September 1967. Her son-in-law told her that he had met this individual in Missouri and the purpose for "RED" coming to Cobb County was for the purpose of seeking employment in the neon lighting business. She added that "RED" was accompanied by his, "RED's" wife and baby boy who was then four to five months old. "RED" and his family came to Cobb County in about a 1956 or 1957 Dodge which he traded in for a Volkswagen probably at Schoenfeld, Inc., 350 White Ave., SE, Marietta, Georgia, telephone number 422-4303.

She described "RED" as being a white male, 6'5" tall, very slender, late 30s or early 40s, reddish hair and reddish-brown complexion.

She added that the parents of her son-in-law, LEWIS DOWDA, live at 110 Chandler Ave., DeLand, Florida. She stated that her daughter and son-in-law visited his parents in DeLand.

She again reiterated that she has absolutely no information concerning subject RAY under his true name or aliases, and she is certain that there has been no contact between subject and her son-in-law DOWDA.

SHARON DOWDA, 2016 Olive Springs Road (Frances Ann Apartments, Apartment I-3, Marietta, Georgia) advised that she is the wife of LEWIS DOWDA and she has been married to him since 8/19/67. She advised that she and her husband are the parents of a two week old baby. She reported she met her husband while she and he were employed at the Bonanza Sirloin Pit, Marietta, Georgia and this meeting occurred sometime in the latter part of May 1967.

She viewed photographs of subject JAMES EARL RAY and advised that she had never met this individual nor had her husband ever mentioned his name prior to about 4/23/68 when she discussed this with her husband while he was in jail in Marietta, Georgia. She advised that at that time he said to her that he had met this individual whom he referred to as "JIMMY" at the Missouri Prison. She explained that this was after GALT's picture appeared on television and in the newspapers and her husband stated he did not know anyone by the name of GALT. Later as GALT was identified as RAY, her husband stated that he slightly knew RAY as a "JIMMY" at the Missouri Prison Branch.

She advised that the only friends her husband had other than the individuals he became acquainted with in Marietta were the following:

PAUL LAIL, JR., who owns a home in Palm Beach, Florida. She reported that LAIL together with LAIL's wife, BETTY, and baby DAVID visited her and her husband some two to three months ago and visited with them in Cobb County, Georgia for about three weeks. LAIL, according to Mrs. DOWDA, was in the lighting business and worked for an Atlanta company (name not known to her) for a period of about two weeks during the time that Mr. and Mrs. LAIL were visiting them.

She explained that she does not know the circumstances surrounding her husband's meeting LAIL but stated this occurred in Missouri.

She described LAIL as being a white male, 38 to 39 years of age, 6'5" tall, skinny, red hair, ruddy complexion, wears glasses and had a Volkswagen which he bought and paid for at some automobile dealer's agency in Marietta.

JOHN PETRIE, Shott Road, Star Route #2, Jefferson City, Missouri, who had something to do with the State Penitentiary there.

✓ A guard, name unknown, who was also affiliated with the penitentiary at Jefferson City, Missouri and still another individual (name unknown) who was also affiliated with the penitentiary at Jefferson City in a supervisory position in the diet kitchen.

With respect to PETRIE and the two unknown individuals, she advised that she and her husband took a trip to California in November and December 1967 and en route there visited the above three individuals in Jefferson City, Missouri.

While in California, she and her husband visited her aunt and uncle, Mr. and Mrs. ROBERT GRAHAM, Palos Verdes Peninsula, Los Angeles and also visited Monterey, California. She advised that she was with her husband constantly during their trip to California and he made no contacts while there.

She advised that the only individual her husband corresponds with is the individual cited above who is affiliated at the Diet Kitchen at the State Penitentiary and who also has a farm and cattle somewhere in the Jefferson City area.

On 4/24/68, RALPH GRAHAM, father of SHARON GRAHAM DOWDA, 65 Wood Ridge Drive, Marietta, Georgia, advised that his son-in-law, LEWIS DOWDA, while working for the Bonanza Sirloin Pit, became friendly with LLOYD JURNIGAN (phonetic) who was the manager of Bonanza Sirloin Pit, and who presently resides in Chamblee, Georgia (address unknown) and is also the operator of a restaurant (name not known) in Atlanta.

According to GRAHAM, JURNIGAN knew some friends of DOWDA.

On 4/17/68 FRED TIBBITS, Ideal Cleaners, Gainesville, Georgia, advised that the laundry mark 20-R-3 in all probability stands for the following:

The number 20 denotes the lot number of the laundry, the letter R denotes the letter which is used the particular week the laundry is checked into the respective laundry, and the number 3 in all probability denotes the bundle number of the laundry.

TIBBITS advised that in the Ideal Laundry at Gainesville, the lot numbers have never gone above the number 12; therefore, he is sure that a laundry marked 20-R-3 did not come from the Ideal Cleaners at Gainesville.

On 4/19/68 FRANCES DOOLEY, Gainesville Steam Laundry, Gainesville, Georgia, advised that the Steam Laundry does not use the Thermo-Seal Laundry Tapes in marking laundry. She advised that she has been employed by this laundry for eight years and that during this period of time, the laundry has utilized paper with metal clips which are attached to the laundry. She reiterated that Gainesville Steam Laundry did not utilize any thermo-seal tapes.

HERSHEL THORNTON, Owner, Thornton Mortuary, 3340 Gordon Road, SW, was interviewed by SA WILLIAMS B. WATTS, JR., on April 24, 1968. THORNTON furnished substantially the same information as he furnished to Complaint Clerk ROSEBERRY on April 22, 1968. THORNTON advised that his mortuary received a telephone call from a woman on the night of April 18, 1968. This woman indicated that she was presently located on the Buford Highway in Chamblee, Georgia, and asked for directions as to how to get to his funeral home. He instructed her to take the North Expressway to Interstate 20. Sometime shortly before 11:00 p.m., on April 18, 1968, an individual appeared at the funeral home and identified himself as Dr. EARL VAN NESS. VAN NESS was accompanied by a woman whom he introduced as his wife. VAN NESS related to him that he wanted to make funeral arrangements for Dr. HOWARD CLEVELAND, a former professor at Howard University in Washington, D.C. VAN NESS indicated that he had either worked with VAN NESS or been associated with him in some way. VAN NESS stated that Dr. CLEVELAND's home address was Washington, D.C., was 223 East Capitol Street, Apartment 103, Washington, D.C. VAN NESS also mentioned the name of the Hospital that CLEVELAND reportedly died in but THORNTON was unable to recall the name of the hospital but thought it may have been connected with Howard University. VAN NESS told THORNTON that the funeral was to be a quiet arrangement and would be attended only by teachers and officials from Washington, D.C. He indicated that no announcement was to be made in the papers. VAN NESS told THORNTON that he had only \$280 to use as expenses for the funeral for Dr. CLEVELAND. THORNTON advised that he exhibited caskets and quoted VAN NESS a complete funeral arrangement, the cost of which including cemetery lot came to \$740. VAN NESS

indicated to him that he would have to look into the matter of obtaining the extra \$460 to pay for the funeral and promised to call THORNTON on April 19, 1968, at 11:00 a.m. sharp.

THORNTON advised that he never received a call from VAN NESS and has heard nothing from him since that time.

Mr. THORNTON advised that during the time he discussed the funeral arrangements with VAN NESS, VAN NESS commented that Washington was in an uproar. He further indicated that Dr. CLEVELAND had died as a result of the death of Dr. MARTIN LUTHER KING. Mr. THORNTON advised that he got the definite impression that VAN NESS was trying to engage him in a conversation about Dr. KING's death but he refused to discuss the matter with him. Mr. THORNTON advised that VAN NESS may have thought that the funeral arrangements for Dr. KING had been made by his funeral home; however, funeral arrangements for KING were handled by his brother's funeral home, the Marcellous Thornton Funeral Home, located on Jonesboro Road, SE.

Mr. THORNTON advised that he became suspicious of VAN NESS after VAN NESS indicated that Dr. CLEVELAND held a PHD degree and he wondered how such a man who had been associated with Howard University could have died without insurance. He stated that VAN NESS explained to him that Dr. CLEVELAND had been originally from the Atlanta, Georgia area but there were no living members of his family now in Atlanta. THORNTON advised that he definitely smelled whisky on VAN NESS' breath at the time he was at the funeral home.

Mr. THORNTON advised that VAN NESS indicated that he was staying at the Holiday Inn, north end or northeast, in Room 210 E.

THORNTON described Dr. VAN NESS as follows:

Mr. THORNTON advised that there was another white woman with blond hair sitting in the rear of VAN NESS' 1968 white Mustang. THORNTON advised that he observed this woman as he walked VAN NESS to the door of the funeral home. THORNTON advised that inasmuch as he was suspicious of VAN NESS at this time, he did not accompany VAN NESS to his automobile. THORNTON was shown photographs of JAMES EARL RAY and advised that RAY resembled the individual known to him as Dr. EARL VAN NESS provided one colored RAY's hair red, placed a bushy red moustache on his photograph. He added that in addition, Dr. VAN NESS was wearing dark horn-rimmed glasses. VAN NESS spoke with an accent which resembled the accent of a person who had lived in the South at one time but had moved to the North. He indicated that VAN NESS stated that he was originally from Birmingham, Alabama.

Reurmemo 4/24/68, with lead to attempt to develop any information from the Atlanta Police Department regarding the possibility of subject's being involved in any "fracas" with any Negro in the area during his presence in Atlanta.

Det. Sgt. ROBERT B. MOORE, Atlanta Police Department, advised on 4/24/68 that matters involving difficulty between white and Negro individuals are normally called to his attention for informational purposes; however, an arrest report would not necessarily be made on all arrests, therefore, the most satisfactory approach would be to contact the superior officers in charge of each watch as well as a particular officer covering the 14th and Peachtree Street area.

On 4/25/68, Sgt. MOORE advised that he had contacted the logical officers in a position to have knowledge of any arrests involving a white man of the subject's description with a Negro individual anywhere in the Peachtree-14th Street area during the approximate period of 3/24/68 through 4/11/68, and no one recalled any incident which could be considered pertinent to this matter.



At this time a number of other c/m came around the street and the boys jumped in a automobile headed west on Auburn Ave. He does not believe he would be able to recognize them.



A-2 advises that he was asked to a meeting Wednesday evening, February 10, at the home of Lewis Eldridge, who now lives at 412 Shannon Drive, S.W. (Eldridge and A-2 have known each other for some time).

Present at the meeting was Earl Holcolm. Our records reflect that on May 14, 1962, Holcolm was one of four individuals meeting in James Venable's office with regard to the Defensive Legion of Registered Americans. Holcolm is described as a klansman who had been involved in the Athens riots.

Holcolm was armed with a .38 caliber top break revolver which he carried in a western style holster and a full shell belt under his coat.

Eldridge and Holcolm quizzed A-2 unmercifully, told him he had been under their constant surveillance for the past four years (obviously a lie), that Eldridge had four men high up in ADL and that A-2 would be checked through ADL records, etc. They wanted details about his proficiency with weapons in the service and specifics about his feelings on the race issue. Their attitudes indicated they believe the Reverend Martin Luther King, Jr. is one of their main problems.

They specifically invited A-2 to be a member of a secret group to go anywhere on a few minutes notice, to do anything he was ordered to do without question.

A-2 by pure luck under the stress gave the correct answers and fended and parried to the degree that Eldridge was impressed. A-2 has a permit to carry a pistol while working as a security guard for Southern Detectives, Inc. with whom he is occasionally employed to make extra money. Eldridge and Holcolm insisted that this was excellent cover and cautioned him to maintain his status with them.

The final touch of the evening was when Holcolm produced an application blank for membership in the National Knights of the Ku Klux Klan, headquarters unit in Tucker, Ga., made A-2 sign and stated "this will make it legal."

A-2 believes from the discussion that there is in being this small secret group and they represent a serious potential danger.

A-3 advises that he was present in the room when Venable spoke to J.B. Stoner and as the conversation progressed he was asked to leave the room. He feels very strongly that these two items are inter-related.

SELECTION OF KING AS THIS YEARS WINNER NOT ONLY MAKES THE PEACE PRIZE MEANINGLESS BUT A MOCKERY. ALTHOUGH THERE ARE SOME CLOSE RUNNERSHIP HE HAS DONE MORE THAN ANY OTHER INDIVIDUAL TO STIR UP HATRED AMONG RACES, sow discord and generate violence in his country while piously and HYPOCRITICALLY posing as an ADVOCATE OF NON-VIOLENCE.

KING'S CANDIDACY WAS SPONSORED BY POLITICAL FIGURES IN THE UNITED STATES AND EUROPE AND THIS SHOULD EXPLAIN IN PART WHY HE WAS CHOSEN FOR THE AWARD. WE WERE UNABLE TO COME UP WITH A NOMINEE. IN FURTHER SEARCH ON A GLOBAL SCALE WE CONSIDERED CASTRO AND MAO TSE-TUNG BUT REJECTED THEM FOR TECHNICAL REASONS."
