University of Georgia Student
DERREL E. LEE, Athens, Ga.

Pursuant to instructions from SAC FRANK V. HITT to SA ROBERT MICHAEL KANE on 4/29/68, DERREL E. LEE was reinterviewed at Athens, Ga. on 4/30/68.

LEE advised that he and fellow University of Ga. students JACK GARRETT and DAN YOUNG who along with himself live in Russell Hall, a men's dormitory at the University of Ga., spent their spring vacation from the University of Ga. in New York City, N.Y. LEE advised that he roomed with his uncle DONALD LEE at 175 W. 79th St., New York City, N.Y. He explained that his uncle is a fashion photographer in New York City.

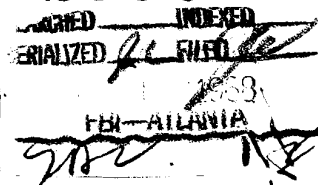
He related that approximately the night of 3/20/68 while he and JACK GARRETT and DAN YOUNG were standing in a cafeteria line, name of cafeteria being Tad's Steak House near Rockefeller Center, New York City, he had conversation with a man, who was also standing in this cafeteria line, who noticed that LEE had a southern accent. This man, according to LEE, told him his name was GARY BURNSED (phonetic) who originally came from the vicinity of Denver, Col.

LEE related that he and BURNSED had some casual conversation while standing in the line and then made plans to go nightclubbing in New York City that night together. LEE stated that his friends, JACK GARRETT and DAN YOUNG, were planning on going to the theater. LEE advised that he and BURNSED went to

a lot of nightclubs together and he noticed that BURNSED drank a lot and in fact used some of the tickets obtained by LEE in the nightclubs which entitled LEE to have some drinks. He stated that these tickets were obtained when he and BURNSED paid the cover charges at the door and that these tickets represented drinks that they were entitled to as a result of paying the cover charge. LEE advised that he does not drink very much and only had one or two drinks while BURNSED had quite a bit to drink.

LEE advised that a night or so after he and BURNSED were together, LEE was with his uncle DONALD LEE and they ran into BURNSED at an unrecalled nightclub. LEE described his uncle as being a fashion photographer, "who" plays around a lot" in New York City. He stated that when they ran into BURNSED, his uncle DONALD went his separate way leaving LEE and BURNSED together.

He further related that while sitting and drinking in this nightclub, BURNSED had approximately eight or ten mixed drinks which he believed were liquor and some mix, and that during the conversation LEE mentioned to BURNSED that LEE felt that the students at the University of Ga. would back BOBBY KENNEDY in his election campaign for President. LEE stated that this visibly angered BURNSED who said to LEE, "Let me tell you a few things." LEE stated that BURNSED then proceeded to tell him that President JOHNSON would leave office within two weeks of that night they were together in New York, that JIM GARRISON would be killed this summer, that MARTIN LUTHER KING would be assassinated down South, and also proceeded in giving his version of the assassination of President JOHN F. KENNEDY. LEE recalled that BURNSED stated that President KENNEDY was shot from a bridge rather than from the book depository in Dallas, Texas. LEE also recalled that BURNSED told him that the Viet Nam War would be de-escalated in the near future.

LEE stated that he "just thought that BURNSED was like a person who had extrasensory perception qualities".

LEE further advised that he last saw BURNSED at the Checkerboard Nightclub in Greenwich Village, New York City on his third and last occasion, prior to leaving New York City for return to Athens, Ga. He explained that the observations

concerning the assassination of MARTIN LUTHER KING took place on the second meeting with BURNSED at an unrecalled nightclub in New York City. He advised that no one else was present during the statements made by BURNSED and that neither of his friends, JACK GARRETT or DAN YOUmans, had heard BURNSED make any such statements because they were not physically present when BURNSED told LEE in the nightclub conversation.

LEE could furnish no address for BURNSED and described him as being approximately 25 or 26 years of age, Scandinavian appearing, and a person in such physical condition as he could pass as a physical training teacher. LEE recalled that BURNSED told him that he was "in training", type of training not disclosed, from 6:30 a.m. until evening hours at night. LEE also recalled that BURNSED told him that he had to fly to New Jersey quite frequently from New York. He also recalled that BURNSED told him that he could only come into Manhattan every other day.

LEE was queried as to whether he questioned the statement made by BURNSED to him about flying to New Jersey when New Jersey was just across the Hudson River from Manhattan. LEE stated that he did not question him concerning this flying back and forth from Manhattan to New Jersey. He also stated that he did not note any credit cards or any other form of identification that BURNSED may have had.

LEE was queried as to whether this BURNSED individual made any improper advances towards him which caused LEE to become physically agitated and he vigorously denied that any improper advances had been made to him by BURNSED.

During the course of conversation with DERREL LEE, it was obvious that he has effeminate type speech and that he was visibly nervous and agitated and reacted to questions concerning his being a discotheque dancing instructor as well as prior questions mentioned concerning improper advances made by BURNSED in an agitated manner. At one point during the interview, LEE started crying and appeared very emotional. He subsequently calmed down and stated that he was telling the truth concerning his encounter with the individual named BURNSED.

He advised that the only person that he told that he was going to discuss this matter with the FBI was his roommate JACK GARRETT. He denied confiding in any other student or other person that he had an appointment with the FBI in Athens, 4/16/68.

LEE stated that the headline and news article that appeared in the Daily News, Athens, Ga. on Wednesday morning, 4/17/68, is inaccurate and entirely blown out of proportion to what actually he had told the reporter from that paper. He advised that he did not make any statement to the newspaper that he heard of a plot to kill MARTIN LUTHER KING. LEE also denied making any statement that he had talked with a person who called himself "a Secret Agent" working out of Colorado Springs, Col. He stated that he made no statement that MARTIN LUTHER KING, according to the alleged Secret Agent, would be assassinated in Memphis, Tenn. He advised that there is no truth to this statement whatsoever. He also denied telling the newspaper reporter that he had feared the "Mafia". He further denied making a statement that the FBI was protecting him at the University of Georgia.

LEE advised that since his initial conversation with reporters from the Athens Daily News he has been harrassed by newspaper reporters and has received telephone calls from the UPI, Atlanta, Ga. as well as the New York Times in New York City, N.Y. He stated that he has not commented any further to any member of the press and has no plan on making any further comment concerning his meeting with GARY BURNSED in New York City on 3/20/68.

The following investigation was conducted by
SA JAMES RICHARD FLICK:

AT ALPHARETTA, GA.


On 4/26/68, contact was made with Mrs. LUCAS E. BIRT, 325 Karen Dr., regarding the possible information and photographs that she and her husband may have had regarding the whereabouts of JAMES EARL RAY. At the time of this interview, Mrs. BIRT advised that her husband was not available for interview at this time and that she did not desire to speak to the interviewing agent without her husband being present. Mrs. BIRT was asked by the interviewing agent about when would be a convenient time for their interview. BIRT requested that telephonic contact be made with them on Monday morning, 4/29/68, as she was uncertain as to whether or not they would be home over the weekend.

On 4/29/68, telephonic contact was made with the BIRT residence, phone 475-7428, at which time SA FLICK was advised that Mr. BIRT was again not at home and she was not certain when the two of them would be available for interview.

On 4/30/68, Mrs. BIRT was again contacted and again advised that her husband was not at home and was not certain when they would be available for interview.

On 5/1/68, Mr. and Mrs. LUCAS BIRT were interviewed at their place of residence, 325 Karen Dr., Alpharetta, Ga., at which time Mrs. BIRT advised during October of 1967 while she and her husband were attending choir practice at the Mount Paran Church of God, Atlanta, Ga., she noticed a man whose face was familiar to her. Mrs. BIRT advised that the time she first saw this man she was not aware of his identity, but later

on met him inside the Mount Paran Church of God and asked if he possibly could have attended college with her. This person told her that he had attended Lee College in Cleveland, Tenn. in about 1949 and told her that his home was either in Birmingham or Mobile, Ala. BIRT stated that later that same evening when they were leaving the church she had noticed this person depart in a white 1966 Mustang.

BIRT continued, upon reading of the information surrounding the captioned subject, she thought that possibly this person whom she had seen at the Mount Paran Church of God might be identical with the subject, JAMES EARL RAY. BIRT advised upon reviewing her college annual, entitled "Vindaugua" for the year 1949, she came across a photograph of a man whom she believed was identical with the person whom she had seen at the Mount Paran Church of God. This man, THERMAL JOHNES, attended either Lee College or High School in the fall of 1948 or 1949. BIRT stated that she had no particular reason to believe that this was the subject, but stated that the photograph of THERMAL JOHNES taken in 1949 bore a slight resemblance to the subject and she felt that this information might be of value.

BIRT advised that she has neither seen nor heard anything of the man whom she knew as THERMAL JOHNES, since October of 1967, and neither she nor her husband had any idea where JOHNES might presently be contacted for interview. BIRT advised this was the only information she had available and stated that she would cooperate in any way with the FBI.

The following investigation was conducted by SA ROBERT K. LEWIS, at East Point, Georgia, on May 1, 1968:

Mrs. LILLIAN GUNDERSON, operator, East Point Heating and Air Conditioning Company, 1728 Connally Drive, advised she has employed JAMES W. WINDOM as a supervisor since August, 1967. She said he has worked steadily during this period and definitely worked the entire first week of April, 1968. She said he is presently in charge of construction of a new fire house at the airport. She stated WINDOM is a native of this area, having gone to school in Hapeville, Georgia. She advised that before she hired WINDOM he worked for many years for Chrysler Airtemp in Atlanta. She stated he does not resemble JAMES EARL RAY. She said WINDOM is a bit "loud-mouthed" and has probably made a few enemies. She said he is definitely not a racist and she did not believe he would be involved in any criminal acts.

She said she did not know who might try to cause trouble for WINDOM or to imply that he might be connected with the murder of MARTIN LUTHER KING, JR.

Mrs. EDNA E. CROOKE, 169 Memorial Street, SE, Apartment 511, was contacted and furnished the following information:

Her apartment overlooks the parking lot in which the 1966 white Mustang was subsequently found. CROOKE said she had never seen this car arrive at the parking lot but was aware that it had parked there for several days prior to its discovery. CROOKE said that on April 5, 1968, she was visited by a friend, Mrs. FLOYD MEDLEY, Jonesboro, Georgia. Sometime about dusk, Mrs. MEDLEY was seated at the front door taking care of her young children. This area overlooks the parking lot which is in front of the CROOKE apartment. At this time nothing was said about any car being in the parking lot. After the discovery of the white Mustang and on a day which CROOKE believes was April 14, 1968, she talked with Mrs. MEDLEY on the telephone. At this time MEDLEY mentioned that while seated at the front steps on April 5, 1968, she had observed a white colored car, which was probably a Mustang slowly drive into the parking lot. Because of the darkness, she was unable to see the license plate on this car and did not get a good look at the driver. She was interested in the car because at first she thought it might be driven by CROOKE's former husband. MEDLEY said that the car drove slowly in the lot and then turned around and left.

CROOKE said she did not recall that MEDLEY had said anything further about the car. About a week or ten days ago, CROOKE was visited by a reporter named DON MC KEE and she mentioned MEDLEY's conversation to him. At that time CROOKE was aware of the unlisted phone number for MEDLEY and furnished it to MC KEE, who immediately phoned her. CROOKE said she overheard the entire conversation and that MC KEE took no notes whatsoever and that at no time

CROOKE advised that MEDLEY suffers a nervous and emotional condition and is easily upset and for this reason her husband has forbidden her to discuss this matter any further with anyone. CROOKE said it is MEDLEY's attitude that Mrs. MEDLEY actually does not know anything about this case anyway. CROOKE further advised that the MEDLEYS have had their unlisted phone number changed and she does not at this time know what it is and she does not know their address, except that they live in a large subdivision somewhere south of Jonesboro.

GAULT was employed as a dragline operator for COBB CONSTRUCTION COMPANY, which company was paving Highway 319, between Wrightsville, Ga. and Dublin, Georgia. About 2 or 3 years after he moved from Brewton, GAULT stopped by to visit there. GAULT had indicated he had followed construction work all over the United States, as well as work in South America and Mexico.
