On April 25, 1968, Special Agents WILLIAM V. KENNEDY and KENNETH R. HEINEMAN followed JOE (No Middle Name) SHARLOW to Mableton, Georgia. SHARLOW was driving his cab. SHARLOW drove around the streets of Mableton for one hour and was unable to find the home at which he dropped off a fare which he stated resembled JAMES EARL RAY. SHARLOW was then told by the above names agents that if should he locate this home, he should contact the FBI in Atlanta. SHARLOW stated that he would do this.

On April 25, 1968, JOE (No Middle Name) SHARLOW, Taxi Cab Driver for the Buffalo Cab Company, 1075 Brady Avenue, Northwest, Atlanta, Georgia, advised he had some information which might possibly aid in the investigation of the death of MARTIN LUTHER KING, JR. SHARLOW stated that at approximately 1:30 a.m. on April 5, 1968, he was parked in his cab at the Atlanta Airport waiting for a fare. He stated that an individual got into his cab and asked SHARLOW to take him to Mableton, Georgia. He described this individual as follows:

SHARLOW further stated that the man told him that he would let him know the route to Mableton because he knew a shortcut. SHARLOW agreed and they pulled away from the Airport.

SHARLOW stated that the man had been drinking and that he could smell liquor on his breath. He advised, however, that he did not consider the man to be drunk. He stated that on a number of occasions during the trip this individual asked him (SHARLOW) for a eigarette and on each

occasion SHARLOW told him that he did not smoke. SHARLOW advised that they drove out 285 and at one point got lost somewhere around Union City, Georgia. He advised that his fare kept saying that his wife was supposed to pick him up but that she had left him and that is why he was taking a cab home. SHARLOW stated that this individual was oddly dressed in the sense that he was wearing a large cowboy hat, tan suit and string tie. He also stated that the man was wearing large dark glasses even though it was very dark outside.

SHARLOW further stated that about half way to Mapleton the man propped his shoulders up on the front seat, took off his glasses, and asked SHARLOW if he thought that a white man had done the killing "up yonder." SHARLOW advised that the man then said that he knew that STOKELY CARMICHAEL did the killing and when SHARLOW asked how he knew that, the man advised that he just knew. SHARLOW then stated that the man stated that he knew all the KINGs. He said that he knew the old man, the mother, the son and lots of other people in the colored section of Atlanta. SHARLOW stated that he then asked him where Dr. KING lived and the man told him that he did not know but it was some place downtown. SHARLOW advised that the above conversation was the last mention of Dr. KING.

SHARLOW then stated that they proceeded on Route 285 and got off on the Mableton exit. They then drove onto Gordon Road and passed Six Flags Road, where they stopped at a small market on the right hand side of the road. At this point, the man got out of the cab and went into the market. When he came out he made the statement that "those people in there don't know me." The man then got back into the cab and asked SHARLOW if he wanted to buy a gun.

He said that he had a "38 and a 45." SHARLOW advised that he did not want a gun. The man then stated that he would be able to sell it in Atlanta.

SHARLOW stated that they then went on past the market and turned left. They then went approximately three blocks and turned left again toward a wooded section. SHARLOW advised that they pulled up to a house with a brick wall on one side and a large driveway. In the driveway were four cars; a 1963 or 1964 green Cadillac with Alabama tags; a 1963 or 1964 dark Buick; a late model, dark brown Thunderbird; and a white Mustang. SHARLOW stated that the man had mentioned previously that he owned these four cars. He stated that the man then asked SHARLOW if he was afraid and stated that he would not hurt him because he was a nice fellow. SHARLOW advised that the man then took out the exact amount of the fare without SHARLOW telling him and paid it. He then went into the house. SHARLOW stated he believed the house number was 113, but did not know the name of the street.

SHARLOW was shown photographs of JAMES EARL RAY also known as ERIC STARVO GALT, and stated that they resembled the man he brought to Mableton on the morning of April 5, 1968. He stated that although he could not give clear directions to the house, he would be able to lead agents to it. He stated that he was willing to do this.



MATCH BOOK FROM REID MOTEL, GREENVILLE, ALABAMA, FOUND BEHIND 107-113 14TH STREET, N.E., ATLANTA, GEORGIA

The following investigation was conducted on May 3, 1968 by SA DANIEL W. MC ALLEN, III, at Greenville, Alabama:

Mr. LONNIE DANIELS, SR., Manager, Reid Motel, Highway 31, advised that he has been working at this motel for the past two years, and presently is managing same in the absence of the owner, Mrs. ETHEL B. DYKES. He said that he normally checks guests in and out of the motel and feels certain he would recognize individual guests from photographs. DANIELS said he was a law enforcement officer for 16 years and has had experience in identifying people from photographs.

DANIELS was shown photographs of JAMES EARL RAY and could not identify any of the photographs as anyone having stayed at this motel in the past. In addition he made available records of the motel which were examined by SA DANIEL W. MC ALLEN, III, but no registration for Subject RAY, under his true name or aliases, was found. This check covered the period from April, 1967 to date.

DANIELS stated that match books at this motel are not kept out in the open where anyone could pick them up, but are given out to persons only on request. He said that the motel has used several different colored match books, and the printing on the match books have differed at times. He stated that if the color of any particular match book and the writing thereon were made known to him, he would possibly be able to pinpoint the approximate time the match book was dispensed at that motel. DANIELS advised that numerous persons from the Atlanta, Georgia, area frequent this motel.

Mrs. MARY OWENS, maid, Reid Motel, was shown photographs of RAY, but could not identify the photographs as anyone having stayed at that motel in the past. 44-9396

OLIVER stated that the person using the name BODKER had a much thinner face, no double chin, and she could recall no facial characteristics of BODKER which resemble those of the photographs of RAY.

Interview WOLKERSTORFER and TOUNY for anything they might have observed while in Atlanta and possibly Birmingham about 4/7/68.

This lead is being set out by sirtel rather than teletype insamuch as they are not returning to the Notre Dame campus until sometime Sumday, 5/5/68.

ARMED AND DANGEROUS.

On April 18, 1968, LARRY KEITH voluntarily appeared at the Thomasville, Georgia Resident Agency of the FBI. He was furnished with a voluntary appearance and Waiver of Rights Form which he read and executed. He was advised that he was being interviewed concerning his activities in the Memphis, Tennessee area during the period surrounding the murder of MARTIN LUTHER KING, JR.

KEITH furnished the following descriptive data concerning himself:

Occasionally drives 1968 Ford Torino, dark blue in color, belonging to friend of VICTOR BATEMAN who resides in Thomasville, Georgia, and occasionally drives motorcycle belonging to VICTOR BATEMAN

Employment

KEITH advised that he has been employed as farm laborer, bakery worker and most recently as deck hand, engineer, and first-mate on tug and tow boats operating along the Mississippi River.

### BACKGROUND

KEITH advised that following the death of his parents in an automobile accident at Keokuk, Iowa, in 1957, he was placed in the custody of RICHARD L. BATEMAN, SR., by Juvenile Court in East St. Louis, Illinois. Since that time, he has resided off and on with RICHARD L. BATEMAN, SR. In 1959, while employed by the B and D Toy Company out of Pittsburgh, Pennsylvania, he suffered an accident aboard the tug boat, "Montgomery". Both of his legs were broken and surgery was later performed on both legs. He was hospitalized in Pekin, Illinois for forty days and was out of work for approximately two years. During his convalescence, he resided with RICHARD L. BATEMAN, SR., at 502 North 61st Street, East St. Louis, Illinois. It was during this period that he married his wife. While residing at the BATEMAN residence, his wife cared for BATEMAN's children inasmuch as BATEMAN was then separated from his wife. In 1965, BATEMAN's residence burned to the ground and BATEMAN acquired a new residence in Berkfield, Illinois. As this time, KEITH and his wife moved to Fairview, Illinois, and purchased a house trailer from an individual by name WILLIAM J. MC MURTREY, About one and one-half months ago, KEITH's wife, upon his instructions, sold the house trailer back to MC MURTREY and rented an apartment situated on Third Street in Madison, Illinois. Occupancy of this apartment is temporary pending their child's completion of this term of school when KEITH's wife and his child will move to a house rented by him in Thomasville, Georgia, and situated at 628 Marshall Street. Occupancy of this house is scheduled in June of 1968.

KEITH advised that on night of March 29, 1968, about midnight, he left the "M-V Ray-A" tug boat owned by Wisconsin Barge Lines, Cassville, Wisconsin, at Memphis, Tennessee. He had been employed on this tug boat for the previous thirty days as a first mate.

He spent the night of March 29, 1968, and March 30, 1968, at the Waterways Marine in Memphis, Tennessee. The Waterways Marine is a store supplying boats coming up and down the Mississippi and has sleeping facilities for "on and off" crews.

On Sunday, March 31, 1968, he checked into the Linden Lodge Motel in downtown Memphis, Tennessee. On that same date, he had telephonically contacted KAY CONE in Boston, Georgia, who advised him that he had received a telephone call from the Mississippi Valley Barge Lines concerning employment. KEITH advised for this reason, he indicated his employer on the registration form provided him at the Linden Lodge Motel as the Mississippi Valley Barge Lines.

KEITH was passing time in Memphis, Tennessee, while awaiting additional employment on a tug or tow boat on the Mississippi River. He spent his days walking in the downtown Memphis area and watching television at the Linden Lodge Motel. Because a curfew was in effect in Memphis, Tennessee, during this period, he was in the Linden Lodge Motel by 7:00 p.m., each evening and never left the motel after that time. He stayed at the Linden Lodge Motel until he departed the Memphis, Tennessee area on April 6, 1968. He paid on a daily basis at the motel until April 3, 1968. He then began 'charging' his room on a daily basis. Because several expensive ties which he purchased in the downtown Memphis, Tennessee area were apparently taken from his room at the Linden Lodge Motel, he left without paying his room bill because they would not reimburse him for these ties. He has since contacted the Linden Lodge Motel and paid the board bill owed by him.

On April 4, 1968, he awoke and followed his usual practice of watching television in his motel room until about 11:00 a.m. He then went to a drugstore situated on the corner of Main and Linden Streets in Memphis and ate lunch. During each day that he

was in Memphis, Tennessee, and ate lunch, he ate lunch at this drugstore and always ordered chili and a pepsi cola. He then caught a bus to the east side of Memphis, Tennessee in the area of Rogers' Tennis Center. He got off of the bus near the medical district of Memphis, Tennessee, where several hospitals are located and walked the rest of the way to Rogers' Tennis Center. This was about 1:00 p.m. No one was playing tennis and he started back towards the downtown area. He ate a sandwich en route but does not recall the name of the restaurant. He walked down the same street on which the Memphis, Tennessee Western Union Office is located in the downtown area, name not recalled. but still on the east side of town. Near an overpass. he witnessed an automobile accident involving a 1968 Ford Thunderbird bearing Arkansas license plates and a 1964 Comet, four-door, and 1967 Cadillac sedan, both bearing Tennessee license tags. The two occurs The two occupants of the Comet were University of Tennessee medical students. No one was injured but the female driving the Thunderbird was given a traffic citation for running a red light. This was about 5:40 p.m. During investigation of automobile accident by officers of Memphis Police Department, one officer left his squad car and advised the persons involved in the accident, the other officers and bystanders standing at the scene that he had just received a radio message from his headquarters advising that Dr. KING had just been shot at his motel. KEITH stayed at the scene for about one hour after this. A problem arose concerning a wrecker and he advised the white female owner of the Thunderbird that a Ford Company garage was nearby inasmuch as he had just passed it. He pointed this garage out to the white female and suggested that she contact people at this Ford automobile agency concerning a wrecker.

About 6:30 p.m., he started walking again toward the downtown area and went through the used car lot of the above described Ford Dealership which was located near the accident scene. Several men appearing

to be salesmen were standing in this used car lot. asked him concerning the sirens which could then be heard in the Memphis area and KEITH informed them that he had been told by an officer investigating a wreck nearby that Dr. MARTIN LUTHER KING had been shot at his motel. KEITH continued walking on towards the downtown area and passed the Travel Lodge Motel and by the Greyhound Bus Station. He went to a pancake house located at the Downtowner Motel in downtown Memphis and inquired of the cashier if she had received any additional information concerning the shooting of Dr. MARTIN LUTHER KING. A customer seated nearby fadvised that he had heard a radio broadcast indicating that the person believed to have perpetrated the shooting was a white male wearing a moustache. Because KEITH was then wearing a bushy moustache, he left the pancake house and went to the desk of the motel and asked a white female attendant on duty who had red hair and was about 35 years of age regarding the shooting of Dr. KING and the reported radio dispatch that the perpetrator was a white male wearing a moustache. The desk attendant could not confirm this but furnished KEITH with directions to the downtown Memphis, Tennessee Police Station. KEITH advised that to go to the Linden Lodge Motel, he had to walk through a Negro section of Memphis. Tennessee and if the person believed perpetrating the shooting of Dr. KING was described only as a white male with a moustache, he wanted to know about it before he completed his return to the motel. KEITH arrived at the Memphis, Tennessee Police Department about 7:00 p.m. He heard then that MARTIN LUTHER KING, JR., had been pronounced dead. He stated there was a lot of excitement at the Police Department and one officer directed him to an office on the ground level from which he was directed to another office and from there to a desk sergeant who was on the ground level of the police station near the main entrance. On each occasion, KEITH advises that he informed the
