officer to whom he was directed that he was from out of town, was staying at the Linden Lodge Motel, and had hearda rumor that the person believed to have perpotrated the murder of Dr. KING was a white male wearing a moustache. He wanted to give the police department his name and address in the event they received any inquiries concerning him. No one took down his name and address, however, except the desk sergeant near the entrance of the police station who wrote his name and address on a piece of scratch paper.

KEITH then left the Memphis Police Department and walked down Main Street by the Chisa Hotel to the Linden Lodge Motel. He talked to the desk man on duty about the shooting of KING and watched television for the remainder of the evening until he retired. He never again left the Linden Lodge Motel.

On April 5, 1968, KEITH remained in the Memphis, Tennessee area and made several telephone calls to KAY CONE in Boston, Georgia, and to RICHARD L. BATEMAN, SR., aboard the "M-V-WILLIAM H. CRAIG". He ascertained that BATEMAN was scheduled to end his present tour of duty as captain of the above motor vessel at Cairo, Illinois, at 3:00 p.m., on April 7, 1968. KEITH made arrangments to obtain BATEMAN's automobile which was stored by him at the Waterways Marine Company in Memphis, Tennessee, and to drive it to Cairo, Illinois, where he would meet BATEMAN as he left the above motor vessel on April 7, 1968. He was then to accompany BATEMAN back to his Boston, Georgia residence.

On April 6, 1968, at about 10:30 a.m., he left the Memphis, Tennessee area in BATEMAN's automobile and drove to Madison, Illinois to meet his wife. They made arrangements to obtain a baby-sitter for their daughter and spent the night of April 6, 1968, at a motel in East St. Louis, Illinois, name not recalled, but situated at the intersection of Highways I-55 and 40.

On the morning of April 7, 1968, he took his wife back to their apartment and left for Cairo, Illinois. He arrived there about 4:00 p.m., and BATEMAN arrived about 7:00 p.m. He picked BATEMAN up as he left the tug boat and the two of them then drove directly to Boston, Georgia, stopping only for gas and to eat. They arrived in Boston, Georgia about 9:00 a.m., on April 8, 1968.

BATEMAN has since returned to a job captaining a tug boat on the Mississippi River. KEITH has continued his efforts to obtain employment and in the meantime has obtained a residence to rent in Thomasville, Georgia, and has been spending his time painting and cleaning up this residence. Subsequent to arriving in the Boston, Georgia area, he has shaved off the moustache he was wearing while in the Memphis, Tennessee area during the above mentioned period. The names ERIC STARVO GALT, HARVEY LOWMYER, JOHN WILLARD are unknown to him.

KEITH consented to be photographed and fingerprinted for elimination purposes with respect to investigation being conducted into the murder of MARTIN LUTHER KING, JR.

The following investigation was conducted by SA M. ROBERT MC FARLAND:



On April 17, 1968, Chief of Police WAYNE I. WILSON, Boston, Georgia, advised that a white male fitting KEITH's description arrived in the Boston, Georgia area about two weeks ago and has been staying at the residence of a RICHARD L. BATEMAN, SR., in Boston, Georgia. This white male

has been driving a 1968 Ford Torino automobile. Nothing concerning this individual is known to WILSON. He has shaved off his moustache within the last couple of days.

On April 17, 1968, MARLINA KAY CONE, nee BATEMAN, was contacted at the residence of RICHARD L. BATEMAN, SR., in Boston, Georgia, where she is residing. CONE advised that she is the niece of BATEMAN, SR., and is presently separated from her husband, CHARLES WILLARD CONE, who resides and is employed in Auburndale, Florida.


CONE advised that LARRY KEITH is known to her as a white male who brought her uncle from Cairo, Illinois, to Boston, Georgia, on April 8, 1968, after he had completed duty on a tug boat on the Mississippi River. BATEMAN, SR., has, for several years, been employed as a tug boat captain on the Mississippi River. KEITH has been staying at the BATEMAN residence since that time though R. L. BATEMAN, SR., has returned to duty on the Mississippi River. KEITH is supposedly an old acquaintance of BATEMAN, SR., and is apparently known to the BATEMAN family. CONE's first contact with KEITH came by way of a telephone call from Memphis, Tennessee, on the day following the murder of Dr. MARTIN LUTHER KING, JR., believed to be April 5, 1968. KEITH requested the telephone number of BATEMAN, SR., indicating that he wanted to contact him. CONE furnished KEITH with the number of the Marine Operator by way of which BATEMAN, SR., could be reached and advised KEITH that he was presently on board the tug boat WILLIAM H. CRAIG. CONE stated that KEITH called again the next day and wanted CONE to send him some money, so that he could go to Illinois to pick up BATEMAN, SR., and return him to the Boston, Georgia area, when he had completed his present trip aboard the WILLIAM H. CONE informed KEITH that such would not be possible without the approval of BATEMAN, SR., inasmuch



as he had previously advised her that he was returning to Boston, Georgia, by commercial airliner from Cairo, Illinois, after he completed this trip. KEITH telephonically producted CONE on the following day, which would be Saturday, April 7, 1968, and informed her that he had talked to R. L. BATEMAN, SR., and that he had given authority for CONE to forward KEITH money. CONE then wired \$50 to Western Union, Memphis, Tennessee, in care of a ROBERT NNUGENT which is the name KEITH asked her to use in wiring the money. CONE did not know why KEITH asked that the money be wired in this name. On the following Monday, April 8, 1968, KEITH arrived in Boston, Georgia, with RICHARD L. BATEMAN. SR.

CONE has little contact with KEITH and knows little about him. He comes and goes as he pleases and has never mentioned money problems to her. He occasionally buys grocery for the household and has indicated to her that he is married and has a child. He supposedly recently rented a residence in Thomasville, Georgia, and has indicated to CONE that he plans to bring his wife and child to the Thomasville, Georgia area as soon as his child completes this term of school. The address of the residence in Thomasville, Georgia, which KEITH supposedly has rented, is unknown to CONE.

To CONE's knowledge, KEITH is supposedly also a tug boat employee and has reportedly been employed on numerous occasions by her uncle, RICHARD L. BATEMAN, SR., whom KEITH has indicated got him his first job on a boat. KEITH has made several calls in an attempt to obtain employment in the recent past but to CONE's knowledge, has been unsuccessful to date. He has also been dating a waitress, name unknown, who is employed at the Cherokee Restaurant in Boston, Georgia. When KEITH first arrived in the Boston, Georgia area, he was sporting a bushy moustache but has shaved same off in the last few days.



The following investigation was conducted by SA M. ROBERT MC FARLAND at Boston, Georgia:

On April 19, 1968, LARRY KEITH was contacted at the residence of RICHARD L. BATEMAN, SR., in Boston, Georgia. Photographs of JAMES EARL RAY were exhibited to KEITH and he was furnished with RAY's descriptive data and known aliases. KEITH advised that RAY is unknown to him as anyone he has ever seen or heard of.

Investigation subsequently conducted by above Agent and SA ROYAL A. MC GRAW at Boston and Thomasville, Georgia, on April 21 and 22, 1968, determined that LARRY KEITH is ROBERT LEE NUGENT. The 1968 Ford Torino being driven by NUGENT in the Boston and Thomasville areas is the subject of a stolen report out of Memohis. Tennessee, on April 6, 1968. In signed statement. NUGENT admitted the theft of this automobile and its subsequent transportation to Boston, Georgia. NUGENT advised that the name LARRY KEITH is a name frequently used by him. He advised that the rest of the information furnished concerning his activities in the Memphis, Tennessee area at the time of the KING assassination is accurate. NUGENT is presently incarcerated in the custody of the United States Marshal, Macon, Georgia, following his arrest and arraignment on Interstate Transportation of Stolen Motor Vehicle charges for the theft and interstate transportation of the above 1968 Ford Torino from Memphis, Tennessee to Boston, Georgia. His incarceration is in lieu of bond on these charges.




