Prior to receipt of reBuairtel, the New Orleans Division on 5/31/68 contacted Mr. NAURBON PERRY, Group Supervisor, Intelligence, Internal Revenue Service, New Orleans, exploring the feasibility of obtaining information from TCR-1 Forms.

PERRY stated that his office receives these forms through the Federal Reserve Bank and they come from banks all over the Gulf Coast, including Mobile, Alabama. He stated cooperation with regard to completing a TCR-1 Form is for the most part voluntary on the part of the banks. The regulations regarding the TCR-1's completion are handled by the Comptroller of Currency and he pointed out that most banks do not follow these regulations to the letter.

PERRY stated he was specifically prohibited by Statute from disclosing information from the TCR-1 Form, and that he would not be able to disclose this information without the specific permission of the Commissioner of IRS.

RAYMOND LOUIS CURTIS, who is confined in the Whitfield County Jail, Dalton, Georgia, advised he did not personally serve time with JAMES EARL RAY in the Menard Prison, Illinois, and the only information he has regarding this is what RAY told him. This information was related to him by RAY while he and RAY were serving time together in the Jackson County Jail, Kansas City, Missouri, for a six or seven month period.

He stated he never heard RAY say that he had served time in Joliet or Pontiac Prisons, but he felt that if RAY had served time in either one of those places, he would probably have been shipped to Menard Prison for discharge.

CURTIS advised there was a close associate of RAY's serving time in Jackson County with them. He cannot recall the name of this individual, but stated he was convicted as a co-defendant with RAY on the same check charge and from conversation with RAY, this individual was presumably the same person with whom RAY served time in Menard Prison.

CURTIS advised he recalls a third unidentified individual visiting RAY and his co-defendant in Jackson County Jail who seemed very close to both of them, but stated he strongly doubted that the visitor's log maintained at the Jail would reflect the name of this visitor due to irregularities in keeping such logs.

He advised he could not furnish a description of the third man.

CURTIS advised he was confined in the Jefferson County Jail with RAY and his co-defendant from approximately March of 1955 until July of 1955, and that they all subsequently ended up together in Leavenworth Prison.

On 4/25/68, RICHARD E, CARLISLE, Station Attendant, Super Test Station, Canton, Route 5, Woodstock, Georgia, advised that HENRY PROBUS, Route 2, Canton, Ga., is the night attendant at the service station, working from 10:30 p.m., to 7:30 a.m. CARISLE stated that PROBUS has no home phone and has been travelling each day to Jasper, Ga., after completion of his work in the morning, to see his father-in-law who is dieing with cancer.

Attempts were made at the abover service station on 4/30/68 and 5/2/68, to contact PROBUS with negative results. On 5/7/68, it was determined that PROBUS! father-in-law had died and he was expected to be in Jasper, Ga., for a few days.

On 5/15/68, PROBUS was interviewed at Route 2. Cantony Georgia, by SA's HUGH ROBINSON, JR. and JOSEPH G. SHEA at which time he advised that on the morning after the FBI recovered the Mustang of the man who was believed to be the murderer of Reverend KING, and while he was working at the Super Test Oil Company Station, Casten Highway, Woodstock, Ga., a cattle truck pulled into the station to get some gas. There were several cars at the station receiving gas, and PROBUS said he was very busy taking care of the customers. When he got around to filling the truck of the cattle hauler, the man mentioned to him that within the past 10 to 15 minutes, three Regross had driven into the station and let a white man out of their car. The white man thereafter went to the telephone inside the station and placed a call. The cattle truck driver advised he overheard some of the convergation and the man was calling for a Mrs. TAYLOR, and a trailer court in the Woodstock, Ga., area was mentioned. The cattle truck driver stated that

PROBUS advised that he never saw the white man referred to by the cattle truck driver and he does not know the name of the cattle truck driver and did not know whether he would ever visit the station again..

In view of the non-specific details of this complaint received by Complaint Clerk JERRY D. On 4/22/68, Mrs. MIRIAM HARKINS, Mableton Mail newspaper, Mableton, Georgia, was contacted regarding an anonymous telephone call received by her regarding the captioned matter. Mrs. HARKINS stated that it was her first day of work, 4/17/68, at the Mableton Mail newspaper and she was not familiar with the voices of anyone calling the newspaper. She stated that a woman telephoned and began talking about a white Mustang. Mrs. HARKINS believes that the woman was talking about a car that was to be sold and would be contained in the advertising section of the paper. The woman kept talking, and Mrs. HARKINS then realized that the woman was talking about the white Mustang that had been recovered in Atlanta, Georgia, and was alleged at that time to have been driven by the murderer of Reverend KING. woman only stated that she knew the identity of the person who was wanted for the murder, and indicated that he resided in Mableton, Georgia, and drove a white Mustang. The woman hung up without identifying herself. Mrs. HARKINS advised that from the voice of the woman, it would appear she was in her 50's and was a white woman.

Mrs. HARKINS has been recontacted on 4/30/68; 5/6,10,16, and 22/68, and stated that she has never been recontacted by the anonymous woman caller regarding the white mustang.

In view of the above, no further investigation is going to be conducted in this matter, and Mrs. HARKINS has stated that should she be recontacted by the anonymous caller she would immediately contact the FBI. 44-2386-2041



BRUCE IRWIN GOVERN was interviewed at the Marin County Jail on May 20, 1968. GOVERN stated that the letter set out above was given to him by an inmate while he was confined either at the San Francisco County Jail or the San Francisco City Jail. He stated the letter was given to him about three weeks ago by a young inmate known to him only as TOM. He said he had not known TOM before, did not know why he was then in jail, and knew nothing about his background. GOVERN stated he was still in the San Francisco Jail when TOM was released on bail and that he has not seen or heard from TOM since. GOVERN stated following his release from jail he obtained certain telephone numbers listed in the letter by calling the Information Operator.

The files of the San Francisco Office indicate that GOVERN is the subject of San Francisco file 25-67044. This file indicates that GOVERN's Selective Service Number is 33-46-45-23 and that he was declared delinquent by his draft board for failure to report for induction on September 8, 1965. GOVERN was arrested by Agents of the San Francisco Office on February 23, 1968, was given a physical examination on February 28, 1968, and on that date was disqualified at the Induction Center for medical reasons, one of these reasons being that he was a user of heroin.

On May 29, 1968, GOVERN was reinterviewed at the Marin County Jail. GOVERN advised he was in the San Francisco Jail from about April 15, 1968, to April 24, 1968. He insisted that the letter referred to was given to him by a person who he knew as TOM. GOVERN stated he was confined to a cell with TOM for about seven days but did not speak to him until his last two days in jail. He advised that both he and TOM were released from City Jail on the same day. GOVERN stated he did not know JAMES EARL RAY and had never seen him. He stated he had seen pictures of RAY in the newspapers.

He advised that on the letter his hand-printing appeared on Page 1 when he wrote the telephone number 404-688-7263 regarding the Ebenezer Baptist Church and on Page 3 when he wrote the telephone numbers 527-6611, 526-8811, and 516-2141. He advised that the telephone number 404-688-7263 was the telephone number of the Ebenezer Baptist Church in Atlanta, Georgia, and he obtained this number by calling Atlanta Information.

He advised he has no knowledge as to the identity of the subscriber to telephone number 221-6201 which appears on the first page of the letter. He advised that the name ROBERT LAWRENCE appearing on Page 1 is unknown to him. GOVERN stated that the rifle used to kill MARTIN LUTHER KING was the same rifle that killed President JOHN F. KENNEDY. When asked to elaborate on this

SF 173-65 MTG/sms remark he stated, "You guys know that and there is no sense in me telling you anything about that." The telephone number 415-324-1130 is a San Francisco telephone number. Inquiry at this number reflects that LARRY YOUNG resides there. YOUNG advised that he would contact the San Francisco Office this date. ROBERT MOORE, San Francisco Police Department, Star 1648, San Francisco City Jail, on May 31, 1968, advised that BRUCE IRWIN GOVERN was arrested and confined to the San Francisco City Jail on April 16, 1968, and was bailed out on April 19, 1968. MOORE stated that a review of the records reflected that the only "TOM" that was discharged on April 19, 1968, from the City Jail was THOMAS LYNCH who was confined on April 17, 1968, and was released on April 19, 1968. He advised LYNCH was confined to cell block "L" whereas GOVERN was in Dormitory 3. THOMAS PATRICK LYNCH, 116 Frederick Street, Apartment 29, San Francisco, California, on May 31, 1968, stated he does not know anyone by the name of BRUCE IRWIN GOVERN. He observed photographs of GOVERN and stated that he did not recognize this individual as being identical with anyone that he knows. He stated he was arrested on a narcotics charge and that he was kept separate from the rest of the prisoners in the jail. LYNCH observed photographs of JAMES EARL RAY and stated he did not know RAY and that he had never seen him. LYNCH advised that he had not given GOVERN the four-page letter which GOVERN said he had obtained from "TOM." LYNCH stated he had been shocked at the death and the manner of the death of Dr. MARTIN LUTHER KING and that he had not written this note and that he would not have anything to do with any such scheme as this seems to be. LARRY YOUNG, 974 Weeks, Palo Alto, California, on June 3, 1968, advised he was confined at the San Francisco City Jail from about April 6, 1968, to April 13, 1968. He advised that a white man by the name of LAWRENCE who was in the "tank" with him gave him a letter which was already sealed and asked him to mail it when he got out. YOUNG stated this letter was addressed to MARTIN LUTHER KING, SR. YOUNG stated he does not know the contents of the letter. YOUNG stated he did not know GOVERN.
