I understand and know what I am doing. No promises or threats have been made to me and no pressure or coercion of any kind has been used against me.

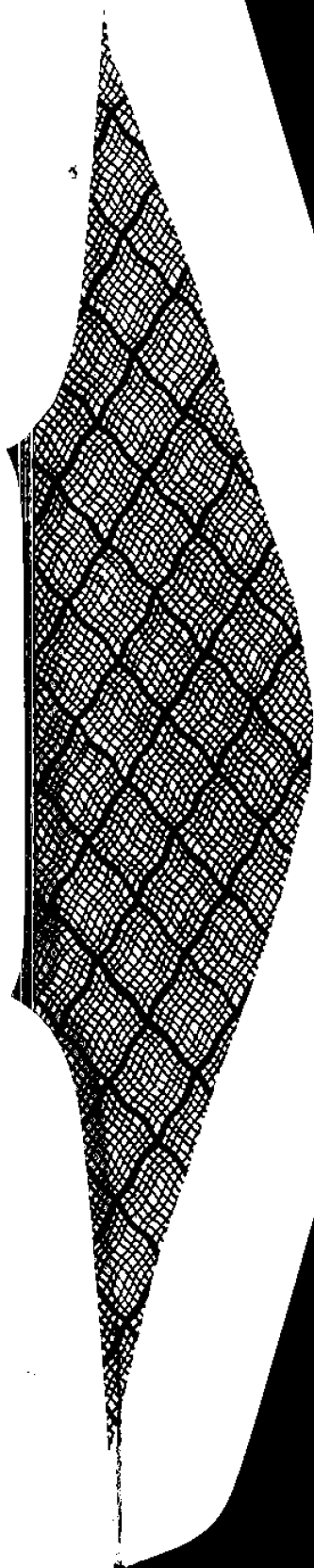
