At General Delivery, it was observed there was a large manilla envelope addressed to ERIC GALT, 9533 Hollywood Boulevard, Hollywood, California 90028. This was crossed out and in turn had been forwarded to General Delivery in Atlanta, Georgia. There is no postmark on the letter, but it is stamped on the reverse side 4/13/68, in Hollywood. The letter appears to contain a regular size sheet of paper and a ~~small~~ booklet; ~~its~~ address as HEW, Social Security Administration, Baltimore, Maryland.

The Bureau, to this point, has developed very limited background information on GALT.

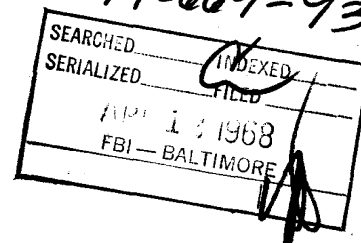

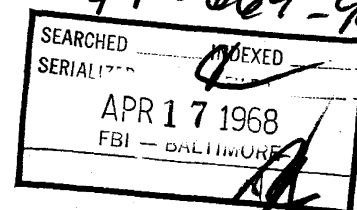
