On April 8, 1968, former Federal Bureau of Investigation Special Agent Birl Wilson, now at Liberty National Bank, Buffalo, New York, brought to the attention of this Office background data concerning one Dr. Alvin Eugene French, who is being sought by various banking institutions in Western New York for passing bad checks and use of credit cards on closed accounts.

Investigation by bank officials indicate that Dr. French was in Memphis, Tennessee on April 5, 1968 and indicated to a girl friend in Rochester, New York that he was going to Atlanta, Georgia, where he would confer with some Negro people, whom he said were successors to Dr. Martin Luther King, Jr.

Further investigation by bank officials has established that Dr. French is now in Atlanta, Georgia, and staying in Room 466, Airport Holiday Inn, and intends to remain there through April 10, 1968.

Dr. French reportedly served as a Missionary in Africa some years ago, where he contracted brain fever. He has served as a part-time Psychiatric Consultant at Gowanda State Hospital, Gowanda, New York, and has been a mental patient at that institution; and subsequently, at the Rochester State Hospital, Rochester, New York. He left the latter institution in September, 1967. He was at one

time self-employed as a physician in Collins, New York.

Dr. French was born in Indiana on August 12, 1927, is white, and is described as being 5'10" in height, and 170 to 180 pounds in weight.

His presence in Memphis, Tennessee on April 5, 1968 makes him a possible suspect in the assassination of Dr. King and his presence in Atlanta, Georgia, together with his past history of mental illness, is believed to be a matter of concern to Secret Service, in view of the possible presence of Fresident Johnson at the funeral service of Dr. King in Atlanta, Georgia on April 9, 1968.

The foregoing information, together with all available background data concerning Dr. French has been furnished to Federal Bureau of Investigation Headquarters and to Federal Bureau of Investigation Offices in Memphis, Tennessee and Atlanta, Georgia.

This is being brought to your attention for appropriate action.



BUREAU HAS FURTHER ADVISED THAT ALL INVESTIGATION MUST BE HANDLED UNDER THE PERSONAL SUPERVISION OF THE SAC. LEADS ARE TO BE AFFORDED IMMEDIATE, THOROUGH, IMAGINATIVE ATTENTION. ALL POSSIBILITIES FROM SUCH LEADS MUST BE EXHAUSTED AS ANY ONE LEAD COULD RESULT IN SOLUTION OF THIS MOST IMPORTANT INVESTIGATION.
