LOS ANGELES, MAY 3 (NANA)--THE SEARCH FOR THE SLAYER OF DR. MARTIN LUTHER KING JR. IS MORE THAN A MANHUNT FOR JAMES EARLE RAY, ALIAS ERIC STARVO GALT. FOR THE SEARCH IS THAT OF A TROUBLED NATION TRYING TO LOCATE ITS SOUL, OF A REPUBLIC IN SEARCH OF ITS OWN VALUE SYSTEM.

PRESIDENTIAL ASPIRANT HUBERT HUMPHREY CAME CLOSE TO THE TRUTH A FEW DAYS AGO WHEN HE SAID WE ARE NOT LOST, THAT WE ARE A NATION GROWING UP AND TRYING TO FIND BETTER WAYS. THE ASSASSINATION OF DR. KING HAS INTENSIFIED THE SEARCH FOR BETTER WAYS AND I SUSPECT THERE WILL BE A GOOD DEAL OF FOUNDATION SHAKING, IN HIGH PLACES AT THAT, BEFORE THE ENTIRE MATTER IS PUT TO REST.

I AM SPEAKING SPECIFICALLY OF THE FEDERAL BUREAU OF INVESTIGATION AND ITS DIRECTOR, J. EDGAR HOOVER.

"MOST NOTORIOUS LIAR"

IT IS OPEN PUBLIC KNOWLEDGE THAT HOOVER DEEPLY DISLIKED MARTIN LUTHER KING. HE ONCE REFERRED TO KING AS "THE MOST NOTORIOUS LIAR IN THE NATION." NOW HOOVER IS CALLED UPON TO LOCATE KING'S ASSASSIN.

THERE ARE A FEW BLACK PEOPLE INDEED WHO BELIEVE HOOVER WILL WORK OVERTIME IN THIS SEARCH. THE FEELING IS NOT WITHOUT SOME FOUNDATION; EITHER THE FBI IS INEPT OR THE BUNGLING OF THE KING CASE IS INTENTIONAL.

THE FBI ISSUED A REPORT THAT JAMES EARLE RAY TOOK DANCING LESSONS IN NEW ORLEANS IN 1964-65. THE FBI'S OWN FILES SHOW THAT RAY WAS IN PRISON AT THE TIME.

. SHORTLY AFTER I DISCOVERED TELEPHONE BOOTHS IN LOS ANGELES FROM WHICH RAY ALLEGEDLY MADE PHONE CALLS, THE FBI MOVED IN AND CONFISCATED THE TELEPHONE COMPANY RECORDS. THEY AND ONLY THEY KNOW WHAT THOSE RECORDS REVEAL.

BLACKS DON'T TRUST HOOVER

LET ME MAKE IT PLAIN, VERY PLAIN: AMERICA'S BLACKS NEVER HAVE AND DO NOT NOW TRUST EITHER J. EDGAR HOOVER OR THE FBI. THOSE OF US WHO HAVE BEEN ASSIGNED TO COVER CIVIL RIGHTS STORIES IN THE SOUTH KNOW ALL TOO WELL HOW MUCH THE FBI CAN FUMBLE WHEN IT DOES NOT WISH TO SOLVE A CASE.

THE MURDER OF DR. KING WAS AN ORGANIZED AND WELL PLANNED EXERCISE. THIS WAS NOT THE DEED OF "SOME WHITE NUT." RATHER THERE IS A SENSE IN WHICH SOCIETY ITSELF COMMITTED THE ACT; AND IT IS CERTAIN THAT POWERFUL MEN IN AMERICAN SOCIETY WERE PART OF THE DEED MOST FOUL.

UNLIKE CAESAR'S WIFE, J. EDGAR HOOVER IS NOT ABOVE REPROACH WHEN IT COMES TO THE CIVIL RIGHTS ISSUE. LET MR. HOOVER THEN CLEAR THE AIR BY EITHER REMOVING HIMSELF FROM THE INVESTIGATION OR SHARING THE HUNT WITH MEN AND ORGANIZATIONS THAT COMMAND THE FAITH OF THOSE WHOSE CAUSE KING CHAMPIONED.

On the afternoon of 5/13/68, New York State Parole Officer TED DUKE, with whom the writer has had slight contact on other matters; telephonically advised that one of the State parolees assigned to him named GERALD METZGER, white male, had been arrested on 4/30/68 by the Town of Amherst PD as a parole violator. METZGER had initially been found guilty in New York State as a YO in a stolen car case, and has 13 months of "bad time" to complete.

DUKE related that at the time of GERALD METZGER's most recent arrest, he was staying at 109 Glenalby Road in the Town of Tonawanda, New York with a friend named WILLIAM WATERS.

DUKE stated that he was calling for two purposes, based upon interview he had had earlier that day with GERALD METZGER, and with METZGER's stepfather, the latter named RAY OTTO METZGER (DOB 2/21/14), who resides at 56A Glenwood Court, Maryvale Project, Cheektowaga, New York, telephone number 896-0423. The names on the mailboxes were: "JENNIE PATURZO" for the downstairs apartment and "JOSEPHINE ALDRICH" for the upstairs apartment.

No one answered downstairs.

In the upstairs apartment, a woman, who identified herself as JOSIE ALDRICH, answered the door. She advised she lives upstairs with her father, who is elderly, and no one else lives with them. She said the downstairs premises is occupied by the owner of the house, Mrs. JENNIE PATURZO, who lives there alone and works days.

Photographs of RAY were exhibited to Miss ALDRICH, who said she did not recognize him by name or any of his aliases, photographs, or description. She knew of no one by the name of JAMES RAY living in this neighborhood.

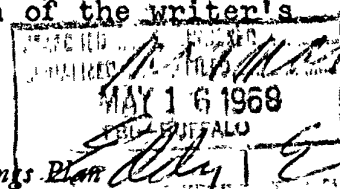

"TEN MOST WANTED FUGITIVES" PROGRAM

James Earl Ray, a Missouri prison escapee who has been sought under the alias Eric Starvo Galt in connection with the gunshot slaying of civil rights leader Dr. Martin Luther King, Jr., has been added to the FBI's list of "Ten Most Wanted Fugitives."

FBI Director J. Edgar Hoover ordered the special addition of Ray to the "Ten Most Wanted Fugitives" list, which already contains ten fugitives, to insure the widest possible dissemination of Ray's photograph and description to help effect his earliest possible location.

Ray has been the subject of a massive and intensive search since the brutal gunshot slaying of Dr. King on April 4, 1968, as he stood on the balcony of a Memphis, Tennessee, motel. One rifle bullet, believed fired from the window of a nearby rooming house, felled the victim.

An exhaustive FBI fingerprint search, comparing latent fingerprints uncovered in the Dr. King case against

fingerprints of over 53,000 persons on whom wanted notices have been posted in the FBI's Identification Division, succeeded in determining that Galt and Ray are identical.

A Federal warrant, issued at Birmingham, Alabama, on April 17, 1968, charges Ray, under the alias Eric Starvo Galt, with conspiring to interfere with a Constitutional Right of a United States citizen. Ray is also sought for unlawful interstate flight to avoid confinement after conviction for armed robbery, based on a Federal warrant issued on July 20, 1967, at Jefferson City, Missouri. He had been confined at the Missouri State Penitentiary, Jefferson City, Missouri, in March, 1960, with a 20-year sentence following conviction for armed robbery and operating a motor vehicle without permission of the owner. In September, 1966, while serving the sentence, he was confined for a time in the maximum security ward at the State Hospital, Fulton, Missouri. He was reported missing from the Missouri State Penitentiary since April 23, 1967.

Ray who has an arrest record dating back to 1949 and has been convicted of burglary, armed robbery and forging United States Postal Money Orders, has also

been confined in the Los Angeles County Jail, the Joliet and Pontiac, Illinois, State Prisons and the United States Penitentiary, Leavenworth, Kansas.

He served in the Army between February, 1946, and December, 1948, received a three-month sentence at hard labor for being drunk and breaking arrest and was given a General Discharge due to ineptness and lack of adaptability for military service.

Ray is a 40-year old white male, reportedly born in Illinois on March 10, 1928. He is approximately 5' 10" tall, weighs from 163 to 174 pounds, has blue eyes and brown hair which he has worn cut short. He has a small scar on the center of his forehead and a scar on the palm of his right hand. He has been described as having a straight, narrow nose and straight and even teeth and to have a nervous habit of occasionally tugging at an ear lobe. His left ear protrudes noticeably.

Acquaintances describe him as a "loner" and "drifter" whose language and diction reflect a "rural" quality and indicate he has had limited education.

He is reportedly a fan of western and country music, drinks vodka and beer, dresses neatly and claims past employment as a merchant seaman and cook on Mississippi River vessels. He is known to have worked

as a baker, laborer and color matcher.

He is known as an avid dancer who has taken dancing lessons. He also completed a course at a school of bartending in the Los Angeles area early in 1968.

Ray should be considered armed and extremely dangerous. Anyone with information concerning this fugitive is requested to immediately contact the nearest office of the FBI, the telephone number of which may be found on the first page of local telephone directories.

PRI advised that the memorial services held in Elmira for KING, as well as the two orderly memorial marches held, all had a large percentage of white involvement. He stated that he understands that the local chapter of the NAACP benefitted by a surge in membership shortly after KING's assassination.

PRI stated that he believed that the fact that there was no violence, looting or other unlawful acts following KING's death, as there were in other cities, spoke well for the Elmira communities' chances of avoiding any civil disorders during the coming summer.

PRI stated that the Elmira-Corning NAACP chapter is planning to take a busload of people to Washington, D.C. on 5/29-30/68, and is now actively ~~recruiting in~~ recruiting people in this area to go to D.C.

PRI stated WAYNE DUNHAM, a Negro speech therapist teaching in the Corning, N.Y. public school system, and active in the local NAACP chapter, is actively recruiting for this trip as is the Rev. WILLIE J. WRIGHT, Negro Pastor of the Elmira Monumental Baptist Church. PRI stated that the NAACP is also attempting to get contributions to underwrite costs of this one day trip from individuals, local industry, and area service organizations.

PRI stated that he heard that there are approximately 40 persons already signed up to go on this trip, which plans to leave Elmira on the evening of 5/29/68, and remain in D.C. until about 6pm, 5/30/68, when they'll come back to Elmira. He did not know what bus line was providing the chartered bus or busses.

PRI was exhibited photographs of JAMES EARL RAY on both 4/22/68 and 5/14/68, without effecting any identification. Notation of this negative contact furnished the MURKIN file by separate communication.

PRI stated that he has recently received word of firm commitments concerning funds available for a variety of Neighborhood Youth Corps jobs and activities this coming summer in Elmira, and he has every hope that he and his staff will be able to really keep the Negro youths gainfully occupied throughout the summer months when the threat of civil disobedience is the greatest.

5/14/68

PRI stated that he has learned that a number of youths in Elmira plan to travel to Washington, D.C. on the evening of 5/29/68, via bus, to participate in the Poor People's Campaign being held there by SCLC. He advised this is planned to be a one-day trip and the drive for necessary funds and recruits to go is being spearheaded by the Elmira-Corning chapter of the NAACP.

PRI stated that the only person he knows who is actively recruiting people to go on this bus trip is WAYNE DUNHAM, who is a speech therapist for the Corning, N.Y. public school system and very active in the NAACP. He advised DUNHAM worked last summer for the Neighborhood Youth Corps, and in all probability will be working agains this coming summer in some capacity for the Neighborhood Youth Corps. PRI considers DUNHAM a civil rights activist, but not a militant one, and not a Black Nationalist.

PRI stated he would remain alert to further information concerning this planned bus trip to participate.

PRI was exhibited photographs of JAMES EARL RAY and the MURKIN case was discussed with him on each of these contacts, but he was unable to furnish any pertinent information. Notation of these negative contacts have been furnished the MURKIN file by separate communication.
