At 9:05 a.m., 4/5/68, SA HOWARD TETEN, Memphis Office, called with regard to Birmingham investigation to trace the Remington rifle at Wimberly & Thomas Hardware Company (W & T), Birmingham. SA TETEN advised Mr. DeLOACH at the Bureau had instructed that it is imperative that Mr. JOE BIDDLE at W & T not furnish information concerning this rifle to anyone except the FBI. He further stated that the Memphis Office needs the information on the rifle as soon as it can be obtained.

This information was immediately furnished to SAC GAMBLE and thereafter at 9:15 a.m., SA NETL P. SHANAHAN, who is conducting investigation on the rifle, was contacted by telephone. He advised that he had already left W & T and had informed Mr. BIDDLE that he should maintain inquiries and information concerning the rifle in confidence. I instructed SA SHANAHAN that he should immediately call Mr. BIDDLE and instruct him not to disclose either FBI inquiries or information concerning the rifle to anyone other than the FBI. I informed SA SHANAHAN that Mr. DeLOACH had instructed that this is imperative. SA SHANAHAN stated he would immediately call Mr. BIDDLE and advise him of this effect.

SA SHANAHAN was also instructed not to disclose to any persons contacted concerning the rifle the reason for our inquiry on the rifle.

SA SHANAHAN stated he had learned at W & T that the rifle had been sold to AEROMARINE in Birmingham and he was then en route there to obtain further information.

At 2:10 p.m., 4/5/68, Mr. CLEM McGOWAN of the Bureau called and gave the following additional instructions:

In view of the fact that suspect LOWMEYER went to AEROMARINE on Friday and then went back again on Saturday, there is a possibility that he lives in Birmingham or, if not, he may have stayed at a hotel or motel.

Therefore, motels and hotels should be checked in the Birmingham area for the name LOWMEYER and variations of that name, LOHMEYER, etc. *1/1/68*

In addition, the Mobile Office should be requested to check on driver's licenses and car registrations in the name of HARVEY LOWMEYER and variations.

SA's BUTLER, JANSEN, MARTIN and SCHWEIN were immediately instructed to begin checking motels and hotels in the Birmingham area for the name HARVEY LOWMEYER and variations for the dates of 3/27, 28, 29 and 30/68. They were instructed that under no circumstances are they to disclose the reason for the Bureau's interest in LOWMEYER. SA BUTLER was placed in charge of the check of motels and hotels.

At 2:30 p.m., I telephonically contacted SA CLIFF ROWE in the Montgomery RA. He was requested to check the State Bureau of Motor Vehicles for a driver's license or car registration in the name of HARVEY LOWMEYER and variations. He was furnished LOWMEYER's description and the false address given by LOWMEYER. He, too, was advised that the reason for the Bureau's interest should not be disclosed. He was also instructed that if anything of value was found, Mr. CLEM McGOWAN at the Bureau and the Memphis Office and Birmingham should be immediately advised telephonically.

The following investigation was conducted 4/5/68 with reference to the name HARVEY LOWMEYER, with the address listed as 1907 South 11th Street, Birmingham, Ala.

City directories reflect the above address is occupied by Mrs. VIRGINIA B. JENKINS, residence telephone 252-1249 and also listed to W. A. JENKINS. The latter resides, according to suburban directory, at 3128 Warrington Road, Mountain Brook, telephone 967-2378.

JENKINS has been an acquaintance for many years and was formerly a Judge in the Jefferson County Circuit Court and is entirely reliable.

He was interviewed in his office, 302 Frank Nelson Building. Judge JENKINS related that the address, 1907 11th Street South, has been occupied by his mother, Mrs. VIRGINIA B. JENKINS, for over 30 years and she being a widow has lived alone for the past several years. At the present time she is in St. Vincent Hospital undergoing treatment so the house is vacant at the moment. He stated definitely that the name HARVEY LOWMEYER means nothing whatsoever to him and he has never heard of any such individual. In the presence of Agent he telephonically contacted his mother at St. Vincent Hospital and determined also that she has never heard the name HARVEY LOWMEYER in any way. Both advised also that reliable neighbors occupy the residences adjoining Mrs. JENKINS's home and that no one in the neighborhood has ever been known by that name.

On 4/5/68, the Memphis Division telephonically advised SAC, Birmingham Division, that a laundry mark had been found on the tee shirt and shorts in a suitcase belonging to the unknown subject in this matter.

This laundry marking consisted of a red tape which was ironed or stuck on the garments, and was described as  $\frac{1}{4}$ " in width and 1 and  $\frac{1}{16}$ " long containing black numbering on the tape, bearing the numbers 2B-6 or 02B-6.

On 4/5/68, SA DAVID T. DALY contacted all laundries listed in the Birmingham, Alabama telephone directory regarding this marking with negative results.

It was determined that this marking was one produced by a thermo-seal machine manufactured by the Textile Marking Company of Syracuse, New York.

On 4/5/68, SA ROBERT RAY, Syracuse, New York Resident Agency, telephonically advised that he had contacted the Textile Marking Company of Syracuse, New York, and had been advised that they were the only manufacturer of the thermo-seal machine which produced a marking  $\frac{1}{4}$ " in width, however, the length was either 1 and  $\frac{1}{8}$ " or 1 and  $\frac{5}{16}$ ".

SA RAY advised that the Textile Marking Company furnished the following listing of the operators of the thermo-seal machine within the State of Alabama:

RECORDS SOUTHERN AIRLINES, BIRMINGHAM, SHOWS THAT ONE W.J. LEHMEYER MADE TELEPHONIC RESERVATION AT BIRMINGHAM FOR TRAVEL ON MARCH TWENTY SEVEN SIXTYEIGHT FROM BIRMINGHAM TO MINNEAPOLIS, MINNESOTA. HE WAS TO CHANGE PLANES AT MEMPHIS, TENNESSEE AND AT CHICAGO, ILLINOIS, HOWEVER, LEHMEYER NEVER APPEARED FOR FLIGHT AND GAVE PLACES OF CONTACT BIRMINGHAM AS PARLIAMENT HOUSE AND AIRPORT MOTELS. At 9:50 A.M., 4/6/68, CLEM MC GOWAN, Chief, Civil Rights Section, Bureau, telephonically advised Birmingham has been sending numerous communications to the Bureau concerning captioned matter under improper titles which has resulted in improper routing and delays in handling at the Bureau. He requested all material sent in concerning this investigation be captioned appropriately.

During the conversation, MC GOWAN requested specifics with respect to investigation being conducted in Birmingham, and when I pointed out our investigation was being handled discreetly, he advised the policy is to conduct a full open investigation without any qualifications because, as he pointed out, the sooner this matter is solved the quicker the rioting in the cities around the country will be reduced. I pointed out we were working on all phases of the investigation and since he has given this policy, there will be no attempt to keep the investigation from the news media.

During the discussion with MC GOWAN, I was given the clear impression that there is no reason to withhold any inquiries we desire to make or to be concerned about any leaks to the press. The only concern the Bureau apparently has, or did have, with respect to this investigation was the fact the Bureau received information from outside sources about the tracing of the rifle before Bureau channels of communication gave Bureau officials the full picture.
