Mr. O. W. CURETON, Timekeeper and Foreman,
Broyles Yard, L & N Railroad, Birmingham, Alabama,
advised that RICHARD EVANS, JR., regularly works Saturday
through Wednesday and is off on Thursday and Friday.
He stated according to his time records, EVANS worked
on March 16, 17, 18, 19 and 20, 1968, was off March 21,
22, 1968; worked March 23, 24, 25, 26, 1968, and was off
March 27, 1968. According to records, EVANS requested to
be off on March 27, 1968. EVANS was off March 28, 1968,
but worked on March 29, 1968, which was a regular off
day but he was called into work as another man was sick on
that day. EVANS worked March 30, 31, April 1, 2, 3, 1968,
and was off on his regular off days April 4 and 5, 1968. EVANS
worked April 6, 7 and 8, 1968, and was working today, April 9,
1968.

RICHARD EVANS, JR., 1827 Short 12th Street, Bessemer,
Alabama, was interviewed at Broyles Yard, L & N Railroad,
Birmingham, Alabama, on April 9, 1968. He stated that he
is a car inspector and was employed by ACL from 1951 until
May, 1966, when ACL merged with L & N Railroad.

He advised that he is Chairman Local Union 385,
Brotherhood of Railway Car Men of America. He stated this
local meets in the City Hall, Tarrant City, Alabama. He
stated that LOUIS L. ELKOURIE, 7448 48th Avenue, North,
Birmingham, Alabama, a member of this Local, several months
ago lost a leg in an accident while working for the railroad.

He stated it was the policy of the National Union to furnish legal advice to members when they are injured.

He stated that about one month ago, J. L. BAILEY, General Chairman, Brotherhood of Railway Car Men of America, Suite 603 Washington Building, Louisville, Kentucky, telephonically advised him that WILLIAM J. LEHMEYER, Investigator for a law firm in Minneapolis, Minnesota, would come to Birmingham and give LOUIS ELKOURIE advice regarding his civil suit against the railroad.

He stated on night of March 25, 1968, LEHMEYER telephoned him that he was going to Atlanta, Georgia, and would like to come to Birmingham to see Mr. ELKOURIE and requested that he contact LOUIS ELKOURIE and his wife as he would like to see them together on his arrival in Birmingham. He stated that he would call him when he reached Atlanta, Georgia, and could advise him of his time of arrival Birmingham.

He stated that LEHMEYER on Tuesday night, March 26, 1968, called him and stated he was in Atlanta, Georgia, and would arrive Birmingham Airport 10:46 A.M., March 27, 1968, and requested that he meet him at the airport.

He stated that he met LEHMEYER at the airport at 10:46 A.M., March 27, 1968, and they rode in his pickup truck to the West End Baptist Hospital, Birmingham, Alabama, where they met Mrs. ELKOURIE, who is a nurse at that hospital. She advised them that she could not talk with them at the hospital as she was on duty and would meet them at her home on the afternoon of March 27, 1968. He stated LEHMEYER on his arrival Birmingham had made reservations to leave Birmingham at 3:00 P.M., on March 27, 1968, but after Mrs. ELKOURIE refused to talk with them at the hospital it was necessary that he cancel his flight plans for 3:00 P.M., on the 27th. He advised after leaving the West End Hospital they went to the Plantation Barbecue Cafe located on First Avenue, North, at 9th Street. He stated he is acquainted with Mr. SMITH, one of the owners of this cafe, and has eaten in the cafe on numerous occasions. He stated that he recalled seeing Mr. SMITH in the cafe on this occasion but does not

know if Mr. SMITH would recall seeing him as he frequently eats at the Plantation Barbecue Cafe. He stated that they left the West End Baptist Hospital about 12:00 Noon and then after having lunch they left the Plantation Barbecue Cafe about 1:00 P.M., then drove to the airport where LEHMEYER changed his reservations. He stated LEHMEYER went to all of the airline ticket offices at the airport and he is not familiar with all the details of their conversation but believes that LEHMEYER was placed on standby. He stated LEHMEYER checked his luggage at the airport at that time.

He stated after leaving the airport they drove around in the area locating Mr. ELKOURIE's address which was not very far from the airport. He stated they then went to a movie on suggestion of Mr. LEHMEYER and believes it was the Melba Theatre in downtown Birmingham. He stated "Blackbeards Ghost" was the name of the movie they went to see. He stated after leaving the movie they returned to the airport and LEHMEYER determined that his plane would leave at 6:30 P.M. He stated that he and LEHMEYER then went to Mr. ELKOURIE's house where Mr. LEHMEYER talked with Mr. and Mrs. ELKOURIE for approximately one hour.

He advised that after leaving Mr. ELKOURIE's home, they returned to the airport at about 6:05 P.M., where he let Mr. LEHMEYER out and then continued to his home in Bessemer.

He stated that on April 3, 1968, after leaving work at L & N Railroad, he proceeded to his home in Bessemer, Alabama, arriving there approximately 4:00 P.M. He stated he was home all the afternoon and that night and shortly after his arrival, he and a friend, W. O. MEEKS, aka BILL MEEKS, who is a neighbor residing across the street from him, painted his trailer and did some work on his boat.

He stated on April 4, 1968, about 3:00 A.M., he and W. O. MEEKS went fishing. He stated they left his home traveling in his 1966 blue Chevrolet pickup truck and they were towing a blue boat with a white trailer. He pointed out a 1966 Chevrolet truck which he stated was the truck they traveled in on April 4, 1968. He stated he and MEEKS

drove to Wauxhatchee Creek (phonetic) which is part of the back waters from the Coosa River and Lay Dam. He stated that they launched the boat at White's Fishing Camp, which is operated by Mr. WHITE and his son, first names unknown to him. He stated that he was not personally acquainted with Mr. WHITE but that Mr. MEEKS had known Mr. WHITE for quite sometime and he is positive that Mr. WHITE and his son would recall that he and Mr. MEEKS were at his fishing camp on April 4, 1968. He stated that they left White's Fishing Camp about 5:15 P.M., April 4, 1968. They arrived at his home approximately 7:00 P.M., on April 4, 1968. He stated that he did not leave his home the night of April 4, 1968, as best he could recall.
