

She established in her mind that he was there from about 8:00 to 8:45 p.m. because during his entire visit the organist was playing the organ. She described the man who was in the bar as about 5' 9" tall, 150 to 155 pounds, approximately 30 years old, with hair between dirty blond and brown. He had a high hairline that was not receding. He was unaccompanied and quiet

in his manner. He spoke to no one at the bar, and in the approximately 45 minutes he was present, he had three drinks of Canadian Club Water. She had some conversation with him and did not believe he was a southerner as he did not have a local or southern accent.

There was a general conversation at the bar, aimed at Mrs. RUSSELL, indicating that she had failed to recognize the Mayor of Bessemer, Alabama, who had been in the bar earlier in the evening. In this connection, the unknown customer asked her if she recognized him, and she replied negatively, asking in turn if she should. He said No, that he was only joking.

He was dressed in a tan, slightly longer than waist length, windbreaker-type jacket (no lining) and wore a solid-colored sport shirt which was open at the throat. She recalled he had asked if he needed a coat and tie and she advised that such was not necessary.

Mrs. RUSSELL remembered that he was at the bar at the same time as two other men, one of whom was a subsequent "skip" from his bar and hotel bill. On the night in question, she had Mr. HARLAN D. WALKER, the Assistant Manager, in the bar because there was some question in his or her mind regarding the possibility of a "skip" by one of these unknown individuals. She expressed her belief that the individual who skipped was registered in the hotel as Mr. TANT or TANTE. She did not believe that FRANCES TAYLOR, the organist, would have noticed the individual in the artist's conception because during his visit at the bar, she was at the other end of the lounge playing music. She advised further that Mr. WALKER was absent from the hotel and probably would not return until the next day. She was unable to state if the individual who resembled the artist's conception was a guest in the hotel on the day in question. She had never seen this individual before or since.

EARL VINSON identified himself as one of two Assistant Managers of the hotel, and he resides at 7410 52nd Court North, Birmingham, Alabama. He closely examined

artist's conception #1, and advised that this individual was unknown to him. Mr. VINSON reviewed the then available hotel reservation records for 3/29/68 and six cards were involved. On the basis of names, addresses, and other information appearing on these cards, as well as VINSON's personal knowledge, it did not appear likely that the individual observed in the bar by WANDA RUSSELL could be identical with any of these individuals.

VINSON advised further that the complete records of 3/29-30/68 were unavailable, locked in the Auditor's Office, and could/be reviewed at this time.

Mrs. ELSIE LESLIE identified herself as the hostess at the Carriage House Restaurant in the Thomas Jefferson Hotel. She has been employed by the hotel on and off for 12 years and as hostess for the past 18 months. She resides at 1147 14th Avenue South, Birmingham, Alabama (328-7828).

Artist's conception #1 was exhibited to Mrs. LESLIE, and she advised that she believed she had seen this individual, and that he looked familiar to her. She said she had seen him in the restaurant on one occasion in the last week or two and had seen him on a couple of occasions in the restaurant sometime ago, possibly as long ago as a year. She was unable to pinpoint the date or time of her most recent observation, but believed it was in the past two weeks.

She described the individual who came into the restaurant as approximately 40 years old, about 5' 11", 180 pounds, with hair which she would describe as sandy or with a reddish tint. She said he looked like a salesman, was quiet and gentlemanly, and was alone at any time she saw him. Most recently, she believed he was dressed in a sport jacket and slacks, but along conservative lines. She said she had no idea whether he was ever a guest in the hotel and could furnish no other information regarding the man she had in mind.

Miss IDA LOUISE PORTERA identified herself as a waitress during the evening hours at the Carriage House, so employed since August 1967. She examined artist's conception #1, and advised this individual was completely unfamiliar to her.

WANDA RUSSELL was recontacted subsequently on 4/6/68, and recalled that Mr. JAMES, of the Southern Bell Telephone Company, was in the bar at the same time as the man in the artist's conception on 3/29/68.

ROBERT LEE JAMES was located and advised that he resides at 405 Rhett Avenue, Huntsville, Alabama (536-0220), and he is an employee of the Southern Bell Telephone Company. He recalled that he was in the Green Olive Bar in the hotel on the evening of 3/29/68 from about 6:00 to 9:00 p.m. and in the company of ED CUTSHALL. Mr. JAMES examined artist's conception #1 and advised that he definitely did not recognize this individual as anyone known to him, and pointed out that on the evening in question he was in the far end of the lounge with his back to the bar.

WILLIAM EDWARD CUTSHALL, of 4237 Mountaindale Road, Birmingham (595-2040), identified himself as an employee of the Southern Bell Telephone Company, and recalled that he was in the bar with ROBERT LEE JAMES on the evening of 3/29/68. He examined artist's conception #1 and advised this individual is completely unknown to him. He said that he and JAMES were seated at a table in the lounge with their backs to the bar and paid no attention to the patrons at the bar.

FRANCES TAYLOR BUSENLEHMER, of 571 Rutherford Circle, Birmingham, identified herself as the organist at the Green Olive Bar, and she generally performs from 8:00 p.m. to midnight, Monday through Saturday. She examined artist's conception #1 and thought she remembered and individual slightly similar to the man in the artist's conception as having been in the bar in the recent past. She described the man she recalled as over 6' tall and 195 pounds. He was in the bar with another male individual, and they were there

until the bar closed at about midnight. She subsequently recalled that the man she had in mind was in on Saturday night, 3/30/68.

The following investigation was conducted on 4/7/68 by SA PATRICK J. MOYNIHAN.

Mrs. BILLIE MARTIN identified herself as the Day Hostess at the Carriage House Restaurant and a resident of 5868 34th Street North, Birmingham, Alabama (841-2833). She examined artist's conception #1 and advised that this individual was not known to her.

Mrs. SARAH DAY, of 2369 23rd Street, Ensley, advised that she was the 11:00 a.m. to 7:00 p.m. Desk Clerk at the hotel, having started on 3/28/68. She examined artist's conception #1, and advised that this individual was completely unfamiliar to her.

BENJAMIN BIRKENFELD, 1000 18th Street, Birmingham, (322-7325), was afforded an opportunity to examine artist's conception #1, and advised that he did not believe he knew the man depicted.

ROY MAULDEN, of 121 Village Court, Birmingham (252-3769), identified himself as a bellman at the hotel, and he was so employed on 3/29-30/68 from approximately 3:00 p.m. until 10:00 p.m. He examined artist's conception #1, and advised that this individual is unknown to him.

HARLAN D. WALKER identified himself as the Assistant Manager and a resident at the hotel. He recalled that he worked the evening of 3/29/68 and remembered being in the bar with WANDA RUSSELL at one time in connection with a possible "skip" whom he identified as BARDY TANTE, of 801 Jackson Blvd., Fort Gaines, Georgia, as per his hotel registration records. WALKER examined artist's conception #1, and advised that he did not know this individual and had no recollection of such an individual as a guest or visitor at the hotel. He said that the above-mentioned TANTE was a big man physically and not at all like the artist's conception.

HARLAN WALKER made available hotel records for 3/29-30/68, and the guest ledgers of all guests were reviewed for the dates 3/26/68 through 4/3/68, with particular attention to the names WILLARD and LOWMEYER/with variations, but no likely registration was found.

Local telephone calls made by all guests at the hotel were reviewed from 3/26 through 3/31/68, but there was no record of a call to 595-2142 (Aeromarine Supply).

W. L. PALMER, of 855 West 5th Street, Birmingham, employed in the Hendon Car Park used by the Thomas Jefferson Hotel for guests' automobiles, observed artist's conception #1, and advised that this individual was unknown to him.

The following investigation was conducted on 4/8/68 by SAs JOHN H. KRESEK and PATRICK J. MOYNIHAN.

Artist's conception #2 was exhibited to Mrs. WANDA RUSSELL, Manager of the Green Olive Bar, and she advised that it was so different from the first artist's conception that the individual who was in the bar on the evening of 3/29/68 did not in her mind resemble the individual depicted in artist's conception #2. She advised further that if artist's conception #2 had been exhibited to her initially, she would not have connected it at all with the individual concerning whom she previously furnished information.

Mrs. ELSIE LESLIE, the Hostess of the Carriage House Restaurant, was afforded an opportunity to examine artist's conception #2, and she advised that it bore a resemblance to artist's conception #1, but much less of a resemblance to the individual concerning whom she previously furnished information, and she did not believe that this was the same individual.


