On 4/10/68, Mrs. BOB WILSON, 2215 Green Springs Highway, advised that she is an elementary teacher at the Glen Iris School, 1115 11th Street South, Birmingham, Alabama, and that shortly after the assassination of MARTIN LUTHER KING, JR., one of her students was slapped by another student, the daughter of DEWEY E. RUFFIN, 1517 13th Street South, after the student stated that it was a shame that Dr. KING had been assassinated; because he was a good man.

Upon inquiry with RUFFIN's daughter, name unknown, Mrs. WILSON learned that Mr. RUFFIN is employed with a rental car agency at the Birmingham Airport and that he had made numerous airplane trips back and forth between Birmingham and Memphis several days before and on the day of the assassination. Mrs. WILSON advised that she does not have any additional information regarding this matter and desires that her identity be protected. Mrs. WILSON is the wife of BOB WILSON, Office of Naval Intelligence, Birmingham, Alabama.

Re Memo of SA COLEMAN D. GEARY, III, dated 4/11/68.

CHRIS MITCHELL, President, Sterling Distributors, 1318 First Ave., North, Birmingham, advised on 4/12/68 that JIMMY LOWERY works as a route salesman for him and that he vaguely resembles the FBI artist's conception of Unsub in this case. He stated LOWERY, however, was working on his route from 6:00 a.m. to 7:30 p.m. on 4/4/68. He stated LOWERY has never owned a white Mustang and he is a long-time resident of Birmingham, Alabama.

JIMMY GLENN LOWERY, telephone 853-1449, 2735 - 6th Street, N.E., Center Point, Birmingham, Alabama, advised he has been employed for Sterling Distributors as a route salesman for the past five years and on 4/4/68 he was delivering beer on his route from approximately 6:00 a.m. until 7:30 p.m. He advised he does not possess any information of value to this investigation, nor is he acquainted with anyone by the name of LOWMEYER or LEHMEYER, nor has he ever met anyone by the name of GALT.

After viewing the FBI artist's conception, he advised he had never met or seen anyone resembling these sketches at any time either at the Five Points South area, where he formerly resided, or along his route. He stated he lived in Apt. F of the Aristocrat Apartments located at 1517 - 16th Avenue, South, from approximately February, 1967, until he moved to his current address in Center Point about three weeks ago. However, as mentioned above, he does not recall ever seeing anyone resembling the abovementioned sketches. He owns and drives a 1965 green Ford Galaxie 500 and states he has never owned a white Mustang.

On 4/11/68, NORBERT ADAMSKI, Federal Bureau of Narcotics, Birmingham, Alabama, advised that his records indicate a file regarding JOHNNIE GRIMES, but that the Birmingham office has never conducted any active investigation regarding him and that he has never been an informant for his Bureau. ADAMSKI advised that his records indicate GRIMES has previously impersonated a Secret Service agent, a Federal Bureau of Narcotics agent, and an informant for the FBN. ADAMSKI advised further that on the basis of his records and personal knowledge, GRIMES has never been an agent for either Bureau or an informant. ADAMSKI stated his records indicate that GRIMES is an alcoholic and was convicted in 1965, for manslaughter, when he was involved in an automobile accident which resulted in the death of his wife.

Attached to the original of this memo is arrest record of JOHN CHRISTOPHER GRIMES, believed to be identical with JOHNNIE GRIMES.
