





On 4/15/68, Mrs. BARBARA DIENL, 3239 Route 225. Rootstown, Ohio, phone 947-2559 (Atwater), which is located about halfway between Youngstown and Akron, Ohio, furnished the following information which she requested be kept confidential:

She stated that after the killing of KING on 4/4/68, she and other members of her family observed sketches of the subject in Ravenna and Akren papers. They observed what they believe is a striking resemblance to her former son-in-law TOWMY RAY WHITE, who divorced her daughter, PATRICIA ANN WHITE, who is making her heme with her at present. They stated at first all of them who knew her former son-in-law treated the matter as a joke but the more they have thought about the act, the more they are of the opinion that he could be the man being sought for the KING murder.

She stated her daughter separated from WHITE in June, 1966, and he secured a divorce from her in Jefferson County, Alabama. He was last in Portage County, Ohio, from 3/18-22/68, when a hearing was held relative to the custody of the child of the marriage, namely LYETTE WHITE, age 3. She stated on this occasion WHITE apparently had no car with him and either arrived in the area by bus, plane or train. She stated that the last she knew, he drove a 1965 White Ford but she does not know what he is driving at present. 44-1740-955

She stated her former son-in-law is definitely psychotic and always carried a loaded gun in his car when he lived in the Fortage County area for a time. When they asked him why he carried a gun, he would state he carried it to "kill niggers". She stated that although he never professed to be a member of the Klan, he indicated that many of his close friends were Klan members and expressed a deep seated hate for Negroes. He threatened to kill her daughter on many occasions and that was why she separated from him.

She stated when in Portage County, Ohio, in March he told them he had married a girl whose maiden name was SHARON HENDERSON, a woman with three children by an unsuccessful marriage. Her family had formerly lived near his former home on Hill Avenue, Hueytown, Alabama.




BETTY NAILS, Anniston Credit Bureau advised the files of her Bureau contained the following information for a CHESTER

Five years military service in the Army being discharged in 1953; divorced; previous employment with Anniston Manufacturing Co. - 2/66-6/67, Moore's Seafood Resturant, Jacksonville, Alabama - 1960 - 1966.

Mr. COLLINS advised BARFIELD's present position was a winder and fixer in the spinning department at the rate of \$2.13 per hour and his immediate supervisor ws CLAUDE BLACK.

CLAUDE BLACK stated the BARFIEID was considered as an excellent employee and he has not missed a day's work since January 4 & 5, 1968 when he was sick with the flu. BLACK stated BARFIELD's normal working hours are from 6:00am to 2:00 pm excluding overtime work which would add additional hours, and the normal work week is monday through saturday.

Mr. COLLINS advised time and attendance records for BARFIELD showed that on April 4, 1968 BARFIELD worked eight hours from 6:00am to 2:06pm, on April 3, 1968 BARFIELD worked $4\frac{1}{2}$ hours from 6:00am to 10:20am, and on April 5, 1968 he worked 12 hours from 6:00am to 6:02pm.

Mr. BIACK advised that BARFIELD was presently attending a special school in Charlotte, N.C. which is being given by the Uniconer Winding Company, Charlotte, N.C.. This school started 4/15/68 and was to run for two weeks. BARFIELD left work friday afternoon and was going to stop at a friend's house in Atlanta, Georgia where he was going to leave his mother while he was attending the school.

Mr. COLLINS further advised that BARFIELD was given a \$200 advance for expenses when he left on friday, 4/15/68.




