JOHN NORRIS, caretaker, National Guard Range, Lewisburg, Birmingham, Alabama, advised that individuals are not allowed to fire rifles at the National Guard Range and he does not recall an individual at the National Guard Range requesting to use the range who in his opinion might be identical with ERIC STARVO GALT.

GEORGE DAVIS, Director, Magic City Gun Club, Birmingham, advised that the Magic City Rifle and Pistol Range is located on Turkey Creek in rural Jefferson County. He stated that this range is in an isolated area; however, it is fenced and the gate is always locked and no one is supposed to have a key except the members. He stated that on 3/31/68, the Magic City Gun Club held a pistol match and he is positive that no one fired a high-powered rifle at the Magic City Gun Club on that date. He stated that the club has a rule that no one fires large caliber rifles on this range on Sundays in view of the noise and the fact that there is a church not very far from this range. He advised he had no information that anyone other than members had used this range.

WALTER E. PLUNKETT, police officer, Tarrant City, Alabama, advised that the Tarrant City Police Department has a pistol range but it is not designed for the firing of high-powered rifles and they do not allow high-powered rifles to be fired on this range. He advised

that he has no information that anyone has used this range to fire a high-powered rifle.

EDWIN H. WOOD, Chief of Police, Homewood, Alabama, advised that the Homewood Police have a pistol range but rifles are not allowed to be fired at that range. He advised that he has no information that anyone has used this range for firing a high-powered rifle in the past several weeks.

J. W. NORRIS, Chief of Police, Midfield, Alabama, advised that the Midfield Police Department does not have a rifle or pistol range. He advised that the Jefferson County Sheriff's Office has a pistol range located near Bessemer, Alabama, but it is not designed and is not safe for the firing of high-powered rifles.

From SA ARNETT's personal knowledge of ranges in this area and since some of them are located in remote areas, it would be possible for someone to fire a rifle without it being known to anyone in the area except by the noise, as several of the ranges do not have any houses located in the immediate vicinity.

Re: Suspect CHARLES L. WEST - Negative

On 4/14/68, JAMES NOLEN SHIVERS, police officer, Birmingham Police Department, Birmingham police car #63, advised at 3:20 p.m. that he had just had a conversation with a Negro whose name he only knows as "PREACHER". He stated that "PREACHER" advised him he had received information from the Negro maids and other help who are employed at the Airport Motel that there had been an individual at the Airport Motel for several days who they thought might be connected with the murder of MARTIN LUTHER KING, JR. This individual, according to information he had received, had a rifle or shotgun which he kept by his bed. The man was nervous, seldom left his motel room, and had his meals in his motel room.

SHIVERS advised that he would attempt to locate "PREACHER" and advise SA ARNETT in order that he could be interviewed by Agents regarding this matter and the identities of persons who had furnished original information. On the afternoon of 4/14/68, SHIVERS advised that he had determined that "PREACHER" was not at his home.

The following investigation was conducted by SA NEIL P. SHANAHAN and SA J. T. ARNETT at Birmingham, Alabama:

The following individuals at the Airport Motel were interviewed regarding the above information and all advised that they had no information concerning such an individual at the Airport Motel:

Mrs. LESLIE YORK, Desk Clerk, Airport Motel, advised that she had not received any information that a man was staying at that motel who had a rifle or a shotgun in his room during the past several days. She advised there were only two individuals in the motel on 4/14/68, who had been there over one night and she was acquainted with both of these individuals. She stated that Mr. M. BIDDLE, Room 235, employed by Birmingham Transit Company, was from Miami, Florida, and had been in Birmingham regarding the labor trouble in Birmingham in connection with the bus company drivers' strike. She stated BIDDLE is a white male, very large in size, and she has known him for six to eight months. She stated that T. ROBERTSON, Room 443, is employed by a rent-a-car company, which she believes to be National Rent-A-Car Company. She stated he is 50 years old and is a very large man. She stated the only other man who had not checked into the motel on 4/14/68, was D. G. DAVENPORT, who checked into the motel at 11:49 p.m. on 4/13/68, from Arlington, Texas, and he is employed by Southway, Inc.

SAs ARNETT and SHANAHAN again met with Officer SHIVERS, who then contacted VADA DOWE, who according to SHIVERS is a police informant, and VADA DOWE advised that she was acquainted with "PREACHER" but did not know his true name. She advised she would attempt to ascertain his true identity. She stated she has information that "PREACHER" resides with HOSEA CARLYLE at 3308 63rd Way, North. Attempts to locate HOSEA CARLYLE were negative.

In the late evening of 4/14/68, Officer SHIVERS telephonically advised SA ARNETT that he had received information that "PREACHER's" name is OBLEE KREER (phonetic) and he might be located at 6305 3rd Avenue, North.

The following investigation was conducted by SA J. T. ARNETT at Birmingham, Alabama:

On 4/16/68, LIZZIE JONES, 6305 3rd Avenue, North, advised she is acquainted with OBLEE KREER but she had not seen him in over a week.

On 4/16/68, HOSEA CARLYLE, 3308 63rd Way, North, advised that OBLEE KREER was not at home but he had received information from OBLEE KREER that the motel where the man with a gun was allegedly staying was the Bama Motel located on 68th Street and 1st Avenue, North, Birmingham, and not the Airport Motel.

On 4/16/68, Mrs. EVELYN L. FRANKLIN, owner, Bama Motel, 6712 1st Avenue, North, advised that the only man who had been at this motel the previous week who had a gun to her knowledge was CHARLES L. WEST, 5200 Rye Drive, Dayton, Ohio, employed by Scientific China Company. She stated that WEST checked into the motel at 2:45 p.m., 4/4/68, and left on 4/12/68. She stated that WEST, according to information WEST furnished her, was in Birmingham to sell some real estate and he had been in contact with a lawyer and was attempting to evict someone from a house that he owned. She stated that when WEST left the motel on 4/12/68, he had apparently forgotten to take the rifle which was left in his room, and he had called the motel and advised them that his niece would come by the motel and pick up the rifle. Mrs. FRANKLIN advised she could not recall the niece's name but she is employed at Hardemons Beauty School located on 2nd Avenue, North, at the rear of Bailey's Drug Store. She stated that Mr. WEST while he was at the motel would usually leave the motel around 9:00 or 10:00 a.m. and return about 4:00 or 5:00 p.m. She stated when he arrived, he had informed

the clerk that he had recently had a heart attack and if he had any difficulty he would furnish the clerk a telephone number which she believes was a relative in Birmingham. She stated she was unable to locate this telephone number. Mrs. FRANKLIN advised on occasions Mr. WEST would appear to be upset and nervous which he attributed to his failure to evict the persons from his house which he was attempting to sell.

Mrs. FRANKLIN exhibited a Marlin model 336 rifle, 44 magnum caliber. This rifle did not bear a serial number that could be observed, it being noted many modern weapons are now being manufactured without serial numbers; for instance, the Stevens double-barrel shotgun. Mrs. FRANKLIN described WEST as a white male, 5'10", 200 pounds, heavy build, gray hair, extremely large fat neck, age 61 to 65, dressed in ordinary clothing (which she noticed on the day he left the seam of his pants in the seat was split). She stated he was driving an old model automobile whose license plate was not obtained by motel personnel.

No further investigation was made concerning CHARLES L. WEST by SA J. T. ARNETT in view of the date of his arrival and information furnished by Mrs. FRANKLIN concerning activities of WEST.

Re Memphis teletype to Birmingham dated 4/9/68.

On 4/15/68, Mr. HARRY A. EDGE, 8179 Rugby Avenue, Birmingham, Alabama, was interviewed by Buagents under a suitable pretext and furnished the following information:

He is employed by the American Cyanamid Company, Johns Road, Bessemer, as a salesman and travels a good deal in connection with his employment. He advised that he was in the Memphis, Tennessee area on April 5, 1968, because he was contacting customers in that vicinity and more especially in Union City, Tennessee, and his itinerary called for a visit to the Joe N. Pless Company in Memphis on Friday morning. Mr. EDGE advised that he registered at the Holiday Inn SE near Memphis between 5:30 and 6 p.m. on April 4, 1968, but after learning of the disturbances in Memphis he left the following morning for Birmingham. He advised that he at no time on this trip entered the Memphis area and that the Holiday Inn is approximately five to ten miles from Downtown Memphis.

Mr. EDGE was shown the artist's conception of GALT but advised that he had never seen anyone resembling this drawing. Mr. EDGE stated he would be most willing to cooperate with the FBI in any manner possible but that he had no information regarding the subject's whereabouts.

SANDY said he formerly worked for Skil Tool Factory, Chicago, Illinois. PACK said SANDY had some resemblance to the photograph of GALT which had appeared in the Birmingham newspapers.

PACK described SANDY as WM, 5'8" to 10" tall, 160 pounds, medium build, and had index finger right hand amputated. He said the amputation appeared to be an old scar.
