RAYMOND J. ISLEY, owner of a public accounting firm, 8100 7th Avenue North, Birmingham, which concern has the account of THERON C. TERRELL AGENCY, INC., Atlanta, on 4/19/68 made available his records from which the following was obtained:

An (FNU) WILLARD was employed in Atlanta by TERRELL as telephone solicitor starting 3/21/67 through about 4/11/67 during a solicitation campaign handled by TERRELL for the Elks Club, Atlanta. No address, Social Security Number, or any other background information re WILLARD in records. No record of \$20 sent to WILLARD, any place, by TERRELL. During March 1967 WILLARD earned \$86.33 in commissions and in April 1967 he earned \$78.62. All commissions paid daily, in cash, based on collections made by agency. Names of other persons employed in Atlanta by TERRELL during same period as was WILLARD (3/21/67 - 4/11/67) have been obtained and are listed hereinafter. In view of information developed re identification of JAMES EARL RAY that RAY escaped from Missouri State Penitentiary 4/23/67, RAY cannot be identical with WILLARD.



On 4/10/68 a review of the Nashville telephone directory reflected that W. R. THOMPSON resides at 1097 Lynwood.

On 4/10/68 a negative attempt was made to contact O. B. THOMASON, residence 1095 Lynwood, JOHN J. BRADY, JR., 1099 Lynwood, and JAMES DILL, 1101 Lynwood.

On 4/11/68 Mrs. O. B. THOMASON, 1095 Lynwood, advised that the residence at 1097 Lynwood was occupied by the W. R. THOMPSON family and that THOMPSON is presently on a Florida vacation with his family. Mrs. THOMASON advised that on 4/4/68 and 4/5/68 she noted that Mr. THOMPSON was working in his yard at his residence at 1097 Lynwood. Mrs. THOMASON advised that Mr. THOMPSON was working in his yard until approximately 6:00 p.m. on 4/4/68.

On 4/11/68 Mrs. JOHN J. BRADY, JR., 1099 Lynwood, advised that the occupants of the residence at 1097 Lynwood were the W. R. THOMPSON family and they are presently in Florida on a vacation. Mrs. BRADY advised that Mr. THOMPSON was a successful businessman and was employed by GENESCO, Nashville, Tenn., and that Mr. THOMPSON was highly respected as a very civic minded man. Mrs. BRADY advised that she recalls that Mr. THOMPSON was working in his yard cutting the grass on the date of 4/4/68 and 4/5/68. Mrs. BRADY could not recall the exact time.

On 4/20/68 Mr. DANIEL S. KELLY, 2533 North Wall Avenue, Milwaukee, Wisconsin, telephonically furnished the following information to the FBI, Milwaukee. Mr. KELLY stated that he and his wife were recently in Florida, having arrived there 3/28/68 from the West Coast. They checked into the Sun Castle Club, 1380 South Ocean Blvd., Pompano, Florida which Mr. KELLY stated was operated by an ex-FBI Agent, ERNEST CASTLE. He said that upon his arrival he was roomed by a bellboy of the Club and subsequently requested this bellboy to furnish him with three or four copies of various newspapers. He stated that two or three days later he attempted to locate the bellboy to reimburse him for the papers and found out that he had left the employ of the Club. He stated that inquiry revealed that this bellboy, whom he knew only by the first name of EARL, had told others at the Club that he was leaving to accept an offer to work as an electrician someplace in Tennessee for \$500 a week. Mr. KELLY stated that this salary sounded absurd and that upon subsequently checking photographs of JAMES EARL RAY he and his wife felt that this individual closely resembled RAY, both in looks and general description. Above being furnished for whatever action deemed necessary by Miami.

At about 6 p.m. on 4/4/68, while standing on the second floor balcony outside Room 306 of the Lorraine Motel, 406 Mulberry Street, Memphis, Tennessee, Dr. MARTIN LUTHER KING, JR. was struck in the right side of the face by a single bullet fired from a 30-06 rifle. The bullet severed KING's spinal cord and death was almost instantaneous.

This investigation, predicated upon a specific request from the Attorney General of the United States, disclosed that the fatal shot had been fired from the bathroom of a cheap rooming house located at 422½ South Main Street, Memphis, which bathroom was located at the rear of the rooming house, and had a window overlooking the Lorraine Motel.

At about 3 p.m. on 4/4/68, an individual using the name JOHN WILLARD had rented Room 5-B in the rooming house at 422½ South Main Street and had paid one week's rent. After hearing the rifle shot at about 6 p.m. on that same day, other tenants in the rooming house observed a man presumably identical with WILLARD, fleeing from the rooming house carrying a large package which was subsequently abandoned by him on the sidewalk in front of the Canipe Amusement Co., 424 South Main Street, Memphis. A neighborhood investigation in the vicinity of 424 South Main Street disclosed that the subject had fled from the scene in a white Mustang.

Found abandoned in front of 424 South Main Street was a 30-06 Remington model 760 rifle which was determined to have been

sold to one HARVEY LOWMEYER on 3/30/68 by Aeromarine Supply Co., Birmingham, Alabama.

Investigation at Memphis disclosed that an individual had purchased a set of binoculars at the York Arms Company in Memphis on 4/4/68. These binoculars were among the material abandoned with the rifle and recovered in Memphis. Also recovered was a brown and green herringbone bedspread. The items abandoned in Memphis were all wrapped in this bedspread. The blue bag which was inside the bedspread contained numerous items, among which were the binoculars and a set of underwear consisting of a T-shirt and shorts. The T-shirt and shorts are those on which appears the laundry mark which has been a matter of interest in this case.

A search of motel records in the Memphis area disclosed that an individual using the name ERIC S. GALT had spent the night of 4/3/68 at the Rebel Motel, Memphis, Tennessee, and was driving a 1966 white Mustang bearing Alabama License 1-38993. Investigation at Birmingham disclosed that this automobile had been purchased by ERIC S. GALT on August 30, 1968, from a private person in response to a newspaper ad. He paid a total of \$1995 cash. While in Birmingham he furnished the address of 2608 South Highland Avenue, Birmingham. This is also the address which appeared on a driver's license issued to him by the State of Alabama. The driver's license identifying data listed his birth date as [redacted], his height as 5'11", his weight as 170 and his eyes blue and hair brown.

The automobile in question, the white Mustang bearing the Alabama tags mentioned above, was recovered in Atlanta on 4/11/68 and determined to have been abandoned there prior to 9 a.m. on 4/5/68.

In connection with the evidence submitted by Atlanta, Birmingham, and Memphis, identifiable latent prints were recovered. It was on the basis of these latents that identification was made of JAMES EARL RAY. In handling future leads, all offices should be particularly interested in securing an identifying number, military, police, or FBI, in connection with suspects so that the necessary check can be made through the Identification Division.

On 4/17/68, AUSA R. MACEY TAYLOR, Birmingham, authorized the filing of a complaint charging ERIC STARVO GALT with a conspiracy to violate Section 241, Title 18, U. S. Code, and

recommended bond in the amount \$50,000. On that same date, SAC JOSEPH H. GAMBLE filed a complaint before USC MILDRED F. SPRAGUE, Birmingham, and warrant was issued that same date.
