Synopsis: Bushnell and Company, Pasadena, California, unable to trace Bushnell binoculars found at scene of shooting of Dr. MARTIN LUTHER KING, JR., 4/4/68, as no record maintained on serial numbers. Duck-bill pliers found in vicinity of shooting traced to Rompage Hardware Company, 5542 Hollywood Boulevard, Los Angeles, California. Employees of Rompage unable to identify purchaser of pliers. Laundry markings No. 02B-6 on red Thermo-Seal tape on T-shirt and under shorts found in vicinity of shooting similar to laundry markings utilized by Home Service Laundry and Dry Cleaning, 5280 Hollywood Boulevard, Los Angeles. Laundry mark No. 02B-6 at this laundry assigned to customer with name E. GALT. 1966 white Mustang bearing license 1-38993, no state given, speedometer reading 34,185, was serviced at H. Beckman Chevron Service Station, 1506 North Normandie Avenue, Los Angeles, on 2/13/68. 1966 white Mustang bearing Alabama license 1-38993, speedometer reading 34,289 serviced at Cort Fox Ford, 4531 Hollywood Boulevard, Los Angeles, on 2/22/68, which service was ordered by E. GALT, 1535 North Serrano, Los Angeles, and signed by ERIC S. GALT. Investigation at 1535 North Serrano Avenue, Los Angeles, revealed ERIC S. GALT resided in Apartment 6 from 11/19/67 to

approximately 1/18/68. Records, U. S. Post Office, Los Angeles, reflected ERIC S. GALT furnished change of address on 1/22/68 from 1535 North Serrano Avenue, Los Angeles, to St. Francis Hotel, 5533 Hollywood Boulevard, Los Angeles. GALT unknown to ANITA KATZWINKEL, whose name along with name of GINGER DAY appeared on piece of cardboard found in trunk of 1966 white Mustang located in Atlanta, Georgia, following the shooting of Dr. KING. Investigation at St. Francis Hotel where GALT resided from 1/21/68 to 3/17/68 reveals GALT left forwarding address of General Delivery, Main Post Office, Atlanta, until 4/25/68. No further information developed as to GALT's present whereabouts. Records, Pacific Telephone and Telegraph Company, reveal GALT made no out of state calls from telephone registered to him at 1535 North Serrano Avenue, Los Angeles, during period 11/27/67 to 1/22/68. GALT took recreational type lessons at National Dance Studios, Long Beach, California, from first week of December, 1967, to 2/12/68. Personnel at this studio unable to furnish information regarding GALT's present location or any background information regarding him. GALT attended International School of Bartending, Los Angeles, from 1/19/68 to 3/2/68. Associates of GALT, CHARLES J. STEIN, RITA STEIN, and MARIE MARTIN interviewed extensively and could furnish no information as to his present whereabouts. CHARLES J. STEIN accompanied GALT on trip from Los Angeles to New Orleans, Louisiana, for purpose of returning two of RITA STEIN's children to Los Angeles during December, 1967. GALT purchased Bank of America money orders payable to Locksmithing Institute, Bloomfield, New Jersey, and various firms in Los Angeles area. FBI Laboratory reports sample of Thermo-Seal laundry markings obtained from Home Service Laundry and Dry Cleaning, Los Angeles, have no significant differences from laundry markings on T-shirt and under shorts found in vicinity of shooting. GALT SHOULD BE CONSIDERED ARMED AND DANGEROUS.

The Memphis Office of the Federal Bureau of Investigation (FBI) advised on April 5, 1968, that a pair of Bushnell 7 X 35 banner binoculars bearing serial No. SNDQ408664 were found near the scene of the shooting of Dr. MARTIN LUTHER KING, JR. on April 4, 1968, in Memphis, Tennessee.

Investigation at Bushnell and Company, 2128 East Foothill Boulevard, Pasadena, California, was requested to ascertain if these binoculars were a part of a purchase of six pairs of binoculars by the York Arms Company, 162 South Main Street, Memphis.

DOROTHY STARVES, Sales Service Manager, D.P. Bushnell and Company, Inc., 2828 East Foothill Boulevard, displayed the file copy of an invoice made out to the York Arms Company, 162 South Main Street, Memphis, Tennessee. The invoice number is D33065. The invoice is dated October 31, 1967. It reflects that an order was placed on October 20, 1967, and shipped October 30, 1967, for the following described items:

1. One 7 X 35 Ultra Vision binoculars.
2. One Pocket scope (Monocular) with two interchangeable objectives.
3. Six 7 X 35 Banner binoculars.
4. Two table top tripods.

STARVES examined the shipping copy of the above described invoice and ascertained the shipment was made and dated October 31, 1967.

STARVES stated that Code 127350 is the code number for the six Banner binoculars.

STARVES advised that serial numbers for binoculars are not recorded by this firm.

The Memphis Office of the FBI advised on April 6, 1968, that information from the National Retail Hardware Association, Indianapolis, Indiana, indicated that the pliers abandoned in the vicinity of the shooting of Dr. KING were purchased from Rompage Hardware Company, 5542 Hollywood Boulevard, Los Angeles, California.

1Date 4/10/68

THOMAS M. WARE, 3344 Glenhurst Avenue, Los Angeles, was interviewed at his residence at which time he furnished the following information:

A photograph depicting a pair of duck-bill pliers containing the name of Rompage Hardware on the handle was exhibited to Mr. WARE. He was asked if he had ever seen such a pair of pliers. Mr. WARE related that he had ordered pliers such as were shown in the photograph from an unrecalled firm while he was manager of Rompage Hardware Store, 5542 Hollywood Boulevard, Los Angeles, California. He stated the pliers were seconds and were received by Rompage Hardware in an assortment of tools which were sold from a bargain bin.

Mr. WARE stated he was employed by Rompage Hardware from 1955 through February, 1967. He was manager of Rompage Hardware for approximately five years. He began ordering the assortment of tools for use in the bargain bin in approximately February, 1966, and continued reordering every three or four months until he terminated his employment with Rompage Hardware in February, 1967. Mr. WARE did not know exactly how many pairs of pliers were received in the assortment of tools but estimated probably no more than a dozen pliers were received in the assortment. He stated when receiving the assortment of tools, he only counted the number of tools received in the assortment and did not note the number of each type of tool received.

Mr. WARE related that he could not specifically recall having sold a pair of the pliers to anyone. He further stated that he did not possess a pair of these pliers himself.

Photographs depicting a pair of duck-bill pliers containing the name of Rompage Hardware was exhibited to JONES. He was asked if he had ever seen such a pair of pliers. JONES stated that to the best of his knowledge, he had not. He related that he was an employee of Rompage Hardware, 5542 Hollywood Boulevard, Los Angeles, in July and August, 1967, but could not recall having seen a pair of pliers such as depicted in the photographs exhibited to him. He recalled Rompage Hardware having a bargain bin in which ninety-eight cent hardware items were sold, but could not recall a bargain bin in which \$1.98 items were sold.

Only at times, when walking through the store, has he been asked by customers the location of various items. He does not recall ever being asked by any customer or anyone else, the location of any pliers of any description. He did not purchase any pliers while employed at Rompage Hardware, and knows of no one who did purchase a pair of duckbill pliers, 8" (eight inches) in length.

The Albany Office of the FBI advised on April 8, 1968, that a suitcase abandoned in the vicinity of the shooting of Dr. KING on April 4, 1968, contained a white T-shirt and multi-colored pair of under shorts, both of which bore laundry marks on red tape with black letters believed to be the Thermo Seal type manufactured by the Textile Marking Machine Company, Inc., Syracuse, New York. The tape was  $\frac{1}{4}$  inch wide and  $1 \frac{1}{16}$  inches long, and it bears letters and numbers 02B-6.

Officials of the Textile Marking Machine Company, Syracuse, advised that the type of machine making this tape was unusual in that the first two characters were 15 point type and the last three characters were 18 point type, with the middle character being narrow rather than regular type.

Among those machines sold by the Textile Marking Machine Company which could have produced instant tape was model RH5K1, serial No. 3145, sold to Delite Laundry, 1607 Brooklyn Avenue, Los Angeles, California.

DAVID L. SIMON advised on April 10, 1968, that he was the former owner of the Delite Laundry Company, 1607 Brooklyn Avenue, Los Angeles. SIMON is presently associated with the Supreme Laundry, 623 Towne Avenue, Los Angeles. He stated that the Delite Laundry Company went out of business in July of 1963 and that he could not recall what happened to the Thermo Seal machines when the company went out of business.

She stated this number would have been used sometime after mid-February, 1968. She said she recently took over management of the laundry from JEROME W. VERNON, who went bankrupt and has disappeared. She said she took over operation of the business on about March 24, 1968, and VERNON was last seen about that time at the laundry. PINELA furnished samples from the thermo seal marking machine using the numbers and letters, O 2 B-6, on red colored tape. She noted that the machine was defective and parts of the first letter O were cut off from the left side of the tape. PINELA advised there were letters unopened, which were delivered to VERNON at this address from the Allstate Insurance Company and Crocker Citizens National Bank. PINELA advised she was sure that the records which contained the laundry mark O 2 B-6 were in the possession of VERNON. She described VERNON as follows:

PINELA advised she never saw VERNON or JIM in the possession of any type of gun. She said a large box of tools belonging to VERNON are now missing from the laundry. She advised she had the home address of DIANE WALL at her residence, and would make this information available later in the day. PINELA's home telephone number is 748-4260, and she would be home between 6:30 and 8:30 P.M.

Concerning the placement of the laundry marks on the garments in the photo, she advised this is where their laundry would place thermo-seals to indicate that the clothing was not to be starched.

While Miss PINELA was cooperative, she said it would be difficult at this time to fully answer questions because of the continuous traffic of customers in and out of the store, requiring her attention.

Mrs. NIETO advised that she could positively say that the laundry in the photograph had been marked at Home Laundry by the Thermo Seal marking machine at the laundry because of the manner in which the first digit zero is partially cut off and also because that most cleaners put the laundry mark on the inside of the underwear and that at Home Laundry the mark is put on the outside of the underwear shorts, as is shown in the photograph.

Mrs. NIETO stated that she was the only person in the shop who ran the marking machine and that she believed she had marked the laundry in question. Mrs. NIETO could not remember marking the specific piece of underwear shown in the photograph or to whom the laundry belonged. Mrs. NIETO stated that she had begun work at the Home Laundry about the last week of February and started running the marking machine on March 4, 1968. Mrs. NIETO stated that the laundry in question would have had to be marked between March 4, 1968 and March 18, 1968, because after March 18, she no longer put the laundry mark on underwear or items of that nature but only on shirts.

VERNON advised that he has been employed by Lockheed Air Craft Company, Ontario, California since April 3, 1968 and exhibited to the interviewing Agents his identification card from Lockheed, which showed the date April 3, 1968.

VERNON advised that he operated the Home Service Laundry and Dry Cleaning Company, 5280 Hollywood Boulevard, Los Angeles, from January 16, 1968 to March 23, 1968. He stated that a man by the name of GALT was a regular customer at the laundry and he believed that he came in each Saturday afternoon. He first saw GALT on Saturday, January 20, 1968, and the last he recalled seeing him was on March 16, 1968. VERNON stated that it was his opinion that GALT always came into the store on Saturday afternoon, left a bundle of laundry which usually consisted of underwear, T-shirts, and dress shirts, and then would pick up the finished laundry the following Saturday. That is, he would leave a bundle and pick up what previously had been washed from the previous Saturday.

VERNON was shown a photograph of the T-shirt and shorts, which were recovered in Memphis, and he believed that they were similar to the ones that were brought in by GALT. He felt that the size of the T-shirt would be that which would have been worn by GALT. VERNON stated that he could not state for sure whether or not the two pieces of underwear belonged to GALT.

VERNON identified the laundry marking on the underwear in the photograph as being similar to the mark used at his laundry.

VERNON does not know GALT by his first name; however, entries in the laundry book, which were obtained from VERNON indicate that GALT's first name was given to the laundry as

VERNON stated that GALT usually wore bermuda shorts, a sport shirt with a T-shirt underneath when he came into the store. He said that GALT never wore glasses nor did he ever observe him to have sunglasses in his possession. VERNON could not determine what kind of foot wear GALT wore. He never observed GALT driving a vehicle nor did he ever see GALT in any other location other than the laundry. GALT never furnished an address to VERNON or any of the other employees at the laundry.

VERNON described GALT as follows:

VERNON never noticed anything unusual about GALT's speech and stated that he would assume that GALT would come from the California area, as he had no noticeable regional accent.

VERNON was exhibited the two composites furnished by the Bureau, and he stated that the eyes, nose, and chin on the composite from Memphis should be placed on the composite of Birmingham and that this would be a good likeness of GALT.

VERNON stated that GALT always paid for his laundry in cash, using bills in the \$10 and \$20 denominations. GALT never mentioned to VERNON where he worked or any other information concerning his background.

JEROME WALLIS VERNON was reinterviewed at the Los Angeles Office of the FBI, and he furnished the following information:

VERNON amended his previous description of GALT as being between 25 - 30 years of age, and approximately 160 pounds. He never wore bermuda shorts as he had indicated in the previous interview stating he was confused with another customer. He now recalls that GALT's dress was unusual in that it was not the California style. He could not place the clothing in any particular part of the country or from any foreign country, but did think it looked more like that of the English style. VERNON stated that after thinking over his knowledge of GALT, he now feels that GALT had a slight educated Southern accent.

VERNON advised that he could not elaborate on the wearing apparel of GALT. He had never noticed any type of jewelry which he might have worn nor did he ever engage in a conversation with GALT in which he could have learned anything of his background.

At this interview VERNON was shown a composite which was made up of the two composites from the description which he had previously furnished, and he stated this was not a true likeness. He thereupon took the forehead of the Birmingham composite and placed it on the one from Memphis and indicated that this now looked like GALT as he recalled him.

VERNON advised that he could furnish no additional information concerning GALT.

Mr. BECKMAN related that to the best of his recollection he and AL BALLAN had a brief conversation with the individual who brought this vehicle into the station at approximately 12 noon on February 13, 1968. From looking at the service order, he assumes AL BALLAN had made out the service order containing the work to be performed on the Mustang. Mr. BECKMAN further related the individual bringing the vehicle into the service station had told him that he did not have a telephone number where he was staying as he would only be in Los Angeles for a few days. The individual left the vehicle at the service station, gave the station a time as to when he would like to have the vehicle, and left the area of the station proceeding on foot west on Sunset Boulevard, Los Angeles. The individual returned to the station at approximately 4:30 or 5:00 P.M. in the afternoon. BECKMAN did not observe what direction he came from when returning to the station to pick up the vehicle. Mr. BECKMAN recorded his name at the top of the service order and at the time the bill was paid, made the notation "Pd. Cash" with his initials. BECKMAN does not recall this individual asking for maps at anytime. Only maps carried by BECKMAN are ones of California and Los Angeles which are Standard Oil maps unmarked by BECKMAN to identify his service station.
