On 4/19/68, Mr. GEORGE J. BRADLEY, JR., Maintenance Manager, Reichhold Chemical Company, Holt, Alabama, telephonically contacted the Tuscaloosa Resident Agency and advised he had some information to confidentially furnish the FBI concerning captioned matter.

On the same date, BRADLEY was contacted at the Reichhold Chemical Company, Holt, Alabama, and he furnished the following information:

BRADLEY, who advised that he resides at 2-0 Northwood, Northport, Alabama, telephone 759-5207, stated that during the early part of March, 1968, he and his wife were vacationing in Mexico and that during this time he noticed an individual who bore a resemblance to the photograph of ERIC STARVO GALT in a hotel in Mexico. BRADLEY advised that on 3/6/68 he and his wife were staying at the Hotel Con Bungalows Playa Azul at Catemaco Vera Cruz. BRADLEY advised this was a resort type hotel and was frequented by individuals whom he would classify as tourists. He advised that during the morning of 3/6/68, while he and his wife were having breakfast in the hotel diningroom, he noticed a man who seemed to be by himself also eating in the hotel diningroom. BRADLEY said this man stood out in his mind simply because he was alone while other persons at the hotel were with their families or other individuals.

BRADLEY stated he would describe this man as a white male, slender build, approximately 5'11" to 6 feet tall, about 160 to 170 lbs., between 32 and 37 years of age; driving either a light-colored Mustang or a light-colored Corvair.

BRADLEY advised that when he read about the murder of Rev. MARTIN LUTHER KING, JR., and the subsequent investigation concerning GALT, this man he had seen at the hotel struck a note with him.

BRADLEY was shown a photograph of ERIC STARVO GALT appearing on Wanted Flyer No. 442 dated April 17, 1968. BRADLEY advised he is not certain but he does not feel that the individual he noticed at the above-mentioned hotel is identical with GALT. BRADLEY stated the man he is thinking about seemed to have a more slender face and build than is shown in the photograph of GALT.

BRADLEY advised that the reason he decided to get in touch with the FBI in this matter was the fact that he read that GALT had spent some time in Mexico and he felt it very strange for a man like the individual mentioned above to be alone at a resort hotel. BRADLEY said he could not positively state that the man he saw at the hotel was not ERIC GALT, but could state that the description of GALT and his photograph as appearing on the above-mentioned Wanted Flyer are not similar to the man in the hotel.

Any leads in this matter will be left to the discretion of the Case Agent in this matter.

DATE: 4-25-68

On 4-5-68 informant was contacted in regard to the murder of Dr. MARTIN LUTHER KING the previous day in Memphis, Tenn. Informant advised that there was a lot of "ugly" talk being passed around among the negro community but he did not feel that there would be any demonstrations or riots of any kind in connection with this shooting. Informant advised that he ~~WEN~~ would be alert for any trouble and would advise the writer immediately.

On 4-19-68 informant contacted the writer and advised that things in North Birmingham are very quiet and there is no trouble. He advised that the negro community seems to be aware that the FBI is conducting a full scale investigation into this matter and that they will bring the man responsible for this murder to justice. He said that there is always talk that the police are not concerned when a negro is killed but that every one thinks now that the FBI is doing everything that can be done.

On 4-22-68 this informant was furnished a copy of the I.O. on JAMES EARL RAY and advised that he would be alert for any information that would be helpful to this investigation.
