ROBERTS stated that FREDERICK and LANIE GREEN also owe Texaco Oil Co. a large sum of money for credit card purchases, and they gave false addresses when renting the 1968 Pontiac.

Reference Memo SA PETER JOHN BODKIN, 4/19/68, and Memo SPC HOMER E. PARKER, 4/24/68, both relating to Mrs. OLIVIA BROWN, 417 56th St., Fairfield, Alabama.

On 4/25/68, Mrs. ARTHUR (OLIVIA) BROWN, 417 56th St., Fairfield, Alabama, was contacted concerning alleged information from her that she had seen subject JAMES EARL RAY, recently. Mrs. BROWN rambled about insurance policies of her nephew, a drunk church member named EUNICE, a picketing of the A & P Store in Ensley, for about 15 minutes. She then described the man she saw about 4/17/68 as a WMA age 24, 6'1", 200, coal black hair. She claimed she saw the same man near the picket line at the A & P Store, Ensley, on 4/24/68, and now he was 6'1", 170 pounds, light brown hair, age about 30. She insisted it was the same man and then she started talking incoherently again for about ten minutes. It is the opinion of the writer this woman has a very acute mental problem. In view of the above no further action being taken concerning this information from Mrs. BROWN, and is recommended no action be taken in the future.

He advised there is no marking on the batteries to indicate from which store the battery had been bought. The battery is marked as to the model and date of purchase (month and year), and thus the purchaser can take the battery into any Sears store if he has trouble with in the warranty time, and receive service, without causing any record keeping. The only record ~~xxx~~ kept of any sales are those that are charge or credit sales. In view of the above no further action being taken in connection with the battery found in subject's car in Atlanta.

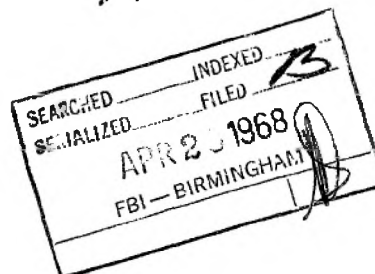
