On 5/9/68, MARVIN P. LITTRELL, owner, Littrell Motor Company, Athens, Alabama, which is the Chevrolet-Oldsmobile dealer, furnished the following information concerning referenced communication:


During the latter part of 1962 or the first part of 1963, exact date not recalled, he was attending a Democratic convention in Mobile, Alabama, and at the conclusion of this convention he went to the Mobile Airport for transportation home. To the best of his knowledge, this was before noon on an unrecalled date and he was just about intoxicated, as he had several drinks before leaving the hotel as well as a couple of drinks at the airport. On this occasion to the best of his recollection, he was accompanied by a prosperous farmer from Mount Hope, Alabama, whom he believed to be (FNU) ROBERTSON. While at the Mobile Airport, he and ROBERTSON were having a Coke when he noticed a group of young Negroes, at which time he struck up a conversation with one of these individuals. According to this Negro, some oil company was flying this group to someplace, he believed to have been New York, and during this conversation, as he was about drunk, he asked this individual how he would like to come to work with him at Athens, Alabama, advising that he was an automobile dealer and could use an employee at his establishment. gave this individual one of his business cards and sometime later, he does not recall the length of the period of time, he received a letter from this individual from New York, requesting money to come to Athens, Alabama, to take this job; however, as well as he recalls, this individual requested more money than it would have taken for this

trip, and he answered this letter, pointing this fact out, but added that he would arrange a job in his establishment for this individual in the event he could get to Athens, Alabama.

Since the receipt of this letter, he has heard nothing more from this individual nor has he given it any thought since then.

Mr. LITTRELL stated he does not recall mentioning anything about Dr. MARTIN LUTHER KING, but it is entirely possible that he did make a statement concerning Dr. KING to this individual, since as well as he recalls he had quite a conversation with this young Negro. Mr. LITTRELL further pointed out that in the event he made such statement as alleged, he had no intentions of implying a threat of violence against Dr. KING. He again stated he may have made the statement to the effect that Dr. MARTIN LUTHER KING was creating trouble throughout the South, which in his opinion at that time was a true statement, but had not entertained a thought of instigating violence against Dr. KING.

Mr. LITTRELL advised that he has been an authorized automobile dealer in the City of Athens, Alabama, during the past 29 years. He further advised he could furnish no information concerning the death of Dr. KING, and the only information he has received concerning this incident was what he has seen in the newspapers, television, and heard over radio broadcasts.



I checked the station and there were six white people in the station and cafe and no one resembled the subject was noted therein. There were no buses in the station at this time. According to MISS WANDA WILLIAMS, ticket Agent, the last bus left the station at \$5:00AM enroute Jackson, Miss.

A check of the Greyhound station reflects a total of 8 white and several colored people. No one at the station resembled the subject in any way. There were no white couples seated togather in the station or cafe except one teen age couple. The last bus departed the station at 5:30AM and I checked the passengers on this bus and no one came close the description of the subject boarding the bus. L. E. CANNON ticket agent advised he had a WF on subject and he had not observed anyone resembling subject purchasing a ticket or in the waiting room of the station. HEALEY advised that he attended the convention and met one, CALVIN S. CRAIG, who claimed to be the Grand Kleagle of the UKA. CRAIG advised that he resides at 1009 Byron, Drive Southwest, Atlanta Georgia.

HEALEY advised that in conversation with CRAIG, CRAIG stated to HEALEY that they (not otherwise described) were going to execute the mayor and vice mayor of Atlanta. Georgia.

HEALEY also stated that CRAIG bears a strong resemblance to photographs he has seen of JAMES EARL RAY who is presently being sought by the FBI in connection with the assasination of KING. HEALEY advised that CRAIG's physical description would appear similar to the physical description of RAY. He was unable to furnish any additional information relating to the above matters.

HEALEY advised that CRAIG furnished him a card which he claimed would permit HEALEY to join the UAK for \$40 if he would do so by 6/1/68.

Chicago indices contain numerous references to an individual (s) with the name RAYMOND J. HEALEY. Chicago file 65-122 appears to pertain to complainant HEALEY referred to above. CG 65-122 indicates HEALEY furnished information to the FBI which pertained to the German American Bund. HEALEY at that time as well as at the present time is a writer who publishes magazines.

CG indices being reviewed and results will be furnished, if pertinent. Subsequent to indice review Chicago will evaluate and give consideration to reinterviewing HEALEY, for any additional information he may have and also to detemine if he has informant potential.

Copies being furnished recipient offices in view of continuing interest in matter set forth above.

CG 44-1114 Since it appears HEALEY may offer informant potential his identity should be protected at this time. Information relative to the alleged plot against the Mayor and Vice Mayor of Atlanta should be disseminated by Atlanta to appropriate authorities. Atlanta advise if HEALEY is known to Atlanta sources or the Atlanta Police Department. Atlanta indices should be checked re HEALEY. JAMES W. BROWN, 305 East Street, Talladega, Alabama, was interviewed at the Rehabilitation Center, Talladega, and furnished the following:

BROWN entered the Missouri State Penitentiary, Jefferson City, Missouri, on March 25, 1960, after having been convicted in Kansas City, Missouri, for murder and receiving a twenty-year sentence. He stayed "inside the walls" at Jefferson City until February, 1964, when he was transferred to a branch of the Penitentiary System at Fordland, Missouri.

During his imprisonment, BROWN became acquainted with one JOHNNY VELANTI (phonetic). VELANTI had told BROWN that VELANTI had some relatives in Baton Rouge, Louisiana, and VELANTI was serving a twenty-year sentence after being convicted in Kansas City, Missouri, for robbery. V LANTI had also claimed to BROWN that when he was arrested by the Kansas City Police Department he, VELANTI, had in his possession the name of a notorious Kansas City gangster, which had been given to VELANTI by a New Orleans friend. VELANTI did not identify either of these two names, but claimed he was questioned "thoroughly" by the Kansas City Police Department about this name VELANTI had in his possession.

BROWN claimed he and V-LANTI became good friends during this time and sometime in either November or December, 1963, through V-LANTI, BROWN met JAMES EARL RAY, another inmate at the penitentiary. This meeting took place in the prison yard at a time shortly after the assassination of President KENNEDY. At the time of the meeting, RAY was involved in a poker game and V-LANTI told BROWN that he, V-LANTI, was a personal friend of RAY's, who was doing twenty years for robbery. V-LANTI introduced RAY to BROWN as "JAMES RAY" and told BROWN that everyone called him "RAY." Later, at an unrecalled time, V-LANTI told BROWN that he, V-LANTI, had known "RAY"

in Atlanta, Georgia, and that they (VELANTI and RAY) had committed a robbery in Atlanta together. BROWN claimed VELANTI had told him that VELANTI and RAY had robbed a oil company about midnight after having watched it for about a week, VELANTI also told BROWN that VELANTI's wife and three children were then, 1963 or early 1964, living in Atlanta and that VELANTI's oldest son had been killed in an automobile accident in early 1964. About that time. early 1964, VELANTI's wife quit writing to him and VELANTI tried to get the Catholic Chaplain to contact his wife in an effort to have her resume writing. BROWN also recalled that VNLANTI had told him he was serving a sentence for the roppery of a Kansas City hotel. BROWN and VELANTI had both been in the same jail at Kansas City, Missouri, at the same time but were in different tanks and did not actually meet until they got to prison.

BROWN stated he was present during about three or four conversations between VELANTI and RAY, but that BROWN and RAY never had any detailed conversation of any kind. BROWN recalls in one of these conversations in late 1963 RAY said to VELANTI that he, RAY, was going to escape from the "pen" and that RAY knew a "guy named COOLEY" who could hide RAY where no one could find him. BROWN claimed that RAY also stated that COOLEY would pay \$10,000 to anyone who would kill MARTIN LUTHER KING. In other conversations, BROWN recalled RAY talking about tunnelling out of the penitentiary, if he had to, and going to Liberia where RAY claimed he had a brother-in-law living, who was "making good money." BROWN recalls that at another time, in discussing the assassination of President KENNEDY, VELANTI stated he did not believe anyone should kill the President, to which RAY said that he. RAY, would have done it himself if he had had the chance and that KENNEDY "was nothing but a damn Catholic." According to BROWN, RAY often expressed his hatred for Catholics and Negroes.

BROWN also recalls RAY claiming he knew where a cave was located in Virginia, whore AY could hide upon his escape. BROWN believed that the of the prisoners who overheard some of the convergations was "NOONEY EDEN."

BROWN claims that VELANTI told BROWN on more than one occasion that RAY had killed three Negroes in the penitentiary with a "shiv" (knife). BROWN claimed he did not know the details concerning these alleged killings.

BROWN believes he once told RAY that he (BROWN) was from Alabama and recalls RAY stating that Birmingham was a good town to steal in and that RAY had once stole a car in Birmingham before he was arrested in Kansas City. BROWN was of the opinion that RAY, at the time he met him, was living in "C" Hall and was working in the license plate plant. BROWN further stated he believed RAY was left-handed, smoked Winston cigarettes, walked pigeon-toed, and had a Zippo lighter with the initials "J.R." scratched on it.

BROWN claims he knows of no lottery or gambling operation conducted by VELANTI in which RAY took an active part.

BROWN stated he would cooperate with the FBI in any way possible and was doing so, not for any reward, but because he felt he should.

Mrs. BEATRICE BRITTON, 1710 Alabama Avenue, Jasper, Alabama, furnished the following:

She is married to THOMAS BRITTON, a former inmate at the Missouri State Penitentiary, Jefferson City, Missouri. Mrs. BRITTON states her husband never identified JAMES EARL RAY as a person known to him after or during the time when RAY's photograph and name were appearing frequently on TV and in newspapers and also stated her husband had never commented anything about RAY until about May 3, 1968, when Mrs. BRITTON was first contacted by the FBI in an effort to locate her husband. Her husband then told her that the FBI was seeking him concerning a man he had known in the penitentiary who had carried hot water to the prisoners' cells.

Mrs. BRITTON stated that neither she nor her husband, to her knowledge, has ever received any telephone calls from any unknown men who were attempting to contact her husband and who could be identical with JAMES EARL RAY. She stated she has never been contacted at her residence by anyone resembling RAY who was looking for her husband. She was unable to identify any photograph of RAY as a person ever seen by her at any time.

She stated that from June, 1967, until January, 1968, she and her family had not resided at 1710 Alabama Avenue, Jasper, but had resided in a rural area outside of Jasper. During the same time, however, they had kept the same telephone number they had had prior to moving from 1710 Alabama Avenue. In January, 1968, they moved back into the house at 1710 Alabama Avenue.

On 5/6/68, DONALD WOODS, AEROMARINE SUPPLY, Birmingham, Alabama, advised that a friend of his, CHARLES T. ROSS, who is employed at STANDARD BRANDS, Inc., had told WOODS that ROSS had received information to the effect that one BILLY FULMER, a fellow employee at Standard Brands, had made a comment that he, FULMER, had previously donated to a fund which was to be used for the assassination of MARTIN LUTHER KING.

On 5/8/68, CHARLES T. ROSS, 998 Martinwood Lane, telephone 833-0806, a senior clerk in the Accounting Department, Standard Brands, Inc., Birmingham, furnished the following:

On 4/5/68, in the company lounge, while having coffee, the warehouse supervisor, BILLY J. FULMER, made the comment, in connection with the assassination of KING, that at one time FULMER had given some money for the assassination of KING and that the person he had given the money to had told FULMER, "Don't worry, the money will be spent for a good cause." ROSS further stated that FULMER is frequently making racist remarks concerning Negroes.

On 5/13/68, BILLY J. FULMER, Route 4, Box 187, Birmingham, admitted to Special Agents ROBERT M. BARRETT and WILLIAM A. SAUCIER that he had made a statement to the effect he had donated to a fund which was being raised for the assassination of MARTIN LUTHER KING. He claimed he had made the statement in a joking manner and in an effort to make conversation while having coffee "with the boys." He stated he had never made such a donation, had no knowledge about any such fund ever actually existing; that he was not a member of the KKK and had no information

Each Senior Resident Agent is requested to contact major police departments, supplying additional copies of the identification order and wanted fliers, and bring to the attention of the robbery squad the possibility that RAY may have participated in armed robberies in order to secure funds. In this connection, investigation at Birmingham revealed that he was residing in the rooming house on Highland Avenue in Birmingham, 8/26/67, to the date of his departure on 10/7/67. He is known to have returned to Birmingham for two days, 3/29-30/68, when he purchased the murder weapon, paying cash.

In addition to descriptive data in your possession, one former inmate interviewed in the Birmingham Office territory, who was confined in the Missouri State Penitentiary with RAY, stated that he has a definite peculiar walk, described as "slew-footed", ie, with toes pointed outward, (not pigeon-toed), causing heels of shoes to wear on outer edges.

This same former inmate describes the photograph taken in the Missouri Department of Corrections on 1/4/66, as being the best likeness of RAY during the time the inmate was acquainted with him. A supply of these photographs has been requested from the Bureau, and you will be furnished copies.

In order to cover the possibility that subject may have died since commission of the crime, the U. S. Census Bureau and Department of Health, Education and Welfare were contacted and they advised that no central records of unidentified deceased are maintained by those agencies. It was suggested that each state may maintain such a record in their Bureau of Vital Statistics or similar agency.

There is no known Federal law requiring the maintenance of such information; and it is possible that if any record of unidentified dead is maintained, it would only be maintained at local police departments, morgues, medical facilities, or the like.

Each office covering state capitals should check to ascertain if such records are maintained, and if so, should check records for the period from 4-5-68, to date, for any information which might possibly identify subject Ray with unidentified deceased person over that period.
