By airtel dated 4/7/69, the Bureau advised that in a third "Look" magazine article, WILLIAM BRADFORD HUIE stated that JAMES EARL RAY had spent the night of 4/2/68 in a motel near Corinth, Miss. The Bureau instructed Jackson to review motel records in and around Corinth to determine the identities of individuals registered there during the period 3/29/68 to 4/3/68. By airtel dated 4/18/69, the Jackson Office advised the Bureau that motel records at Corinth, Miss., had been reviewed under the subject's true name and aliases and had been reviewed for subject's Alabama license number. Nothing identifiable with the subject was located.

By airtel dated 5/7/68, copies of which were not furnished the Bureau, the Jackson Office set out leads for those offices to whom copies of this communication are designated. These offices have been requested to interview several hundred persons who spent the night in motels at Corinth, Miss., on or about 4/2/68.

In view of the fact that more than a year has passed since these persons stayed over night at Corinth, and since similar investigation of this type in this case has previously been unproductive, and since HUIE has admitted that RAY frequently is untruthful in statements to him, and further since it is not believed that it is of any particular importance to establish whether or not JAMES EARL RAY stayed over night at Corinth on 4/2/68, all offices will disregard the leads set out in Jackson airtel dated 5/7/69, unless specifically advised by the Bureau to cover same.

In line with Birmingham telephone call to SAC Memphis, Birmingham has thoroughly reviewed all names of individuals set forth on FD-302's submitted by the Jackson office, and in no instance has there been any identification of the individuals with names appearing in the Birmingham file in this matter which might indicate any conspiracy with subject RAY.

Birmingham, in the absence of any additional request from Memphis, will consider above action as being sufficient at this time.

It is noted that Birmingham has previously conducted investigation at motels in the Florence, Alabama area, as reported in FD-302 submitted to Memphis by airtel dated 4/24/69.

SUBJECT JAMES EARL RAY HAS BEEN RETURNED TO THE SHELBY COUNTY JAIL AT MEMPHIS, TENN., FROM THE TENNESSEE STATE PRISON AT NASHVILLE, TENN., FOR A HEARING ON MAY TWENTYSIX NEXT ON HIS MOTION FOR A NEW TRIAL.

JERRY RAY WAS DISCOVERED BY BUAGENTS TODAY VISITING THE SUBJECT AT THE SHELBY COUNTY JAIL. AS JERRY RAY WAS LEAVING THE JAIL, HE WAS APPROACHED IN THE CORRIDOR BY BUAGENTS WHO REQUESTED THAT HE ACCOMPANY THEM TO SOME PLACE SUITABLE FOR INTERVIEW. JERRY AGREED TO GO WITH THE AGENTS INTO ONE OF THE SHERIFF'S DEPARTMENT OFFICES, AND AS JERRY AND BUAGENTS WERE ENTERING THIS OFFICE, THEY WERE JOINED BY THE SUBJECT JAMES EARL RAY'S ATTORNEY, J. B. STONER. STONER REFERRED TO THE BUREAU AS THE FEDERAL BUREAU OF INTEGRATION AND ADVISED JERRY NOT TO ANSWER ANY QUESTIONS. INTERVIEWING AGENTS

REMINDS JERRY THAT HE HAD BEEN WIDELY QUOTED IN THE NEWSPAPERS AS HAVING SAID THAT JAMES EARL RAY WAS A PART OF A CONSPIRACY TO MURDER MARTIN LUTHER KING. JERRY WAS ADVISED THAT IF HE HAS ANY INFORMATION OF A CONSPIRACY HE SHOULD TURN IT OVER TO THE FBI. STONER AGAIN ADVISED JERRY RAY NOT TO TALK, AND JERRY RAY THEN SAID HIS INFORMATION WOULD BEST BE GIVEN AT A TRIAL. JERRY WAS REMINDED THAT AT THIS TIME THERE IS NO REASON TO BELIEVE THERE WILL BE A TRIAL, AND JERRY RAY WAS ASKED IF BY THE TERM TRIAL HE MEANT HE INTENDED TO TESTIFY BEFORE A GRAND JURY. STONER AGAIN CAUTIONED RAY NOT TO TALK AND SAID HE IS CONVINCED JAMES EARL RAY WILL BE GIVEN A TRIAL FOR THE KILLING OF KING.

AS THE AGENTS TURNED TO LEAVE STONER AND RAY, STONER CALLED OUT TO THE AGENTS TO "BE GOOD" AND TO "PROTECT ALL THE NIGGERS." MOMENTS LATER RAY AND STONER WERE OBSERVED TALKING TO A REPORTER FROM ONE OF THE LOCAL NEWSPAPERS.

NO FURTHER CONTACT IS CONTEMPLATED WITH EITHER JERRY RAY OR WITH STONER. F. B. I.

Hanes freed from charge of contempt

Judge Arthur Faquin, who will hear James Earle Ray's request for a new trial, dismissed contempt of court charges Friday against Birmingham Atty. Arthur Hanes and six other persons. Ray pleaded guilty to the murder of Dr. Martin Luther King Jr. at his first trial.

The committee had suggested that new trials be granted or the charges dropped against Hanes, private investigators Renfro T. Hays and Memphis newspaper reports Charles Edmundson of The Commercial Appeal and Roy Hamilton of the Memphis Press-Scimitar.

Contempt proceedings were recommended against author William Bradford Huie, FBI firearms expert George Bonebrake and Southern Christian Leadership Conference official Rev. James Bevel.

Judge Faquin will hear Ray's plea for a new trial Monday.
