

Report of F.B.I Informant
Filed by Agent Leonard C. Peterson

On November 23, 1963, J. A. Milteer was in the Union Train Station, Jacksonville, Fla., and at about 4:25 p.m. on that date stated he was very jubilant over the death of President Kennedy. Milteer stated, Everything ran true to form. I guess you thought I was kidding you when I said he would be killed from a window with a high-powered rifle. When questioned as to whether he was guessing when he originally made the threat regarding President Kennedy, Milteer said, I don't do any guessing.

On November 10, 1963, a source who has furnished reliable information in the past, advised Agent Leonard C. Peterson that J. A. Milteer on November 9, 1963, at Miami, Fla., made a statement that plans were in the making to kill President John F. Kennedy at some future date; that Milteer suggested one Jack Brown of Chattanooga, Tenn., as the who could do the job and that he (Mildeer) would be willing to help. Milteer reportedly said that he was familiar with Washington and that the job could be done from an office or hotel in the vicinity of the White House using a high-powered rifle.

U.S. Secret Service was advised of the foregoing information.

In Nov. 1975, I was working with two F.B.I. Agents in connection with the secret service. Agent Steve Yates and Don Grogan. They filed a report and its on record.

Then Along Nov. 1976, I started to hear about the House Committee on Assassination. I was working for D.E.A. and Secret Service.

I told Larry Hahan at D.E.A. I was going to try and contact the Committee. We sat and discussed it for a while, we then talk to Bud Henry Asst. D.A. in Federal Court B'ham. It was decided to give the F.B.I one more chance to do something with the info.

Then Agent Monohand call me to come down to the F.B.I. office, I told that I would not come there, But if he wanted to come to the D.E.A. office I would give him a full statement.

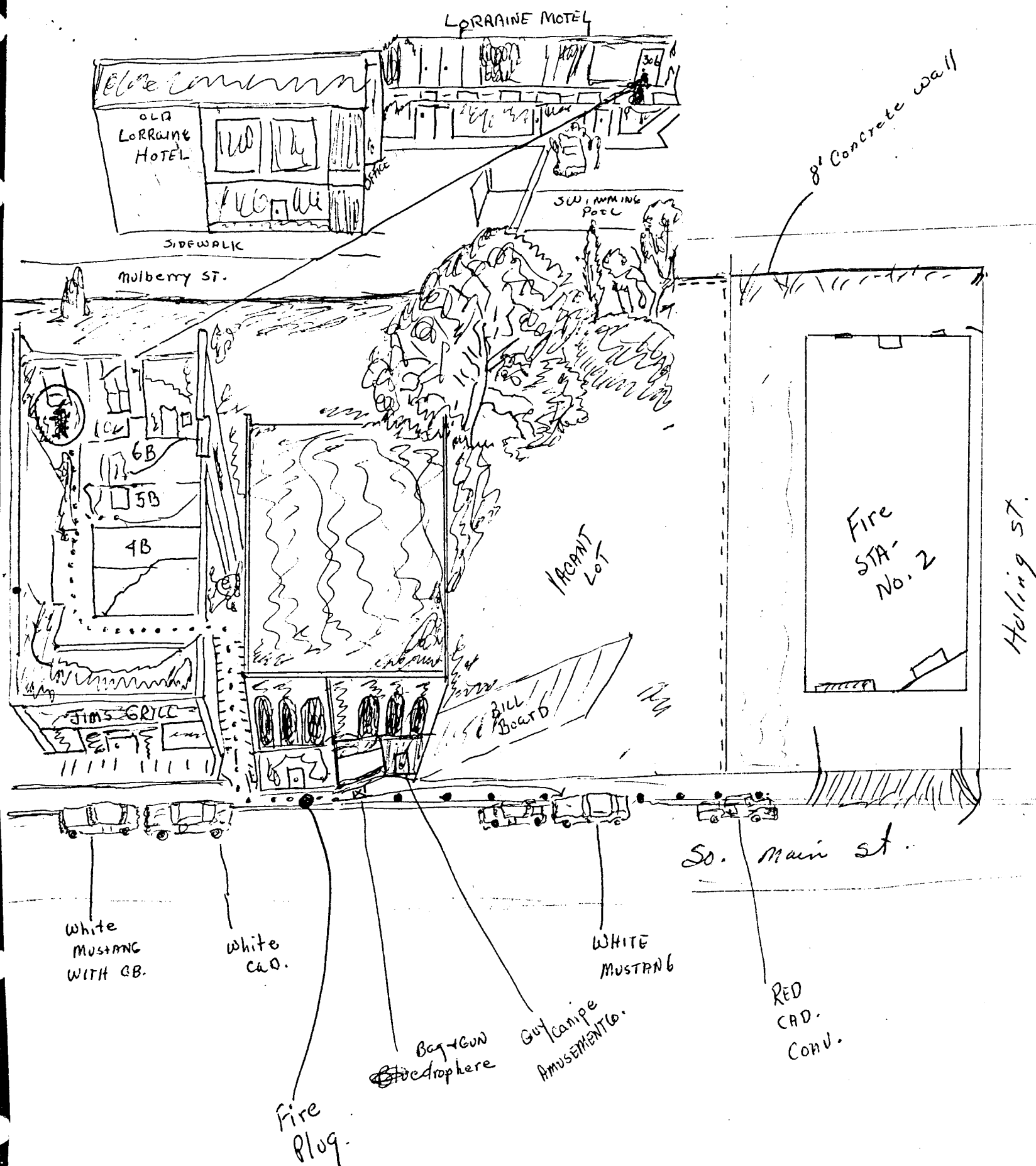
He came on over to the D.E.A. we went into Larry Hahan office, Larry was present thru most of the five hours we talked so there could be a witness to the statement if need be.

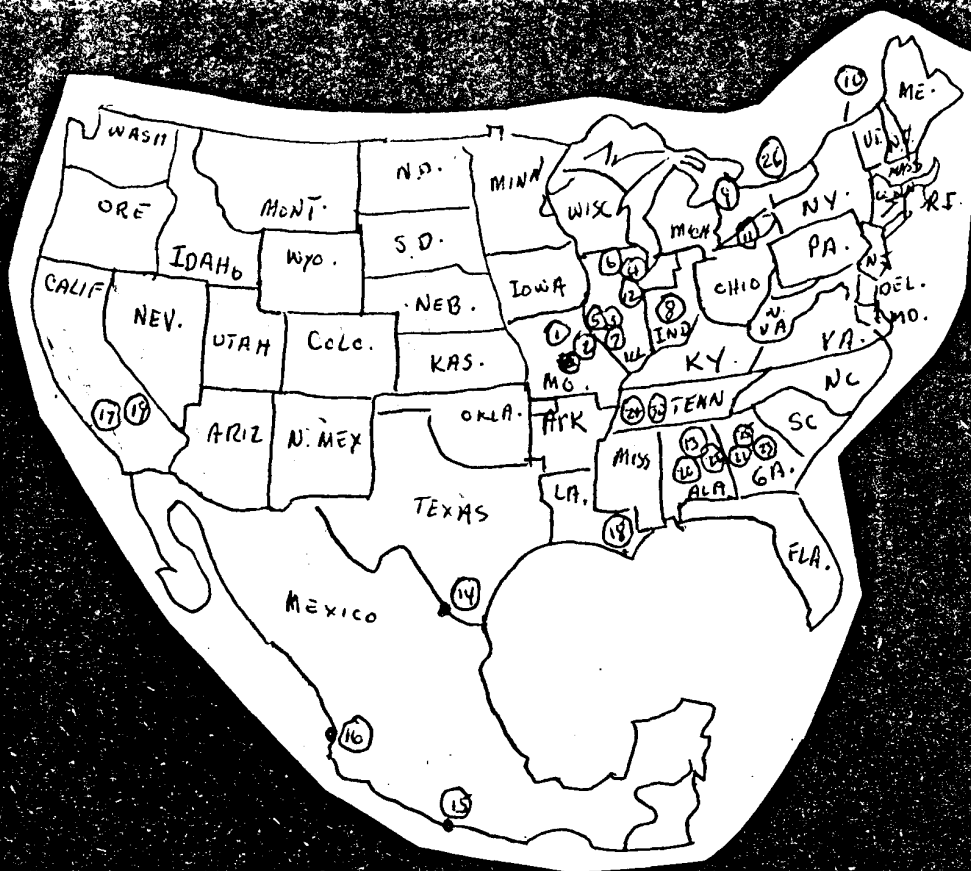
we talked and he waited for five hours. In most cases you are asked to sign a statement but he did not ask me to. I thought this was rather odd. This was on Dec. 17, 1976.

He assured me and Larry that there would be a full investigation into the case. That he would let us know when it starts.

About the 10th of Jan. Larry told me I should call Monohand. This I did and started getting the same run around. I told him that I didn't think they would do anything when I gave him the details.

Agent Monohand has talked to me two or three times since then. Has given me some info on the case and his personal feelings on the case.



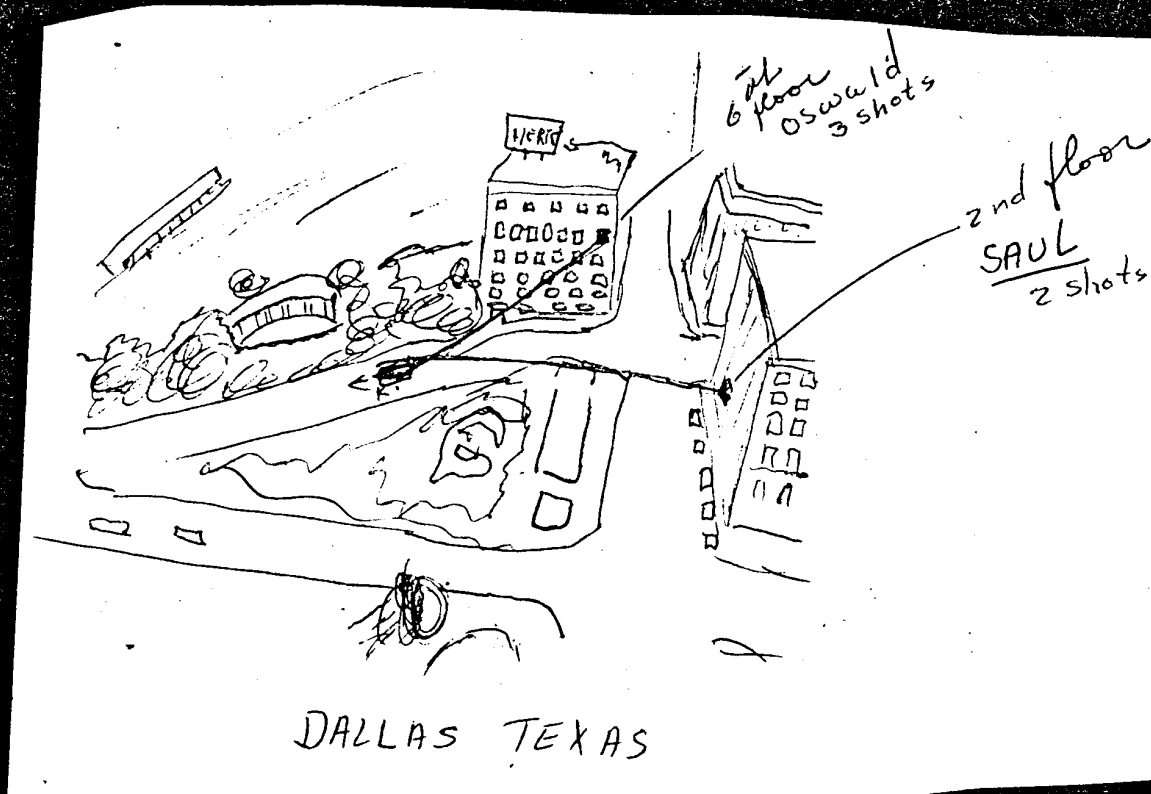
