BALDRIDGE.

RETEL CONTAINS INFORMATION RECEIVED FROM SGT. ELBERT  
BALDRIDGE, FT. BLISS, TEXAS, RE WIFE, SHELBY JEAN BALDRIDGE,  
AND TWO CHILDREN, WHO WERE OVERDUE IN RETURNING TO EL PASO AND  
WHO BALDRIDGE HAD REPORTED AS MISSING. BALDRIDGE AND WIFE HAD  
BEEN SEPARATED SINCE NOVEMBER, NINETEEN SIXTY SEVEN, AND WIFE  
HAD BEEN LIVING FAYETTEVILLE, NORTH CAROLINA.

RETEL STATED BALDRIDGE JUST LEARNED HIS WIFE LIVED WITH  
ANOTHER MAN WHILE BALDRIDGE WAS IN VIETNAM IN SIXTY SIX AND  
SIXTY SEVEN AND HE PLANNED DIVORCE ACTION. BALDRIDGE WAS OF OPINION  
WIFE HAD PROBABLY RUN OFF WITH SOME MAN. RECALLED THAT HE AND  
WIFE PLANNED TRIP TO TAMPA, FLORIDA, IN NINETEEN SIXTY SEVEN.

WAS CALLED OFF DUE TO OVERSEAS TRANSFER. WIFE REMARKED TO BALDRIDGE AT THE TIME THAT SHE MIGHT HAVE CHANCE TO SEE FRIEND EARL IF THEY WENT TO FLORIDA. BALDRIDGE SUBSEQUENTLY QUESTIONED HER MORE THOROUGHLY RE THIS, AT WHICH TIME WIFE SAID THAT, AFTER GRADUATING FROM HIGH SCHOOL IN NINETEEN FIFTYSEVEN, SHE AND HER COUSIN PATSY MADE TRIP TO <sup>TAMPA,</sup> FLORIDA, WHERE SHE MET ONE ERIC RAY, WHOM SHE CALLED EARL. WIFE CLAIMED EARL MUCH OLDER THAN SHE. WIFE NOT KNOWN TO HAVE EVER CORRESPONDED WITH EARL. BALDRIDGE WONDERED IF WIFE WAS POSSIBLY IN CONTACT WITH SUBJECT JAMES EARL RAY, POSSIBLY IDENTICAL WITH ERIC RAY SHE MET IN FLORIDA.

RICHMOND OFFICE SUBSEQUENTLY IDENTIFIED PATSY AS PATSY OWEN AND INTERVIEWED HER AND MRS. LENA FAUCETT, MOTHER OF SHELBY JEAN, AT CLARKSVILLE, VIRGINIA. BOTH DENIED ANY KNOWLEDGE OF ALLEGED TRIP TO TAMPA BY PATSY AND SHELBY JEAN. BOTH DISCLAIMED ANY KNOWLEDGE OF ERIC RAY, AKA EARL. RICHMOND WAS UNABLE TO LOCATE SHELBY JEAN FOR INTERVIEW IN SALTVILLE, VIRGINIA, AREA.

SGT. BALDRIDGE SUBSEQUENTLY STATED HE NEVER DISCUSSED TAMPA TRIP WITH ANYONE BUT WIFE AND DIDN'T KNOW IF ANY TRUTH TO IT. SHELBY JEAN NEVER SAID ANYTHING TO HIM TO INDICATE SHE HAD EVER CORRESPONDED WITH OR MAINTAINED CONTACT WITH ERIC RAY, AKA EARL.

SGT. BALDRIDGE ADVISED THIS DATE AS FOLLOWS: WIFE, SHELBY JEAN, WAS IN EL PASO FROM MAY THREE TO MAY SIX LAST AND THEN DEPARTED FOR HOME OF PARENTS OF DANIEL C. COLLEY, AIRMAN THIRD CLASS, USAF, IN BRISTOL, TENN, WHERE SHE PLANNED TO RESIDE. COLLEY IS MAN SHELBY JEAN LIVED WITH WHILE BALDRIDGE WAS IN VIETNAM AND SHELBY JEAN NOW FOUR MONTHS PREGNANT BY COLLEY. SHELBY JEAN PLANS TO SEND BALDRIDGE EXACT ADDRESS IN BRISTOL SO HE CAN SEND DIVORCE PAPERS TO HER. COLLEY CURRENTLY STATIONED POPE AFB, FAYETTEVILLE, NORTH CAROLINA, TELEPHONE THREE NINE FOUR DASH TWO SIX ONE SIX. BALDRIDGE HAD FEW WORDS WITH SHELBY JEAN AND DIDN'T QUESTION HER RE ERIC RAY.

KNOXVILLE, AT BRISTOL, LOCATE SHELBY JEAN AT COLLEY RESIDENCE AND INTERVIEW HER IN EFFORT TO ASCERTAIN IF SUBJECT JAMES EARL RAY POSSIBLY IDENTICAL WITH ERIC RAY, AKA EARL, WHO SHELBY JEAN AND PATSY OWEN ALLEGEDLY HAD CONTACT WITH IN FLORIDA IN NINETEEN FIFTYSEVEN. IF POSSIBLY IDENTICAL, DEVELOP ALL PERTINENT INFORMATION RE SHELBY JEAN'S ASSOCIATION WITH HIM.

IF SHELBY JEAN NOT LOCATED, ASCERTAIN EXACT WHEREABOUTS THROUGH COLLEY AND SET OUT LEAD TO HAVE HER INTERVIEWED. SHELBY JEAN, BORN [REDACTED] TRAVELLING WITH TWO CHILDREN, KIMBERLY JEAN, AGE FOUR, AND THOMAS ELBERT, AGE THREE. SHELBY JEAN TRAVELLING IN SIXTYSIX FORD, TWO DOOR, BROWNISH RED WITH WHITE TOP, NINETEEN SIXTYEIGHT VIRGINIA LICENSE PLATES ONE FIVE TWO

# Memorandum

At approximately 10:45 A. M., 5/8/68, a telephone call was received at the Charlotte Office of the FBI, Raleigh, N. C., RA, from an individual who identified himself as J. K. SHEARIN, a farm Bureau manager. SHEARIN advised that he was calling from a telephone pay station near the Howard Johnson Restaurant on U. S. Highway #1, North, Raleigh, North Carolina. He advised that he had just observed an individual walking along-side of Highway #1 heading north who was dressed in a tan jacket with dark trousers, wearing sunglasses who greatly resembled the photographs of JAMES EARL RAY which had appeared in the morning paper that day, which photographs were stated to have been taken in Mexico. SHEARIN stated this individual was near Charlie's Esso Station at the time and proceeding north on the east side of the road.

Shortly thereafter, an individual was observed near Charlie's Restaurant, U. S. Highway #1, North, Raleigh, N. C., who was proceeding at a normal walk. He was dressed as described above by SHEARIN. This individual identified himself as JOSEPH BURWELL McCLARY, JR. McCLARY advised that on 4/25/68 or 4/26/68, he was released from Dorothea Dix Hospital where he had been confined since 3/16/68, because of alcoholism. McCLARY furnished a South Carolina driver's license, number 552127, in his name which indicated his address was 615 W. Palmetta St., Florence, S. C. McCLARY advised this was a former address of his. He furnished a "Certificate of Service" which indicated he had been in the U. S. Marine Corps from 2/12/52 - 2/11/54, and received an honorable discharge. He advised his Marine Corps SN was 1286810.

McCLARY advised that his wife and mother reside at 4823 N. Kings Highway, Myrtle Beach, S. C. His wife's name is FRANCES H. McCLARY. Since he was released from the hospital at Raleigh, N. C., he has been residing at 506 Cutlar St., Raleigh, N. C., which is the Flynn Christian Fellowship Home. He advised that he was born [redacted] confirmed by driver's license. He was further described as follows.
